# CITT Ambassador Program Reaches a Milestone and Recognizes Outstanding Ambassadors

This summer - only six months after its official launch - the CITT Ambassador Program welcomed its 100th CITT Ambassador to the program.

As part of the program, CITT Ambassadors, who are frequent transit riders, fill out surveys that can be accessed via a mobile app. The information captured is then compiled and shared with Miami-Dade County's Department of Transportation and Public Works, and soon will be expanded to be shared with local municipalities and on-demand service companies – all in an effort to enhance the transit experience.

This past summer and fall, the CITT also recognized its outstanding Ambassadors of the Month and the CITT Ambassador for Third Quarter of 2023.

The first to be recognized for her stellar performance was CITT Ambassador Cathy Bernstein, who was selected as the first CITT Ambassador of the Month for June 2023 and the first CITT Ambassador for the Third Quarter 2023. Likewise, CITT Ambassadors Nadeige Laleau and Kirah Shakoor were also recognized as CITT Ambassadors for the months of July and August 2023, respectively.

The winners were selected based on the number of points they earned from filling out transit surveys and sharing messages via social media. These points can then be redeemed for a variety of transportation rewards, including credits for Uber and Lyft.


