





ORDINANCE AMENDING ORDINANCE NO. 08-116
CREATING AIRCRAFT NOISE ABATEMENT ADVISORY
BOARD FOR MIAMI INTERNATIONAL AIRPORT;
PROVIDING MEMBERSHIP, PURPOSE, PROCEDURES,
POWERS AND DUTIES; TO PROVIDE SUNSET PROVISION
UNTIL OCTOBER 7, 2018

**BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF
MIAMI-DADE COUNTY, FLORIDA:**

Section 1. Section 11 of Ordinance No. 08-116 is hereby amended to read as follows:¹

* * *

Section 11. >>Sunset. The provisions of this ordinance shall sunset on October 7, 2018<<[[~~This ordinance shall stand repealed five (5) years from its effective date~~]], unless extended by amendment of the Board of County Commissioners prior to such date.

Section 2. If any section, subsection, sentence, clause or provision of this ordinance is held invalid, the remainder of this ordinance shall not be affected by such invalidity.

Section 3. It is the intention of the Board of County Commissioners, and it is hereby ordained that the provisions of this ordinance, including any sunset provision, shall become and be made a part of the Code of Miami-Dade County, Florida. The sections of this ordinance may be renumbered or relettered to accomplish such intention, and the word "ordinance" may be changed to "section," "article," or other appropriate word.

¹ Words stricken through and/or [[double bracketed]] shall be deleted. Words underscored and/or >>double arrowed<< constitute the amendment proposed. Remaining provisions are now in effect and remain unchanged.


Section 4. This ordinance shall become effective ten (10) days after the date of enactment unless vetoed by the Mayor, and if vetoed, shall become effective only upon an override by this Board.
