RESOLUTION NO. R-1077-08

RESOLUTION APPROVING THE DESIGNATION OF THAT PORTION OF S.W. 67TH AVENUE BETWEEN S.W. 56TH STREET AND S.W. 64TH STREET AS "RICHARD D. WARD WAY"

WHEREAS, during the 2008 regular session, the Florida Legislature passed Senate Bill 1604, which, among other road designations, designated that portion of S.W. 67th Avenue between S.W. 56th Street and S.W. 64th Street as "Richard D. Ward Way"; and

WHEREAS, section 334.071, Florida Statutes, provides that the installation of road designation signs shall be contingent on the applicable county or city commission passing a resolution in support of the particular honorary road designation,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the designation of that portion of S.W. 67th Avenue between S.W. 56th Street and S.W. 64th Street as "Richard D. Ward Way".

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Secretary of the Florida Department of Transportation.

The Prime Sponsor of the foregoing resolution is Commissioner Carlos A. Gimenez, and the Co-Sponsor is Commissioner Rebeca Sosa. It was offered by Commissioner **Carlos A. Gimenez**, who moved its adoption. The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:
