

Recommendation

It is recommended that the Board of County Commissioners grant the attached Road Closing Petition following a public hearing. The Miami-Dade County Departments of Permitting, Environment and Regulatory Affairs, Public Works and Waste Management (PWWM), Water and Sewer and Fire Rescue have no objection to this right-of-way being closed.

Scope

This road closing is located within Commission District 9.

Fiscal Impact/Funding Source

The Property Appraiser's Office has assessed the adjacent properties to this right-of-way at an average \$1.78 per square foot. Therefore, the estimated value of this right-of-way would be approximately \$49,550.00. All the properties abutting the right-of-way to be abandoned are owned by Miami Community Charter School, Inc. (Charter School), and as such are tax exempt as per Florida Statutes 196.198 and 196.1983. Therefore, if this right-of-way is closed and vacated and the land is placed on the tax roll and solely used by the Charter School, they would be required to apply for the exemption on the additional portion of the land. The fee for this road closing is \$5,755.00.

Track Record/Monitor

PWWM is the entity overseeing this item and the person responsible is Raul A. Pino, PLS, Land Development/Right-of-Way Chief.

Background

The petitioner, Miami Community Charter School, Inc., owner of the properties on both sides of the street, wishes to close the right-of-way for SW 353 Street, from the west right-of-way line of SW 187 Avenue West for approximately 558 feet, in order to unite the property. The right-of-way being closed has never been improved nor maintained by Miami-Dade County. Therefore, this action will not adversely impact traffic flow or continuity of traffic in the area.

The subject right-of-way was dedicated in 1925, by the plat of FLA. CITY HIGHLANDS, recorded in Plat Book 20, Page 36, of the Public Records of Miami-Dade County, Florida. The subject right-of-way is zoned EU-M (Estates Modified District).

RESOLUTION GRANTING PETITION TO CLOSE SW 353 STREET, FROM THE WEST RIGHT-OF-WAY LINE OF SW 187 AVENUE WEST FOR APPROXIMATELY 558 FEET (ROAD CLOSING PETITION NO. P-892)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, (1) that the street, road, highway or other place used for travel as described in the attached petition is hereby vacated, abandoned and closed, all rights of Miami-Dade County and the public in and to the same are hereby renounced and disclaimed; (2) it is found that the action will serve a public purpose and benefit the public without violating private property rights; (3) that the procedure utilized in the adoption of this resolution is expressly ratified and approved; and (4) the Clerk is hereby directed to publish notice of the adoption of this resolution one time within thirty (30) days hereafter in a newspaper of general circulation of Miami-Dade County.

The foregoing resolution was offered by Commissioner **José "Pepe" Diaz**, who moved its adoption. The motion was seconded by Commissioner **Dennis C. Moss** and upon being put to a vote, the vote was as follows:



The undersigned, pursuant to Sections 336.09 – 336.12 Florida Statutes, hereby petitions the Board of County Commissioners to vacate, abandon, discontinue and close an existing public street, alleyway, road, highway, or other place used for travel, or a portion thereof, and to renounce and disclaim any right of the County and the public in and to any land in connection therewith; or to renounce and disclaim any right of County and the public in and to certain land, or interest therein, acquired by purchase, gift, devise, dedication or prescription for street, alleyway, road or highway purposes; or to renounce and disclaim any right of the County and the public in and to certain land delineated on recorded map or plat as a street, alleyway, road or highway.

The undersigned hereby certify:




EXHIBIT "A"

1. Legal Description:

That portion of SW 353rd Street (formerly known as 17th Street), lying between Blocks 1 and 4 of FLORIDA CITY HIGHLANDS, according to the plat thereof, as recorded in Plat Book 20 at Page 36 of the Public Records of Miami-Dade County, Florida; Less that portion of SW 353rd Street lying Westerly of the East line of Lot 12 in said Block 4, prolonged Northerly.

6. Grounds for requesting petition and proposed use for the land by this request:

The Applicant, Miami Community Charter School, Inc., is the owner of approximately 6.345 net acres of land located at southwest corner of SW 352 Street and SW 187 Avenue in Miami-Dade County.

The northern portion of the Property, which encompasses that land area located north of SW 353 Street, is being developed with a charter school that will serve 640 students in grades 6 through 12. The southern portion of the Property, which encompasses that land area located south of SW 353 Street, is vacant property that is planned to serve as a future expansion site for the school campus. The current petition to vacate the roadway will allow for a single unified campus with fewer portions for student-vehicular conflicts and potential security breaches.

The subject roadway was dedicated to Metropolitan Dade County, Florida, through the plat of "FLA. CITY HIGHLANDS", recorded in Plat Book 20, Page 36 of the Public Records of Miami-Dade County, Florida. However, the roadway has not been improved as essential infrastructure necessary to serve the immediate vicinity. Moreover, with the proposed unification of the north and south portions of the Property, the single site will cause the theoretical roadway to be unnecessary for the surrounding community.
