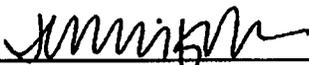
It is recommended that the Board approve the attached Resolution authorizing in-kind services and cash allocation for the Mission Miami, Inc. in an amount totaling \$6,510.

WHEREAS, Mission Miami, Inc., has requested in-kind services and cash allocation from the Miami-Dade Police Department for the December 4, 2010 "March for Unity Event" in an amount not to exceed \$6,510 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the "March for Unity Event" is an outdoor community event; and

WHEREAS, Mission Miami, Inc., is a not-for-profit organization; and

WHEREAS, the "March for Unity Event" is a special event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$6,510 of the in-kind services shall be funded from the unspent balance of the Mayor's FY 2008-09 In-kind Reserve Fund,

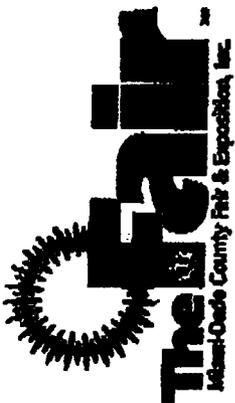

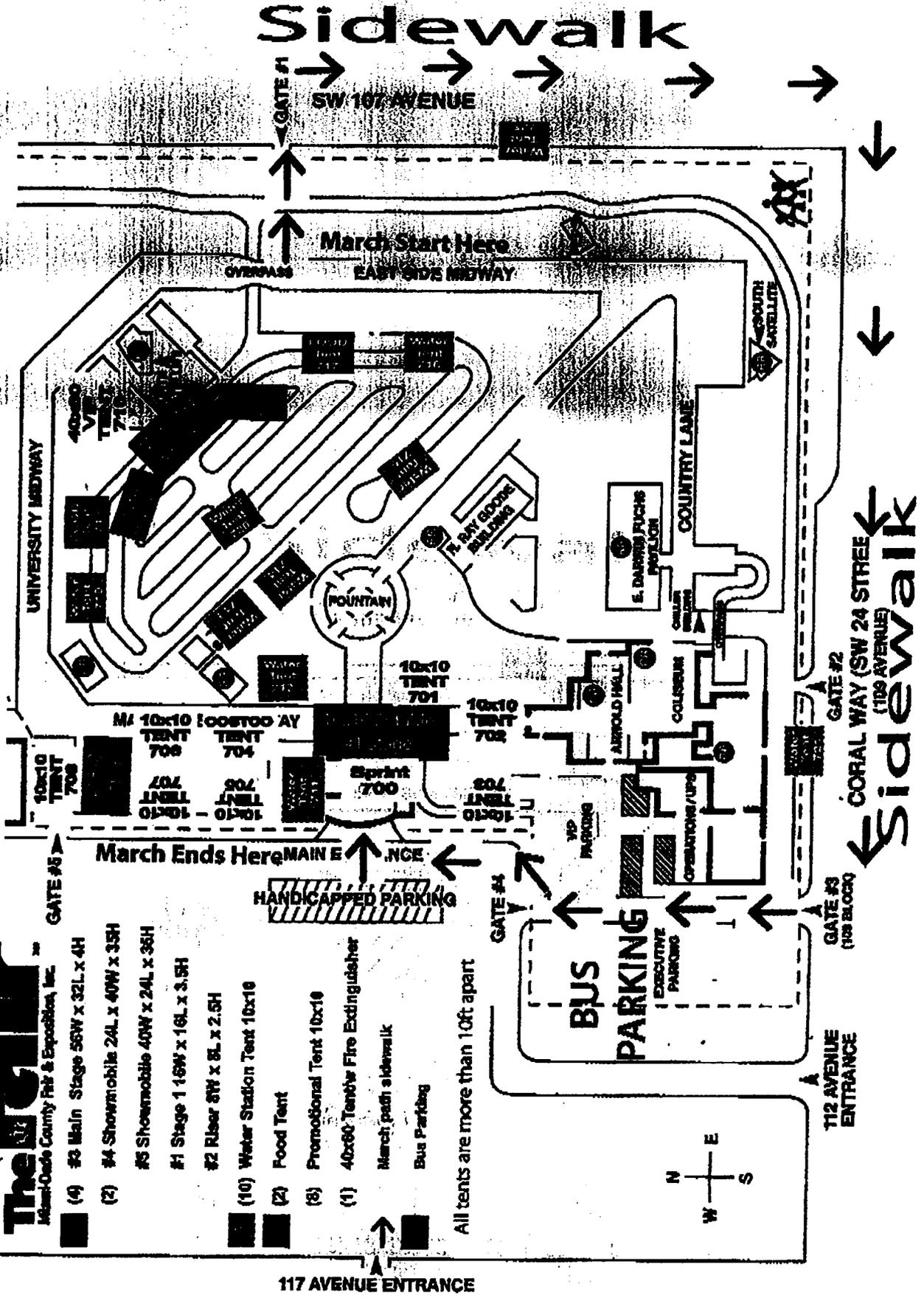
