**WHEREAS**, the Greater Goulds Optimist Club, Inc. has requested in-kind services from the Parks, Recreation and Open Spaces Department for the November 9, 2012 "Non-Violence Rally" event in an amount not to exceed \$650.00 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the purpose of the "Non-Violence Rally" event is to reduce violence in the community; and

**WHEREAS**, the Greater Goulds Optimist Club, Inc. is a not-for-profit organization; and

**WHEREAS**, the "Non-Violence Rally" is a district event, as that term is defined in the attached Fee Waiver/In-kind Service Application, and \$650.00 of the in-kind services shall be funded from the District 9 FY 2012-13 In-Kind Reserve Fund,


