RESOLUTION NO. R-1069-14

RESOLUTION DIRECTING THE MAYOR OR THE MAYOR'S DESIGNEE TO ANALYZE THE FEASIBILITY AND ADVISABILITY OF ISSUING A REQUEST FOR PROPOSALS FOR THE PURPOSE OF SELECTING ONE ENTITY TO PROVIDE DISPATCHING SERVICES FOR WHEELCHAIR ACCESSIBLE TAXICABS; AND REQUIRING A REPORT FROM THE MAYOR OR THE MAYOR'S DESIGNEE WITHIN SIXTY DAYS OF THE EFFECTIVE DATE OF THIS RESOLUTION

WHEREAS, in 2003, the County adopted an ordinance implementing a wheelchair accessible taxicab program; and

WHEREAS, the ordinance established a goal of having at least 3 percent of all taxicabs be wheelchair accessible; and

WHEREAS, currently, there are 80 such taxicabs amounting to 3.8 percent of all taxicabs; and

WHEREAS, these wheelchair accessible taxicabs are associated with various for-hire license holders and passenger motor companies throughout Miami-Dade County; and

WHEREAS, wheelchair accessible taxicabs are an essential element of Miami-Dade County's transportation system; and

WHEREAS, the lack of a centralized dispatching service with one dedicated telephone number makes it more difficult for users of wheelchairs to locate accessible taxicabs; and

WHEREAS, the Commission believes that it is in the best interest of the citizens of Miami-Dade County for the Mayor or the Mayor's designee to consider the feasibility and

advisability of issuing a request for proposals for the purpose of selecting one entity to provide dispatching services for wheelchair accessible taxicabs,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that the Mayor or the Mayor's designee is directed to consider the feasibility and advisability of issuing a request for proposals for the purpose of selecting one entity to provide dispatching services for wheelchair accessible taxicabs. The Mayor or the Mayor's designee shall provide a report on the feasibility and advisability of issuing such a request for proposals to this Board within 60 days of the effective date of this resolution and shall place the completed report on an agenda of the Board pursuant to Ordinance No. 14-65.

The Prime Sponsor of the foregoing resolution is Commissioner Bruno A. Barreiro. It was offered by Commissioner **Sally A. Heyman**, who moved its adoption. The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:
