



- 05/19/2009 Case # 200912002733 - Condition #13 of Resolution Z-122-77 (no storage of school buses at school) civil violation notice #T002278 was issued on 5/19/09 for violating the resolution. (See related case #_200612012776 opened on 12/28/06)
- 05/05/2009 Case # 200912002671 - Received complaint regarding the leasing of the recreational fields and the Arts Center Building for private events. The recreational fields can be used only as an accessory use of the school. On 5/19/09 a letter was hand delivered to school requesting a list of events that are not school related.
- 03-26-2008 Received complaint regarding chain link fence surrounding vacant property installed without permits. Building permit #2008030214 was opened on 2/15/2008 for fence around vacant property. The permit was approved and the case was closed on 2/5/2009. The matter was also reviewed with Public Works Department who did not object to the fence for safety and to prevent illegal dumping on the lot. This complaint was closed.




- 01/08/08 Case # 200712014787 - Outdoor lighting installed without a permit. An inspection of the property did not confirm the violation. Therefore, case was closed on 01/08/08.
- 04/19/2007 Case # 200712005061 – A Warning Notice was issued for illegally displaying banners. On 4/24/2007, CVN # 982951 was issued for non-compliance. An inspection on 5/23/2007 confirmed compliance. The CVN was paid and the case was closed on 6/4/2007.
- 12/28/2006 Case # 200612012776 – CVN # 982814 was issued for violation of Resolution Z-122-77 (8 & 13); Condition #8 provided only for Grades - only 7 to12 & Condition #13 imposed requirement that no school buses were to be stored at the school). Deferral was granted because property owner agreed to go to public hearing to cure violations. Condition #8 of resolution Z-122-77 was approved by CZAB hearing 08-11-CZ10-2 to expand grades to 6-12 (from 7-12). The case was closed. Condition 13 remains a violation therefore separate citation was issued on May 19, 2009. See case CMS No. 200912002733.
- 11/08/2006 Case # 200612010231 – Case opened due to a citizen complaint regarding “light spillage”. Various inspections of the property did not confirm the violation therefore the case is closed on 04/06/2007
- 05/10/2005 Case # 200512002431 - Case opened due to a citizen complaint regarding safety issues with the ball field. An inspection of the property confirmed there was no violation and the case was closed on 05/13/2005
- 04/13/2005 Case # 200512002180 – A Warning Notice was issued for overgrowth on the swale area. An inspection on 5/18/2005 confirmed compliance and the case was closed.


