It is an honor to serve as the Chairman of the Miami-Dade County Board of County Commissioners for the next two years. I am truly grateful for your confidence in me and look forward to working with each of you, as we strive to improve the lives of the residents of Miami-Dade County.

After thoughtful consideration and acknowledgment of each member's areas of expertise, I have established nine standing committees and an ad hoc committee, effective immediately. To ensure clarity and alignment of the committees with the Board's policy initiatives and priorities, my office will coordinate Sunshine meetings with each Committee Chair to discuss our collective goals and objectives. To enhance our stewardship of County tax dollars, I will, in consultation with the County Attorney, assign certain items to two or more committees, including the Appropriations Committee, for review. This additional layer of oversight will help evaluate fiscal impacts and ensure long-term financial sustainability.

The Appropriations Committee also will play a pivotal role in promoting fiscal accountability by conducting detailed line-item departmental budget reviews and issuing recommendations to truly streamline County government while ensuring the delivery of quality and responsive services to the residents of this community. I intend to coordinate with the Appropriations Committee Chair to promptly schedule additional committee meetings, as needed, to prioritize this line-item departmental budget review process. This proactive approach will allow the Board to take a more meaningful role in shaping the budget during the budget development process with an eye towards streamlining operations, reducing costs and improving service delivery. I have directed the Commission Auditor to provide staff support and budgetary analysis to the Appropriations Committee as it undertakes this key initiative. It is my intent

that at the conclusion of this budget review process, the Commission Auditor will be positioned to present to this Board a balanced proposed budget alongside the County Mayor's proposed budget for this Board's consideration. To this end, I have asked the Commission Auditor to work with the County Administration and to collaborate with every member of this Board to facilitate this process effectively.

It is imperative that as the newly established Constitutional Offices begin their operations, all County services, programs, and processes —particularly procurement, permitting, and other essential governmental functions— are efficient, accountable, and free from duplication. The Government Efficiency and Transparency Ad Hoc Committee will convene at my discretion to address these matters, identify inefficiencies and redundancies, and ensure there is no overlap in services. This proactive oversight will enhance transparency, streamline operations, and empower residents to hold the County accountable for its performance.

Attached, you will find an overview of the committee structure, including the jurisdiction of each committee, assigned Chairs, Vice Chairs and members, and schedule for the year. Please note that additional committee meetings or workshops may be scheduled to ensure thorough review and discussion of critical items.

It is my intent to maintain the new committee structure throughout the calendar year. However, I will reevaluate and implement changes as necessary to adapt to the needs of the County and its residents. I look forward to working closely with all of you to achieve our shared objectives and uphold our commitment to public service.
