

### PUBLIC NOTICE

Pursuant to F.S. 98.075(7), notice is hereby given to the voters listed below. Please be advised that your eligibility to vote is in question based on information provided by the State of Florida or the Clerk of the Court and Comptroller. You are required to contact the Supervisor of Elections in Miami-Dade County, Florida, no later than thirty days after the date of this notice to receive information regarding the basis for the potential ineligibility and the procedure to resolve the matter. This includes the right to request a hearing for the purpose of providing information to substantiate your status. Failure to respond will result in a determination of ineligibility by the Supervisor of Elections and your name will be removed from the Florida Voter Registration System.

If you attempt to vote at an early voting site or your normal election day polling place, you will be required to vote a provisional ballot. If you vote by mail, your ballot will be treated as a provisional ballot. In either case, your ballot may not be counted until a final determination of eligibility is made. If you wish for your ballot to be counted, you must contact the Supervisor of Elections in Miami-Dade County within two days after the election and present evidence that you are eligible to vote. ### AVISO PÚBLICO

Conforme a la Sección 98.075(7) de los Estatutos de la Florida, por el presente aviso se notifica a los electores nombrados a continuación que, según información proporcionada por el Estado de la Florida o el Secretario de los Tribunales y Contralor, se cuestiona su elegibilidad para votar. Es necesario que se comunique con la Supervisora de Elecciones del Condado de Miami-Dade, Florida, a más tardar treinta días después de la fecha de este aviso para recibir información sobre el motivo por el que tal vez no sea elegible para votar, así como el procedimiento para subsanar el problema, lo que incluye el derecho a solicitar una audiencia con el propósito de brindar información que sustente su estatus. Si no responde, la Supervisora de Elecciones determinará que usted no es elegible para votar y se eliminará su nombre del Sistema de Inscripción de Electores de la Florida.

Si intenta votar en un centro de votación anticipada o en su recinto electoral habitual el Día de las Elecciones, tendrá que hacerlo con una boleta provisional. Si vota por correo, su boleta se tratará como una boleta provisional. En cualquiera de los casos, no se podrá contar la boleta hasta que se haya tomado una decisión definitiva sobre su elegibilidad. Si desea que se cuente su boleta, debe ponerse en contacto con la Supervisora de Elecciones del Condado de Miami-Dade en un plazo de dos días después de las elecciones y presentar pruebas de su elegibilidad para votar.
