QUALIFICATIONS: [\[F.S. 103.091\(1\)\]](#) and [Miami-Dade County Democratic Executive Committee Bylaws, Article II, Section 1.1.](#)

1. Democrat registered voter.
2. Resident of the precinct.

TYPE OF ELECTION: Partisan [\[F.S. 103.091\(1\)\]](#)

ELECTION AREA Precincts [\[F.S. 103.091\(6\)\]](#)

PRECINCTS TO BE ELECTED: Elected Membership shall be composed of one (1) man and one (1) woman who shall be elected from each of the election precincts at the first Primary election in a Presidential election year. Should the Democratic registration of any precinct total more than one-thousand (1,000) as of January of a year in which qualifying for the election to the County Democratic Executive Committee occurs, an additional one (1) man and one (1) woman per one-thousand (1,000) Democratic voters are entitled to be elected to represent all such precincts. TERM: Four (4) years, commencing on December 1st immediately following the Presidential General Election [\[F.S. 103.091\(4\)\]](#) and [Miami-Dade County Democratic Executive Committee Bylaws, Article II, Section 1.1.](#)

ELECTION DATE: August 30, 2016 – Primary [\[F.S. 103.091\(4\)\]](#)

QUALIFYING DATES: [\[F.S. 103.091\(4\)\]](#)
Noon, Monday, June 20, 2016, to Noon, Friday, June 24, 2016.

A qualifying office may accept and hold qualifying papers submitted not earlier than 14 days prior to the beginning of the qualifying period (June 6, 2016), to be processed and filed during the qualifying period [\[F.S. 99.061\(8\)\]](#).

QUALIFYING REQUIREMENTS: [\[F.S. 99.021\(2\)\]](#)

During the qualifying period, the following **must** be submitted to the Miami-Dade Elections Department [\[F.S. 99.021\(2\)\]](#):

1. Loyalty Oath Form ([Form DS-DE 24C](#))
2. Receipt of Handbook and the Election Laws of the State of Florida ([Form MD-ED 2](#))

If you receive a contribution or make an expenditure, the following item must also be submitted to the Miami-Dade Elections Department:

3. Campaign Treasurer's Report Electronic Filing Requirement for Miami-Dade County ([Form MD-ED 10](#)).
