County Commissioner <i>(Nonpartisan)</i>	<i>No earlier than the 84th day and no later than noon on the 70th day prior to the date of the election at which he/she is a candidate [Miami-Dade County Charter, Article 3, Section 3.04, A]</i>	8:00 am, Tuesday, May 28, 2024 through Noon, Tuesday, June 11, 2024
Mayor <i>(Nonpartisan)</i>	<i>No earlier than the 84th day and no later than noon on the 70th day prior to the date of the election at which he/she is a candidate [Miami-Dade County Charter, Article 3, Section 3.04, A]</i>	8:00 am, Tuesday, May 28, 2024 through Noon, Tuesday, June 11, 2024

Community Development District (Nonpartisan)	<i>Between noon of the 71st day prior to the primary election and noon of the 67th day prior to the date of the primary election [F.S. 99.061(3)]</i>	Noon, Monday, June 10, 2024 through Noon, Friday, June 14, 2024
Community Council (Nonpartisan)	<i>No earlier than the 72nd day and no later than noon on the 70th day prior to the date of the election at which he or she is a candidate [Miami-Dade County Code of Ordinances, Part III, Chapter 20, Article IV, Section 20-43(A)(4)]</i>	8:00 am, Monday, June 10, 2024* through Noon, Tuesday, June 11, 2024

* Since the start date falls on a Sunday, it has been moved to the next business day.
