

As part of our commitment to expanded voter education, the Office of the Supervisor of Elections invested in long form video and podcasting to reach broader, more diverse audiences through modern and accessible outreach.



Through these podcast discussions, the office highlighted important upcoming elections, shared updates on community outreach efforts, and provided transparency on how elections are administered and conducted.

SECURE ELECTIONS

Security remained the cornerstone of our operations in 2025. Significant investments were made to modernize equipment, strengthen security, and protect the integrity of the voter registration system.

Procured and deployed 1,837 DS300 precinct ballot scanners and 150 EViD Edge electronic pollbooks, with an additional 1,900 EViD Edge units purchased for delivery in 2026.

Implemented next-generation firewall solutions to enhance network security and performance.



Achieved 100% compliance with Florida's Statewide Cybersecurity Audit aligned with the NIST Cybersecurity Framework.

Initiated beta testing of enhancements to the Voter Focus Electronic Poll Book System in preparation for the 2026 election cycle.



Updated mailroom and vote-by-mail processing equipment to improve speed and accuracy.

Upgraded back-end infrastructure with new Election Management System and communication servers to support reliability and future scalability.

ACCURATE ELECTIONS

Accuracy was ensured through rigorous testing, compliance with evolving laws, and continuous process improvements.



Implemented new procedures and equipment to comply with 2025 legislative changes impacting petition verification and electronic certification.

Processed and verified nearly 122,000 state, local, and candidate petitions, meeting all statutory deadlines.




TRANSPARENT ELECTIONS

Implemented ballot image capture for every ballot cast in all elections, ensuring enhanced auditability and public trust.

Completed comprehensive post-election audits using an independent system.



ACCESSIBLE ELECTIONS


Ensuring every eligible voter can participate fully remained a top priority.

Media representatives were able to observe how the machines operate, learn about their enhanced security features, and see firsthand how ballots are scanned, recorded, and audited.

In preparation for the November 4 elections, the Miami-Dade County Supervisor of Elections mailed the first batch of 39,000 Vote-by-Mail ballots to voters across the county.

This marked a key milestone in the election timeline, ensuring that voters who opted to vote by mail received their ballots early and had ample time to complete their ballots, and return them securely.

These segments also served as an educational platform—informing voters about polling locations, what to expect on the ballot, and how to prepare ahead of Election Day—ensuring the public had clear, accurate, and accessible information when it mattered most.



Throughout 2025, leading into election season, Supervisor Garcia engaged Miami-Dade County residents through large broadcast networks including NBC, Univision, and Telemundo.

Reaching Miami's diverse communities across multiple platforms was crucial to ensuring that all voters felt like their voice could be heard.

These outreach moments capture our team connecting with residents at over 1,000 outreach events throughout the year, answering questions and building trust.





They presented a historic fireman's axe, preserved from a free Cuba before the revolution to Miami-Dade Firefighters Local 1403.

Supervisor Garcia welcomed Miami Senior High School's Broadcast and Journalism students to Elections Headquarters for an educational tour of the facility and a hands-on learning experience.

Students were given the opportunity to test their reporting skills through an interview with Supervisor Garcia, gaining firsthand insight into elections administration, public service, and civic leadership.
