AND PURCHASE CONTRACT FOR AGREEMENT THE **BONDS: AUTHORIZING BOOK-ENTRY** SYSTEM OF **REGISTRATION:** ACKNOWLEDGING THE FORM AND DISTRIBUTION OF PRELIMINARY **STATEMENT** FINAL **OFFICIAL** OFFICIAL AND STATEMENT: APPOINTMENT OF A TRUSTEE CONSENTING TO THE APPOINTING A SECURITY REGISTRAR AND PAYING AGENT FOR THE BONDS; PROVIDING THAT SUCH BONDS SHALL BE PAYABLE SOLELY FROM REVENUES OF THE UNIVERSITY AND SHALL NOT CONSTITUTE A DEBT OR GENERAL OBLIGATION OF THE AUTHORITY; RATIFYING PRIOR ACTS AND RATIFYING AND CONFIRMING THE ADOPTION BY THE AUTHORITY OF ITS RESOLUTION NUMBER 18-01; AUTHORIZING CHAIRPERSON, VICE-CHAIRPERSON AND ANY OTHER MEMBER OF THE AUTHORITY TO TAKE ALL ACTIONS IN CONNECTION WITH ISSUANCE OF THE BONDS AND OTHER RELATED MATTERS; AND PROVIDING FOR SEVERABILITY AND EFFECTIVE DATE.
