Resolution Authorizing the Elimination of the Designated Properties Known as Parcels 3, 17, 20, 21, 22, 23, 24, 25 and 26 from the Right-of-Way Needed for the People's Transportation Plan Project Entitled Roadway Expansion and Improvements to NW 37 Avenue from NW North River Drive to NW 79 Street

RECOMMENDATION

It is recommended that the Board of County Commissioners (Board) rescind the previously adopted Resolutions Nos. R-691-09, R-696-12, R-708-09, R-709-09, R-710-09, R-711-09, R-712-09, R-713-09, and R-714-09. Said Resolutions authorized the acquisitions of Parcels 3, 17, 20, 21, 22, 23, 24, 25 and 26 for the roadway expansion along NW 37 Avenue from NW North River Drive to NW 79 Street (Project), and authorized the County Mayor or the County Mayor's designee and the County Attorney to take all appropriate action to acquire the subject properties in fee simple by donation, purchase, or by eminent domain proceedings. After further value engineering and cost effectiveness studies, it has been determined that the referenced properties no longer need to be acquired. Accordingly, this resolution authorizes the elimination of those proposed acquisitions, and rescinds the prior resolutions authorizing same.

SCOPE

The properties to be eliminated are located within Commissioner Jean Monestime's District 2, and traverse the City of Hialeah and the City of Miami. However, this project is countywide.

FISCAL IMPACT/FUNDING SOURCE

Funding for the right-of-way acquisition, design and construction of this project will be provided by the Charter Funding Transit Surtax levied pursuant to Section 29.121 of the Code of Miami-Dade County. This project was specifically listed in the People's Transportation Plan (PTP) as one of the Board requested improvement projects for Commission District 2. Not having to acquire the subject parcels, results in net savings of approximately \$2,000,000.00.

TRACK MONITOR

The Transportation and Public Works Department (TPW) is the entity overseeing this project and the person responsible for monitoring the parcel acquisition for this project is Francisco Fernandez, Chief Real Estate Officer of the Right-of-Way Division.

BACKGROUND

In an effort to reduce costs, the Project was reevaluated for cost effectiveness and subjected to value engineering. These efforts resulted in the redesign of a segment of the project, yielding cost savings, minimizing the amount of right-of-way to be acquired, and maintaining the integrity of the project, while adhering to the objectives set forth by the Board for the Project, This resolution authorizes the withdrawal of Parcels 3, 17, 20, 21, 22, 23, 24, 25 and 26 for the right-of-way needed by TPW for the roadway expansion portion of the aforementioned project. The parcels to be eliminated are illustrated in the parcel location map in Exhibit A, attached hereto.


