# Recommendation

The following plat is submitted for consideration by the Board of County Commissioners for approval. This plat for SFLC North is bounded on the north by theoretical NW 46 Street, on the east by NW 67 Avenue, on the south by NW 36 Street, and on the west by NW 69 Avenue.

The Miami-Dade County Plat Committee recommends approval and recording of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Public Works and Waste Management; and Water and Sewer.

#### Scope

This plat is located in Commission District 12, which is represented by Commissioner Jose "Pepe" Diaz.

• That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.

• That all new electric and communication lines may be installed overhead, service conductors from the pole to the building (structure) shall be an underground service lateral.

RESOLUTION APPROVING THE PLAT OF SFLC NORTH, LOCATED IN THE SOUTHEAST 1/4 OF SECTION 23, TOWNSHIP 53 SOUTH, RANGE 40 EAST AND IN THE NORTHEAST 1/4 OF SECTION 26, TOWNSHIP 53 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH BY THEORETICAL NW 46 STREET, ON THE EAST BY NW 67 AVENUE, ON THE SOUTH BY NW 36 STREET, AND ON THE WEST BY NW 69 AVENUE)

WHEREAS, FDG Hialeah, LLC, a Delaware limited liability company, SFLC Building 1, LLC, a Delaware limited liability company, SFLC Building 2, LLC, a Delaware limited liability company, SFLC Building 3, a Delaware limited liability company, and SFLC Building 4, LLC, a Delaware limited liability company, have this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as SFLC NORTH, the same being a replat of a portion of Tracts 52, 53, 54, 55, and 56 of "Florida Fruit Lands Company's Subdivision No. 1", according to the plat thereof, as recorded in Plat Book 2, at Page 17, of the Public Records of Miami-Dade County, Florida, lying and being in the Southeast 1/4 of Section 23, Township 53 South, Range 40 East, and a subdivision of a portion of land lying and being in the Northeast 1/4 of Section 26, Township 53 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,
