Resolution Approving the Plat of South Biscayne Estates

Recommendation

The following plat is submitted for consideration by the Board of County Commissioners for approval. This plat for South Biscayne Estates is bounded on the north by SW 288 Street, on the east by Colorado Road, on the south approximately 220 feet north of theoretical SW 289 Terrace, and on the west approximately 135 feet east of SW 154 Avenue.

The Miami-Dade County Plat Committee recommends approval and recording of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Public Works and Waste Management; and Water and Sewer.

Scope

This plat is located in Commission District 8, which is represented by Commissioner Daniella Levine Cava.

Fiscal Impact/Funding Source

There is no associated fiscal impact to Miami-Dade County with the approval of this plat as all improvements are in place.

Track Record/Monitor

The Development Services Division of the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.

Plat Restrictions

- That the Road and Street, as illustrated on the plat, together with all existing and future plantings, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors and assigns the reversion or reversions thereof, whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted on any lot within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.
- That the utility easement, depicted by dashed lines on the plat, is hereby reserved for the installation and maintenance of public utilities.

Developer's Obligation

None all improvements are in place.

RESOLUTION APPROVING THE PLAT OF SOUTH BISCAYNE ESTATES, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 4, TOWNSHIP 57 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH BY SW 288 STREET, ON THE EAST BY COLORADO ROAD, ON THE SOUTH APPROXIMATELY 220 FEET NORTH OF THEORETICAL SW 289 TERRACE, AND ON THE WEST APPROXIMATELY 135 FEET EAST OF SW 154 AVENUE)

WHEREAS, IICON Builders, LLC, a Florida limited liability company, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as SOUTH BISCAYNE ESTATES, the same being a subdivision of a portion of land lying and being in the Southwest 1/4 of Section 4, Township 57 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,
