Miami-Dade Transit Update on Partnership with Miami-Dade County Public

School System and Private Charter Schools - Directive #142474

This report is in response to a directive at the September 16, 2014 Board of County Commissioners (Board) meeting, where Commissioner Rebeca Sosa directed that Miami-Dade Transit (MDT) partner with the Miami-Dade County Public School System (MDCPS) and private charter schools to create an informational campaign to educate students about and encourage the use of public transportation (R-821-14). Currently, there are over 5,800 active students in MDT's K-12 Discount Fare Program.

Working in conjunction with the Communications Department, MDT launched a new K-12 Program campaign in August 2015. The campaign included:

- · direct Mailers to all private and public schools in Miami-Dade County;
- · flyers distributed through Miami-Dade County Summer Camps;
- · radio advertisements in English, Spanish and Creole;
- Pandora Radio with a clickable web banner;
- exterior bus advertisements:
- online display banners;
- search engine marketing, an advertising words campaign on major search engines focused on key terms associated with the campaign;
- · boosting posts on social media;
- · e-mail blast to parents; and
- print advertisements in newspapers/magazines.

In addition, MDT has had a very successful six-year partnership with City Year, Inc. (City Year) to promote transit via a wide array of service activities designed to provide participants with a close-up and hands-on view of the transit system. Activities have ranged from beautification of Metrorail and Metromover stations to direct outreach to K-12 students. For the most recent school year, the City Year program's 212 participants received EASY Card passes in exchange for an equivalent of 3,500 service hours. These service hours included providing direct K-12 outreach at 18 schools in the form of meeting with parents to inform them of the benefits of the K-12 Program, dissemination of program literature, and assistance with application completion.

MDT is committed to educating our K-12 riders and will continue working collaboratively with the Communications Department, MDCPS, and private charter schools to expand programming, and will report back to the Board within six (6) months on those efforts.

RESOLUTION DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO PARTNER WITH THE MIAMI-DADE COUNTY SCHOOL BOARD AND PRIVATE AND CHARTER SCHOOLS WITHIN MIAMI-DADE COUNTY TO CREATE AN INFORMATIONAL CAMPAIGN TO EDUCATE STUDENTS ABOUT AND ENCOURAGE USE OF THE COUNTY'S PUBLIC TRANSIT SYSTEM

WHEREAS, Miami-Dade County's public transportation system of Metrobuses, Metrorail and Metromover provide vital transportation services for members of the public regardless of age; and

WHEREAS, one of the best ways to increase ridership is to educate residents at a young age about the availability and advantages of public transit options; and

WHEREAS, it is important that the County Mayor, the County Mayor's designee, and Miami-Dade Transit reach out to these young members of our community and educate them and encourage them to make public transportation a part of their lives; and

WHEREAS, the best way to educate young residents is to partner with the School Board as well as the various charter and private schools and create educational, informational and age-appropriate promotional materials, handouts, and live classroom or school-wide presentations related to Miami-Dade Transit; and

WHEREAS, this Board urges the County Mayor or appropriate staff to partner and work with the School Board and relevant school officials to create and implement such an educational and informational program in the upcoming school year in all public, private, and charter schools throughout Miami-Dade County; and
