



RESOLUTION APPROVING THE STATE ROAD
CODESIGNATION OF NW 32ND AVENUE FROM NW 87TH
STREET TO NW 83RD STREET AS "DR. CLIFFORD
GARFIELD O'CONNOR STREET"

WHEREAS, during the 2017 legislative session, the Florida Legislature passed, and the Governor approved, Senate Bill 368 which codesignated NW 32nd Avenue from NW 87th Street to NW 83rd Street as "Dr. Clifford Garfield O'Connor Street"; and

WHEREAS, Dr. Clifford Garfield O'Connor was a podiatrist who also assisted in training new physicians; and

WHEREAS, Dr. O'Connor participated in several medical missions to Jamaica and Haiti; and

WHEREAS, Dr. O'Connor passed away on February 23, 2015, at the age of 50; and

WHEREAS, this Board would like to honor Dr. O'Connor by approving the state road codesignation of NW 32nd Avenue from NW 87th Street to NW 83rd Street as "Dr. Clifford Garfield O'Connor Street"; and

WHEREAS, that portion of NW 32nd Avenue from NW 87th Street to NW 83rd Street is a state road located within unincorporated Miami-Dade County and County Commission District 2,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the state road codesignation of NW 32nd Avenue from NW 87th Street to NW 83rd Street as "Dr. Clifford Garfield O'Connor Street".

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Transportation and Public Works Department, the Development Services Division of the Regulatory and Economic Resources Department, the Miami-Dade Police Department and the Miami-Dade Fire Department.
