Request for Additional Time and Expenditure Authority to Pool No. RTQ-00439,

Furniture Office and Non-Office

Recommendation

It is recommended that the Board of County Commissioners (Board) authorize \$16,517,860 in additional expenditure authority and one year of additional time to *Pool No. RTQ-00439, Furniture Office and Non Office* for multiple County departments. The solicitation was advertised for an eight-year term. In February 2018, the pool was approved by the Board through Resolution No. R-95-18 for a one-year term. Pursuant to the Resolution, this pool is hereby presented to the Board for a one-year continuation based on the Fiscal Year 2018-19 approved budgeted amount.

County departments use this pool for the purchase and installation of furniture, including replacement parts, upholstery and associated products and services. Additional vendors and manufacturer product lines may be added throughout the term of the pool. The furniture purchased under this pool includes items required to furnish new or expanded County facilities and to replace furniture that has reached the end of its useful life. This furniture includes terminal and lobby seating, ticket counters, chairs, and benches that will be installed at Miami International Airport, PortMiami, public libraries, courthouses and other public facilities.

Scope

The impact of this item is countywide in nature.

Fiscal Impact/Funding Source

The current term expires on February 28, 2019 and has an allocation of \$15,185,000. If this request is approved, the Pool will expire on February 28, 2020 and the additional requested expenditure authority of \$16,517,860 will be allocated based on Fiscal Year 2018-19 Board approved budgets for each department. Refer to Attachment 1 for a listing of departments and allocations based on capital and operating budgets.

Track Record/Monitor

Jessica Tyrrell of the Internal Services Department is the Procurement Contracting Manager.

Delegated Authority

There is no additional delegation of authority sought in this item as the authority to solicit pricing and award contracts up to an aggregate amount of the allocation authorized by the Board, exercise all provisions of the solicitation documents and any resulting contracts pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38, and add vendors to the pool at any time, subject to ratification by the Board on a bi-annual basis, was granted when the pool was established.

Prequalified Vendors

There are currently 46 prequalified vendors under the pool, of which ten are local vendors and five are Small Business Enterprises. Refer to Attachment 2 for a listing of the prequalified vendors. Pursuant to disclosure requirements in Resolution No. R-477-18, fewer than 75 percent of vendors recommended are local.

Due Diligence

Pursuant to Resolution No. R-187-12, due diligence was conducted in accordance with the Internal Services Department's Procurement Guidelines to determine contractor responsibility, including verifying corporate status and review of performance and compliance issues. The lists referenced include convicted vendors, debarred vendors, delinquent contractors, suspended vendors, and federal excluded parties. There were no adverse findings relating to contractor responsibility.

Applicable Ordinances and Contract Measures

- The two percent User Access Program provision applies where permitted by funding source.
- The Small Business Enterprise (SBE) Bid Preference and Local Preference will be applied at the time
 of spot market competition where permitted by the funding source. An SBE set-aside applies for spot
 market competition up to \$100,000 where permitted by the funding source when there are three or
 more SBE-certified firms available.
- The Living Wage does not apply.

RESOLUTION AUTHORIZING ADDITIONAL TIME OF ONE YEAR AND EXPENDITURE AUTHORITY IN A TOTAL AMOUNT UP TO \$16,517,860.00 FOR PREQUALIFICATION POOL NO. RTQ-00439 FOR PURCHASE OF FURNITURE OFFICE AND NON-OFFICE FOR VARIOUS COUNTY THE DEPARTMENTS: AND AUTHORIZING MAYOR OR COUNTY MAYOR'S DESIGNEE TO SOLICIT CONTRACTS, **EXERCISE** AWARD PRICING. PROVISIONS OF THE SOLICITATION DOCUMENTS AND ANY RESULTING CONTRACTS PURSUANT TO SECTION 2-8.1 OF THE COUNTY CODE AND IMPLEMENTING ORDER 3-38, AND ADD VENDORS TO THE POOL AT ANY TIME, SUBJECT TO RATIFICATION BY THE BOARD ON A BI-**ANNUAL BASIS**

WHEREAS, this Board desires to accomplish the purpose outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board authorizes additional time of one-year and expenditure authority in a total amount up to \$16,517,860.00 for Prequalification Pool RTQ-00439 for the purchase of furniture office and non-office for various County Departments and authorizes the County Mayor or the County Mayor's designee to (a) solicit pricing and award contracts up to the aggregate amount of the allocation authorized by the Board, (b) exercise all provisions of the solicitation documents and any resulting contracts pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38, and (c) add vendors to the pool at any time, during the term of the pool, subject to ratification by the Board on a biannual basis. A copy of the solicitation document and the contracts once awarded are on file with and available upon request from the Internal Services Department, Strategic Procurement Division.
