WHEREAS, the City of Miami passed Resolution No. R-19-0351 on September 12, 2019, which codesignated that portion of SW 10th Street from SW 15th Avenue to SW 19th Avenue "Miguel Álvarez Gimeno Way"; and

WHEREAS, a copy of Resolution No. R-19-0351 is attached hereto and incorporated herein by reference; and

WHEREAS, Miguel Álvarez Gimeno was a Cuban patriot, a member of the 2506 Brigade during the Bay of Pigs invasion, and president of the 2506 Brigade Veterans Association; and

WHEREAS, Miguel Álvarez Gimeno was born on January 19, 1928, in the City of Havana and died on January 8, 2018 in the City of Miami; and

WHEREAS, Miguel Álvarez Gimeno participated in many actions aimed at liberating Cuba from the Castro dictatorship; and

WHEREAS, that portion of SW 10th Street from SW 15th Avenue to SW 19th Avenue is a city street located in the City of Miami; and

WHEREAS, this codesignation is located in County Commission District 5; and

WHEREAS, this Board would also like to honor Miguel Álvarez Gimeno by approving the City of Miami's codesignation of that portion of SW 10th Street from SW 15th Avenue to SW 19th Avenue "Miguel Álvarez Gimeno Way",

WHEREAS, Miguel Álvarez Gimeno was born on January 19, 1928, in the city of Havana and died on January 8, 2018 in the City of Miami ("City"); and

WHEREAS, Miguel Álvarez Gimeno was a Cuban patriot, a member of the 2506 Brigade during the Bay of Pigs invasion, and president of the 2506 Brigade Veterans Association; and

WHEREAS, Miguel Álvarez Gimeno participated in many actions aimed at liberating Cuba from the Castro dictatorship; and

WHEREAS, Miguel Álvarez Gimeno is remembered as a loyal friend and brother to anyone who was going through a difficult situation; and

WHEREAS, it is appropriate that the City Commission honor the life of its exemplary resident by co-designating that portion of Southwest 10th Street from Southwest 15th Avenue to Southwest 19th Avenue, Miami, Florida as "Miguel Álvarez Gimeno Way";

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF MIAMI, FLORIDA:

Section 1. The recitals and findings contained in the Preamble to this Resolution are adopted by reference and incorporated as if fully set forth in this Section.

Section 2. After an advertised public hearing, the City Commission hereby co-designates that portion of Southwest 10th Street from Southwest 15th Avenue to Southwest 19th Avenue, Miami, Florida as "Miguel Álvarez Gimeno Way"

Section 3. The City Clerk is directed to transmit a certified copy of this Resolution to the Departments of Police, Fire-Rescue, and Solid Waste; the Miami-Dade County Department of Transportation and Public Works; and the United States Postal Service.

Section 4. This Resolution shall become effective immediately upon its adoption and signature of the Mayor.¹
