The administration will be requesting that item 200093 be amended to include the First Amendment to Option Agreement for Sale and Purchase, which is included with this supplement. The First Amendment provides for time extension to the "Assignment of Option to Purchase" for the purchase of approximately five acres within the Environmentally Endangered Lands Program South Dade Wetlands Project with William T. The amendment, the First Amendment to Option Agreement for Sale and Purchase, was signed by the seller and accompanies this supplement.

2. <u>Binding Effect</u>. All other terms of the Option remain unchanged and in full force and effect and are hereby ratified and confirmed as of the date first above written.
