The administration will be requesting that item 200094 be amended to include the First Amendment to Option Agreement for Sale and Purchase, which is included with this supplement. The First Amendment provides for time extension to the "Assignment of Option to Purchase" for the purchase of approximately 4.82 acres within the Environmentally Endangered Lands Program South Dade Wetlands Project with Fenelus Antoine as Seller.

This item was initially on the agenda for the February 11, 2020 meeting of the Infrastructure and Capital Improvements Committee (ICIC), which was canceled. Item was then favorably forwarded from the March 10, 2020 meeting of the ICIC. Due to pending expiration of the purchase agreement, item was approved by the Chairwoman to be waived to the March 17, 2020 meeting of the Board, which was subsequently canceled. It was necessary to amend the assignment of option to purchase to extend the option expiration date from April 6, 2020 to June 30, 2020. The amendment, the First Amendment to Option Agreement for Sale and Purchase, was signed by the seller and accompanies this supplement.

FIRST AMENDMENT TO OPTION AGREEMENT FOR SALE AND PURCHASE

THIS FIRST AMENDMENT TO OPTION AGREEMENT FOR SALE AND PURCHASE (this "First Amendment") is made this 2 6 day of YM1 CC. , 2020, between FENELUS ANTOINE, whose address is 22716 Beltress Ct., Land O Lakes, FL 34649, as "Seller" and THE NATURE CONSERVANCY, a nonprofit District of Columbia corporation, as Trustee of The Nature Conservancy Charitable Trust dated May 11, 1998 as amended, whose address is 2500 Meitland Center Parkway, Suite 311, Maitland, Florida 32751, and its successors and assigns as "Purchaser".

WITNESSETH

WHEREAS, the parties hereto entered into that certain Option Agreement for Sale and Purchase dated October 10, 2019 (the "Option") in connection with certain property located in Miami-Dade County, Florida.

WHEREAS, the parties desire to amend the Agreement to extend the Option Expiration Date.

1. Paragraph 2 is deleted in its entirety and replaced with the following:

"2. OPTION TERMS.

The option payment is \$100.00 (the "Option Payment"), the receipt and sufficiency of which is hereby acknowledged by SELLER.

The Option is exercised by BUYER delivering written notice of exercise to SELLER during the period beginning with BUYER'S execution of this Agreement and ending June 30, 2020 (the "Option Expiration Date"), unless extended by other provisions of this Agreement."

2. <u>Binding Effect</u>. All other terms of the Option remain unchanged and in full force and effect and are hereby ratified and confirmed as of the date first above written.
