<u>Recommendation</u>

It is recommended that the Board of County Commissioners (Board) approve a competitive contract award, *Contract No. FB-01639*, *Chillers and Water Treatment Services*, for multiple County departments. This contract will replace a competitively solicited contract, FB-00074, which was awarded by the Board on March 3, 2015 through Resolution No. R-206-15 for a six-year term.

The contract will provide for turnkey maintenance and water treatment services for air conditioning chillers and auxiliary equipment (i.e. structural components, chilled water pumps, pneumatic compressors, associated piping) located at various County facilities. The solicitation has nine groups (Groups A-I), one for each department included in the contract. The recommended vendor will be required to deliver a comprehensive preventive maintenance program, including all necessary labor, transportation, materials and equipment for the safe operation of chillers, cooling towers, pumps, and auxiliary equipment. In addition to the equipment maintenance, the recommended vendor shall institute a complete water treatment program needed to protect air conditioning, heating equipment and piping from deterioration.

Four bids were received in response to the solicitation, including two "No Bids." Upon advertisement of the solicitation, 10,183 vendors were notified in BidSync, of which 92 vendors viewed the solicitation. Additionally, the local business tax database was used to search for additional vendors by commodity code. The solicitation is being awarded to the lowest, responsive and responsible bidder.

The Internal Services Department has the highest allocation on this contract because the department maintains chiller systems in both the Central Support Facility and the North District Chiller Plant using the services on this contract, which are required to safely and adequately service the chilled water lines and systems of 12 buildings currently housing more than 40 different County and non-County departments and entities. Most of the buildings are in the downtown area such as Overtown Village North and South, Children's Courthouse, Courthouse Center, Hickman, West Lot Garage, Central Support Facility, Cultural Center/Plaza, Stephen P. Clark Center, Dade County Courthouse, 140 West Flagler building, and will also maintain the future New Civil and Probate Courthouse. In addition, the chiller systems managed by the Internal Services Department service two other buildings: the American Airlines Arena and Equinox Data Center.

The Miami-Dade Aviation Department has a separate contract for chillers and water treatment services tailored specifically to Airport facilities that includes different equipment and levels of service than the remainder of the County facilities. Aviation's contract FB-01556 is traveling separately but within the same timing as this contract award, as they were both resolicited at the same time.

Scope

The impact of this item is countywide in nature.

Delegated Authority

If this item is approved, the County Mayor or County Mayor's designee will have the authority to exercise all provisions of the contract, including any cancellation, renewal, or extension provisions, pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38.

Fiscal Impact/Funding Source

The fiscal impact for the six-year term is \$12,145,122. The current contract, FB-00074, is valued at \$9,047,134 for a six-year and six-month term and expires on September 30, 2021. The allocation under the contract is higher than the current contract due to changes in the scope of work, to include increased service frequency and additional equipment to be serviced for some County departments.

Vendor Recommended for Award

An Invitation to Bid was issued under full and open competition. Four bids were received in response to the solicitation including two "No Bids." One of the bidders was deemed non-compliant to the Small Business Program, and therefore ineligible for award.

Pursuant to Resolution No. R-477-18, the lowest priced, responsive and responsible bidder is recommended in accordance with the method of award per the solicitation and is non-local. No local vendors responded to the solicitation because there are limited number of vendors with the required certifications, licenses, permits and experience who can perform these services.

Due Diligence

Pursuant to Resolution No. R-187-12, due diligence was conducted in accordance with the Internal Services Department's Procurement Guidelines to determine vendor responsibility, including verifying corporate status and that there are no performance and compliance issues. The lists that were referenced included convicted vendors, debarred vendors, delinquent contractors, suspended vendors, and federal excluded parties. There were a few adverse findings with regards to Johnson Controls, Inc. which were reviewed by staff and were addressed satisfactorily by the firm.

Pursuant to Resolution No. R-140-15, prior to re-procurement, a full review of the scope of services was conducted to ensure the replacement contract reflects the County's current needs. The review included conducting market research, posting a draft solicitation for industry comment, and holding meetings and drafting sessions with the user department. The scope of services was updated to include a current list of equipment to be serviced, service frequencies, and revision of ambiguous language to ensure clarity.
