Recommendation

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for Cannery Row is bounded northwesterly approximately 220 feet southwesterly of SW 144 Avenue Road, northeasterly by SW 261 Street, southeasterly by the Miami Dade County Busway, and on the south by SW 264 Street.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Full scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

<u>Scope</u>

This plat is located in Commission District 8, which is represented by Commissioner Danielle Cohen Higgins.



RESOLUTION APPROVING THE PLAT OF CANNERY ROW FILED BY CANNERY ROW AT REDLANDS CROSSING, LLLP AND CANNERY HOLDINGS, LLC, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 27 TOWNSHIP 56 SOUTH, RANGE 39 EAST (BOUNDED NORTHWESTERLY APPROXIMATELY 220 FEET SOUTHWESTERLY OF SW 144 AVENUE ROAD, NORTHEASTERLY BY SW 261 STREET, SOUTHEASTERLY BY THE MIAMI DADE COUNTY BUSWAY, AND ON THE SOUTH BY SW 264 STREET)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, Cannery Row at Redlands Crossing, LLLP, a Florida limited liability limited partnership and Cannery Holdings, LLC, a Florida limited liability company, have this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as "Cannery Row," the same being a replat of a portion of Lot 1, in Block 1, of "M.C.R. Industrial Park," according to the plat thereof, as recorded in Plat Book 148, at Page 41 of the Public Records of Miami-Dade County, Florida, lying and being in the Southwest 1/4 of Section 27, Township 56 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or
