Recommendation

It is recommended that the Board of County Commissioners (Board) authorize the County Mayor or County Mayor's designee to approve the attached resolution by retroactively approving the submittal of grant application (Attachment A) to the United States Department of Veterans Affairs 2021 National Veterans Sports Programs for Project VICTOR (Veterans Integrated Into The Community Through Outdoor Recreation) Adaptive Sports Program. It is further recommended that the Board authorize the County Mayor or County Mayor's designee to receive and expend funds and execute grant agreements, certain amendments and other documents as required by the grant agreement upon review and final approval of the County Attorney's Office.

Scope

The project is county-wide and includes various Miami-Dade County parks: A.D. Barnes Park, Amelia Earhart Park, Camp Matecumbe, Crandon Park, Goulds Park, Greynolds Park, Gwen Cherry Park, Marva Bannerman Park, Matheson Hammock Park, Tamiami Park, and Trail Glades Range.

Delegation of Authority

The Board authorizes the County Mayor or Mayor's designee to accept and expend funds and execute contracts, amendments, and other documents as required by the grant, upon review and final approval of the County Attorney's Office. The County Mayor or Mayor's designee shall be required to seek Board approval for any approvals, consents, actions, events or undertakings that would create a financial obligation, cost or expense to the County beyond those specifically identified and set forth in the Agreement.

Fiscal Impact/Funding Source

Project VICTOR is a multi-sport outdoor adaptive sports program at County parks servicing disabled veterans in the South Florida area. The total cost of the project is \$162,115.96. If awarded, the Adaptive Sports Grant Program (ASG) will provide funds of \$128,036.93. The ASG Program has no requirement for matching funds. However, in-kind contributions, supported by the Parks, Recreation and Open Spaces Department (PROS) for \$34,079.03 were included to demonstrate resources related to the project. There will be no fiscal impact to the Department if the grant is awarded. The part-time positions listed as "TBA" in the grant application are accounted for in the Department's budget; however, these positions rotate among sites and therefore will be utilized from a pool of existing staff.

Track Record/Monitor

The U.S. Department of Veterans Affairs Adaptive Sports Grant Program has awarded to PROS \$305,681.01 in grants since 2012. The proposed grant will be administered by PROS Grants Supervisor, Dorothy Mills-Mayers.

Background

The ASG Program is administered through the United States Department of Veterans Affairs (VA). The ASG Program is designated for veterans with disabilities and members of the Armed Forces. The ASG Program provides grant funding to organizations to increase and expand the quantity and quality of adaptive sport activities for veterans and service members with disabilities (including those with mental health issues) to participate with their home communities, as well as more advanced Paralympic and adaptive sport programs at the regional and national levels. Originally authorized as the U.S. Paralympics Integrated Adaptive Sports Program in December 2013, Public Law 113-59 amended U.S.C. 521A and designated the VA's Office of National Veterans Sports Programs and Special Events (NVSP&SE) to directly manage the ASG Program.

If awarded, the grant term is expected to be in fiscal years 2021 and 2022. The project is expected to be completed within the term of the grant. The application deadline was March 31, 2021. However, there was insufficient time from the opportunity announcement to the grant deadline to obtain a resolution. An adopted resolution was not required by the funding agency for the application submittal. The Board approved a previous PROS grant application for Project VICTOR Adaptive Sports in 2019 by Resolution No. R-797-19. It is recommended that the Board approve this grant application in order for PROS to continue providing recreational services to veterans.

Abstract

The 2021 Miami-Dade Parks VICTOR Adaptive Sports Program is a multi-sport program that will provide Disabled Veterans with the opportunity to engage in various sports in order to promote the overall quality of life for individuals by emphasizing the importance of physical fitness and well-being, decreasing social isolation, and providing education on the value and use of recreation as a means tocope with trauma, stress, and to develop a sense of identity. The sports that will be offered include: Archery, Boccia, Camping, Adapted Aquatics, Wheelchair Basketball, Pickleball, Cycling, Paddlesports, Trap Shooting, Fishing, Snorkeling, Sailing, Wheelchair Tennis, Waterskiing, Kiteboarding, and Walking/Hiking. This program also seeks to provide Disabled Veterans progressing along theathletic pipeline with access to competitive-level quality equipment for training purposed. The primary disability populations that will be served through this program include: Spinal Cord Injury and otherrelated diseases and disorders affecting the central nervous system such as Multiple Sclerosis and Amyotrophic Lateral Sclerosis, amputations, range of motion limitations due to disease or injury, traumatic head injury, stroke, visual impairments, and those affected by Post Traumatic Stress Disorder.

I. Program Past Performance

Organizational Overview

The Miami-Dade County Parks, Recreation, and Open Spaces Department (MDPROS) mission statement is to create outstanding recreational, natural, and cultural experiences to enrich and enhance the quality of life for our community for this and future generations. MDPROS is the third largest park and recreation system in the United States comprising 275 parks properties. MDPROS is equipped to serve the Miami-Dade County community and over 25 million visitors annually. PROS is a three-time NRPA National Gold Medal winner and the 2013 Florida Governor's Sterling Award winner, that operates a nationally accredited large multi-dimensional park system recognized as a national model of excellence and efficiency. MDPROS's strategic direction is set during annual and five-year recreational planning processes within the County's strategic planning process.

The Miami-Dade County Parks Therapeutic Recreation and Inclusion Division (TRI) has provided programming in adapted sports for over 26 years, including ongoing sports programs, seasonal clinics, and annual events.

During the last eight years, MDPROS TRI division has had great success in planning and collaborating with the Bruce W. Carter VAMC Spinal Cord Injury (SCI) Unit, Amputee Clinic, the OEF/OIF Outpatient Program, the Paralyzed Veterans Association of Florida and the Wounded Warrior Project in the development and delivery of adapted sports programs to Disabled Veterans. The division has been a recipient of the Veterans Adapted Sports grant for the fiscal years 2014-15, 2017-18, 2018-19, 2019-20, as well as the current 2020-21 fiscal year. Through the Adaptive Sports Program, the division has served over 125 unique disabled veterans.

The current 2020-21 VICTOR Adapted Sports program has already served over sixty unique Disabled Veterans living in Miami-Dade County and vicinity by the middle of the second quarter. Program activities are held on a weekly basis and on several days throughout the week in order to maximize opportunities for participation. The expected turnout has been slightly lower than anticipated due to COVID-19 and the program has had to modify the capacity of veterans served during each activity due to mitigation measures; however, turnout remains consistent.

A. Program Details and Specifics

The 2021-22 VICTOR Adapted Sports Program is a multi-sport program that provides training and recreational opportunities in 16 different adapted sports to veterans living with physical disabilities, those affected by illness or disease, and those affected by PTSD and other mental health issues. Activities are coordinated and supervised by a Certified Therapeutic Recreation Specialist who plans schedules in collaboration with staff from the Bruce Carter VAMC, Wounded Warrior Project, and Paralyzed Veterans Association of Florida. Activities will be scheduled throughout the week, ongoing throughout the year.

All program components will provide both in-person training opportunities and 14 of the components will offer a virtual component which will be presented either pre-recorded or live. The virtual activities will be to offer an alternative session to veterans who have been or are being affected by the COVID pandemic and will consist of (but not be limited to): 1. Rules of the sport and how to play, 2. Adapted equipment for the sport (types, use, and care of), 3. Exercises and techniques to improve performance in the sport, 4. Safety, and 5. A virtual experience for those who are not able to physically attend a live session. All activity sessions have a duration 2-3 hrs, clinics will typically have a duration 2-8 hours depending on the sport and the frequency of clinic offerings, and virtual sessions have a duration of 1-2 hrs.

The program components are as follows:

- <u>Adapted Aquatics</u> (local/introductory/community competition) will include 6 bi-weekly, in-person sessions and a minimum of 3 virtual sessions to include instruction and coaching on techniques to improve swim stroke and efficiency with a former Paralympic swim coach. Veterans to be served: 10
 - <u>Archery</u> (local/introductory and community event) will include a minimum of 20 weekly sessions, and 4 virtual lessons on the fundamentals of archery and the use of adapted equipment. Additionally, 1 competitive event will be held for program participants. Veterans to be served: 12
 - 3. <u>Boccia</u> (community event/introductory) will included 4 in-person clinics, and 1 recreational tournament in the Spring 2022. 6 virtual sessions will be provided to include instruction on the rules of boccia, the fundamentals of play, strategy, and drills to improve technique. Those participating in the virtual program will be provided with equipment which they can use at home. An optional virtual competition will also be provided. Veterans to be served: 12
 - 4. <u>Camping</u> (local/requires travel/introductory) one 3-day trip will be offered on Elliot Key in Biscayne National Park in partnership with Wounded Warrior Project, Biscayne National Park and the National Park Conservation Association. The trip will include a hiking, snorkeling and kayaking component. Veterans to be served: 8
 - 5. <u>Cycling</u> (local/introductory) will include 6 handcycling and tandem cycling clinics for veterans with physical or visual disabilities, a minimum of 2 virtual sessions on the fundamentals of handcycling, caring for equipment, and safety education, 4 long community rides in partnership with our department's ECO Adventures division, as well as 1 virtual bike tour. Veterans to be served: 15
 - 6. <u>Fishing</u> (local/introductory)Ten fishing excursions in Biscayne Bay on a vessel which can accommodate up to 15 participants will be offered as well as 4 virtual lessons on the fundamentals of fishing, fishing regulations in Florida, adapted equipment, conservation and fishing sustainability, and how to filet and prepare fish for a healthy meal. Veterans to be served: 18
 - 7. <u>Kiteboarding</u> (local/introductory) will include two Level 1 (10 hr.) courses and 1 Level 2 (10 hr.) courses for skill-advanced participants. Veterans to be served: 10
 - 8. <u>Paddlesports (kayaking and stand up paddleboards)</u> will include 1 paddleboard clinic in partnership with Adventure Sports, 2 introductory kayaking clinics, 10 in-person

kayaking/paddleboarding excursions throughout Miami-Dade County in partnership with our ECO Adventures division, and 4 virtual lessons on the fundamentals of kayaking/paddling. Veterans to be served: 15

- 9. <u>Pickleball</u> (local/introductory)will included a minimum of 4 in-person introductory clinics to aging Veterans and Veterans who use wheelchairs, 4 virtual lessons will be provided to include instruction on the fundamentals of play, the rules of the sport, and exercises to improve balance and coordination while playing. Veterans to be served: 8
- 10. <u>Sailing</u>(local/introductory/community competition/national competition) in partnership with Team Paradise Sailing, will provide a minimum 12 sessions of adapted sailing under the instruction of U.S. Olympic Gold Medalist, Magnus Liljedahl and a minimum of 4 virtual sailing lessons to include an introduction to the fundamentals of keelboat sailing. Two scholarships for veterans to complete the keelboat sailing course will also be offered so that veterans may prepare themselves for annual regattas piloting vessels for other veterans. Veterans to be served: 10
- 11. <u>Snorkeling</u> (local/introductory will included 1 trip on the coral reef system within Biscayne National Park and 3 kayaking/snorkeling combination trips out of Crandon Beach. Veterans to be served: 8
- 12. <u>Trap Shooting</u> (local/introductory/community competition) will include a minimum of 30 weekly sessions, 3 virtual trap shooting and skeet lessons which will include the fundamentals of the sport, improving performance, and safety. Veterans to be served: 15
- 13. Walking/Hiking (local/introductory/community competition) will include a minimum of 4 virtual sessions on the fundamentals and benefits of starting a walking program and an exercise program to improve coordination, endurance, and balance, integration in the department's weekly Walking Club incentives program throughout Miami-Dade County, 2 Power Walk competitions, and 2 guided nature hikes. Veterans to be served: 12
- 14. <u>Waterskiing</u> (local/introductory) two two-day clinics will be provided in partnership with Ann's Angels Adapted Waterski Foundation to help train those veterans who will be participating in skiing at the Winter Sports Clinic. 1 virtual lesson on the fundamentals of waterskiing will also be provided. Veterans to be served: 12
- 15. <u>Wheelchair Basketball</u> (local/introductory/community competition/national competition) will include 2 in-person clinics, and 4 virtual lessons, and an option to continue training and in weekly practices and competing with the Miami Heat Wheels wheelchair basketball team/program which will offer a minimum of 50 additional practices throughout the year. Veterans to be served: 6
- 16. <u>Wheelchair Tennis</u> (local/introductory)will include 2 in-person clinics and 2 virtual lessons on the fundamentals of wheelchair tennis, rules, equipment necessary, and drills to improve skills and technique, and a minimum of 12 weekly practices to improve skill development will be offered. Veterans to be served: 6

The goals and objectives this program seeks to achieve are:

- A. To promote the lifelong health of disabled veterans and disabled members of the Armed Forces through regular participation in physical activity and sports.
 - 1. Provide multiple program opportunities for disabled veterans and disabled members of the Armed Forces within the following disability types: spinal cord injury, individuals with multiple sclerosis, amputees, traumatic head injury, PTSD, visual disabilities, and those disabled through either disease or by the aging process which foster:
 - a. A therapeutic environment in which Veterans can learn how to cope with and manage the effects of disabling conditions.
 - b. Improved physical performance through individualized activities that promote achievement of performance goals, progressive physical challenges, and skills acquisition.
 - 2. Provide ongoing education to Disabled Veterans in order to increase or improve:
 - a. The awareness of the benefits of participation in sports,

- b. Self-awareness in sports and leisure participation,
- c. The awareness of opportunities to participate in sports and competitions, and
- d. The development of alternative personal strategies to cope with, manage, and/or improve the effects of disabling conditions.
- 3. Provide opportunities for disabled veterans to engage in specialized training beyond onetime experiences that will lead into and encourage long-term participation in various sports by:
 - a. Providing consecutive kiteboarding lessons with trained instructors,
 - b. Providing supplies for trap shooting which would be cost-prohibitive for many individuals,
 - c. Providing advanced and high-performance training and competitive opportunities in sailing, wheelchair basketball, boccia, archery, trap shooting, and power walking.
- B. To increase participation of disabled veterans and disabled members of the Armed Forces in adapted sports:
 - 1. Provide a minimum of 150 recreation and sports training opportunities throughout the South Florida region at multiple locations, days of the week, and at various times throughout the year in order to maximize the number of unique veterans served through the program.
 - 2. Provide the opportunity for disabled veterans to engage in adapted sports programming at no cost.
 - 3. Expand the outreach of programming through partnership organizations, which will draw in disabled veterans from other areas within the state and nationally.

II. Implementation Plan and Environment

The proposed program is designed to be primarily operated out of Miami-Dade County through the already existing resources of MDPROS. The majority of activities will take place at various MDPROS facilities, with few exceptions for some of the water sports activities, so that there is little to no turnover time in planning and scheduling of activities.

Activity schedules and dates will be coordinated among MDPROS staff, VA therapists, and collaborating organizations. Master schedules will be disseminated amongst all interested parties and all disabled veterans already in the Miami-Dade Parks database, as well as available online for veterans to schedule for themselves. Programs will be offered throughout the week on various days and at various times. Some activities will only be scheduled during certain operating quarters taking the South Florida climate into consideration.

Funding for the program will go to the cost of purchasing supplies needed to operate the program, which include but are not limited to fees at the shooting range, charter boats rental for fishing, snorkeling, ECO Adventure activities, and specialized instructor fees, training for staff, and personnel operations to cover the cost of park staff implementing programs and working directly with disabled veterans during program activities.

Purchased supplies will also enhance already existing programs as well as new ones, by replacing items that have already been used up either as a consumable product or through normal wear and tear. Additional resources that will be provided by MDPROS include already allocated resources from previous grant cycles such as archery supplies, boccia supplies, sports wheelchairs, handcycles, and shotguns, indoor and outdoor facilities including gym space, shooting range, beach areas, pool space, and vehicles to transport supplies from one park to another.

Upon conclusion of the award period, it is intended that the following deliverables be achieved:

- 1. That a minimum of 80 unique disabled veterans be served through the program,
- 2. That a minimum of 150 days of programming be offered through the program,
- 3. That a minimum of 10 disabled veterans will participate in either a competition of one of the sports being offered or will move into a high-performance training program for a sport they have participated in through the program.
- 4. That the average overall satisfaction rate among participants with the program will average 4.3 or higher on a Likert scale.
- 5. That the overall outcomes and success of the program will be shared by other professionals at a state or national conference.

Most of the activities can be implemented immediately as the majority of the resources are already in place. Planning and preliminary scheduling have already begun amongst interested entities in order to implement the program effective October 1st.

III. Impact

The proposed program has the potential to significantly impact the amount of adapted sports being offered through the region as well as draw awareness to adapted sports and disabilityrelated issues. Furthermore, the outreach and programming efforts within boccia and pickleball will also extend to the aging population; which, may have an impact on the overall awareness of and participation of aging veterans who can compete at the Golden Age Games. The implementation of the virtual component for activities has the potential to improve the overall level of health and quality of life of veterans, who have been homebound or deemed high-risk as a result of the COVID pandemic. Finally, as part of the effort to document outcomes achieved through the program and raise awareness about the benefits of adapted sports programming for disabled veterans, it is expected that more opportunities will arise in the community as possible partners for further programming in the future.

IV. **Program Sustainability**

Programs and access to each of the sports being offered already exist through the PROS system. During each sport activity, program participants will be provided a leisure education component that includes education on the importance of maintaining a healthy lifestyle through ongoing participation. Program participants will be provided with resources they can connect with to continue pursuing their interests and will be encouraged to do so independently.

At the end of the program, veterans will continue to be provided with the opportunity to engage in the following programs at no cost: archery, wheelchair basketball, and handcycling. Fishing, cycling, trap shooting, snorkeling, camping and archery equipment will be made available at no cost for use by VA hospital therapists as well as equipment for local and out of state competition. Disabled Veterans will also have priority access to the use of equipment during ongoing programs with prior notification at no cost.

I. Budget Narrative and Details

The costs for personnel include fringe and benefits calculated into the hourly rate. These individuals are necessary in order to ensure the safety of the participants attending the program to provide any needed assistance and transferring of individuals in/out of equipment. Operational expenses include the rate of the cost of rounds and ammunition for trap shooting. the cost of nature-based interpretive programs, the cost of operating a water ski clinic with a partnership organization, sailing sessions with a partner organization, the cost of kiteboarding lessons with two partnering organizations and chartering a boat for fishing, snorkeling, and camping excursions. The costs for supplies were based on online searches and through current vendor prices which will include:

- A WiFi hotspot to provide live virtual programming at remote park sites.
- Archery supplies which includes, arrows, targets, and items for bow maintenance.
- Fishing supplies which includes rod and reel combos and tackle.
- Supplies to mail out to veterans to participate in virtual activities (resistance bands for exercise and foot sacks for modified boccia).
- Tents and inflatable pads for camping.
- Additional adapted cycles (2 tandem cycles, 2 foot-pedaled recumbent cycles, and 1 tandem trike) to accommodate those with different types of physical/visual disabilities.
- Two additional basketball wheelchairs to accommodate veterans of different sizes.
- Two additional foot-pedaled kayaks to accommodate veterans with MS, TBI, hemiparesis, and those with upper limb limitations and high-back seats for standard kayaks to provide additional support to veterans who may have back issues or who cannot tolerate sitting on kavaks unsupported for extended periods of time.

In kind contributions supported by MDPROS include partial operational expenses for 8 full-time staff inclusive of recreational therapists, disability program specialists, and recreational specialists in the amount of \$34,079.03. Additional in-kind contributions for events and activities include funding for 21

a round-trip boat ride to Elliot Key for camping by the Wounded Warrior Project.

Key Personnel

Jody Cox, B.S., CTRS, (Recreation Therapist II): Perform all program development and planning, scheduling of activities, and perform administrative tasks related to the grant including writing quarterly reports. Mrs. Cox will provide direct oversight and implementation of the program with other staff working in conjunction with her. She is the primary person responsible for communication with VA staff and other partner organizations, planning, marketing, and coordinating all activities and schedules, monitoring staff hours worked in the program, researching and ordering equipment, and tracking all invoices and expenditures. Mrs. Cox has a B.S. Degree in Therapeutic Recreation and over 26 years experience working in the field of Therapeutic Recreation as a CTRS. Over 17 years in planning, developing and implementing Paralympic and adapted sports programming for Miami-Dade County Parks Disability Services. Certified as a Therapeutic Recreation Specialist through the National Council on Therapeutic Recreation Certification, National Wheelchair Basketball Association (NWBA) coach, Archery Level I Instructor through USA Archery, Water Safety Instructor and CPR/First Aid Instructor through the American Red Cross, and ADA Coordinator certification through the Great Plains ADA Center and the University of Missouri. Budget request is for \$8,342.10 (salary and fringe). In-kind contribution totaling \$14,482.53 (salary and fringe). Total hours expected to work in the program directly with veterans and administering the program is 421 hours.

Belinda Phillips, M.S., CTRS (Recreation Therapist II): Provide direct supervision and activity instruction. Coordinate adapted aquatic activities and pickleball with VA personnel and pool staff. Ms. Phillips has a B.S. and a M.S. Degree in Education. She has over 32 years of experience working in the field. She is a Water Safety Instructor Trainer and also holds certification in CPR/First Aid. Ms. Phillips coached the Jamaican Paralympic Swim team during the 1988 Summer Paralympic Games in Seoul, Korea. She will lead in swimming activities. Budget request is for \$1,908.46 (salary and fringe). In-kind contribution totaling \$1,066.15 (salary and fringe). Total hours expected to work in the program directly with veterans and administering the program is 56 hours.

Christina Perez (Recreation Therapist II): Provide direct supervision and activity instruction. She will be instrumental in delivering aquatic-based activities and will take lead in wheelchair tennis. She has a B.S. degree in Therapeutic Recreation, 5 years experience in the field, and holds certification as a Water Safety Instructor, Lifeguard, and CPR/First Aid through the American Red Cross. Budget request is for \$3,313.85 (salary and fringe). In-kind contribution totaling \$1,387.19 (salary and fringe). Total hours expected to work in the program directly with veterans and administering the program is 106 hours.

Arlene Bouza-Jou (Recreation Specialist I): Provide direct supervision and activity instruction. She has over 24 years working in various adapted sports programs. She will be assisting in activity instruction and supervision and will lead in handcycling activities. She is certified as a Water Safety Instructor and as an Archery Level I Instructor and holds certification in CPR/First Aid through the American Red Cross. Budget request is for \$754.11 (salary and fringe). In-kind contribution totaling \$837.90 (salary and fringe). Total hours expected to work in the program directly with veterans and administering the program is 38 hours.

Camila Carvacho, B.S., (Disability Program Specialist): Will work under the supervision of Recreation Therapists and Specialists in providing direct service delivery to program participants. She has a B.S. Degree in Therapeutic Recreation and is certified as a NWBA coach, Water Safety Instructor and holds certification in CPR/First Aid through the American Red Cross, Archery level I instructor and has 8 years

experience in working with individuals with disabilities. Budget request is for \$0 (salary and fringe). In-kind contribution totaling \$1,368.90 (salary and fringe). Total hours expected to work in the program directly with veterans and administering the program is 44 hours.

Charmaigne Crosby (Disability Program Specialist): Will work under the supervision of Recreation Therapists and Specialists in providing direct service delivery to program participants. She has 17 years experience working with individuals with disabilities and is a certified NWBA coach and Water Safety Instructor and holds certification in CPR/First Aid through the American Red Cross. Budget request is for \$2,007.36 (salary and fringe). In-kind contribution totaling \$344.12 (salary and fringe). Total hours expected to work in the program directly with veterans and administering the program is 82 hours.

Randall Flagler, M.S., (Disability Program Specialist): Will work under the remote supervision of Mrs. Cox in the implementation of activities. Mr. Flagler will lead facilitation of archery, trap shooting, fishing, and wheelchair basketball. He has a M.S. Degree in Sport Management and a B.S. Degree in Sports and Recreation Management and 4 years experience working in various adapted sports programs, and is certified as a NWBA coach and Archery level I instructor and holds certification in CPR/First Aid through the American Red Cross. Budget request is for \$12,573.56 (salary and fringe). In-kind contribution totaling \$12,262.29 (salary and fringe). Total hours expected to work in the program directly with veterans and administering the program is 798 hours.

Eric Cooper, B.S. (Disability Program Specialist): Will work under the supervision of Recreation Therapists in the direct delivery of services to program participants. He has a B.S. degree in Recreation Therapy and 2.5 years experience working directly with Disabled Veterans. Budget request is for \$6,584.87 (salary and fringe). In-kind contribution totaling \$553.35 (salary and fringe). Total hours expected to work in the program directly with veterans and administering the program is 268 hours.

TBA (Recreation Leader): Will work directly under the supervision of Recreational Therapists and Disability Program Specialists in the implementation of activities. These individuals will come from a pool of part-time staff who already work within the TRI division and who have a minimum of 2 years experience working with individuals with disabilities. Budget request is for \$7,053.64 (salary and fringe). In-kind contribution totaling \$276.59 (salary and fringe). Total hours expected to work in the program directly with veterans and administering the program is 302 hours.

Partnerships

The primary collaborating partner for the MDPROS Veteran's Adapted Sports Program is the Bruce W. Carter VA Medical Center. Currently, MDPROS Therapeutic Recreation and Inclusion staff is working with several key therapists at the Bruce W. Carter VA Medical Center to plan programs with the disabled veterans in mind. The key staff from the Bruce W. Carter VA Medical Center includes: Jasmine Martinez-Barrizonte, DO, Alexander Maitre, CTRS, who works with the SCI and amputee populations, Tabitha Aragon, CTRS from the Outpatient OEF/OIF Program, and Christine Dugrot, CTRS and Zuleika Smith, CTRS from the Psychosocial Unit. Additional major collaborating partners include the Paralyzed Veterans Association of Florida, the National Parks Conservation Association. Miami Kiteboarding, Adventure Sports. Florida International University Recreation Therapy Program, The Wounded Warrior Project, Miami-Dade County ECO Adventures, Team Paradise Sailing, the Miami Vet Center, and the Veteran's Services Coalition of Miami-Dade County.
