RESOLUTION NO.

RESOLUTION DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO UNDERTAKE AN ANALYSIS OF AND EXAMINE ESTABLISHING LOCAL PREFERENCE RECIPROCITY WITH BROWARD COUNTY AND MONROE COUNTY AND TO PROVIDE WRITTEN REPORT BACK TO THIS BOARD WITHIN 60 DAYS ON STATUS

WHEREAS, pursuant to section 2-8.5 of the Code of Miami-Dade County, Florida ("County Code"), in any County competitive bid process where award is to be made to the responsive and responsible bidder offering the lowest bid, any local business that is within 10 percent of, or any locally headquartered business that is within 15 percent of, the low bid from a non-local business, shall have an opportunity to submit a best and final bid equal to or lower than the low bid; and

WHEREAS, additionally, pursuant to section 2-8.5 of the County Code, in solicitations that take the form of a request for proposals, any local business that, following the final rankings, is within five percent of the ranking of the highest ranked non-local business, shall have an opportunity to proceed to negotiations with the County; and

WHEREAS, section 2-8.5 of the County Code defines a "local business" as one that, among other requirements, has a physical business address located within the limits of Miami-Dade County from which the vendor operates or performs its business and such business address must have served as the place of employment for at least three full time employees of the vendor for the continuous period of one year prior to the bid or proposal submission; and

WHEREAS, section 2-8.5(6) of the County Code sets forth a reciprocity provisions to the County's local preference ordinance whereby local businesses in the County may also be

considered local businesses in Broward County, Palm Beach County and Monroe County and local businesses from those counties may be considered local businesses for purpose of the County's local preference ordinance following the execution of an interlocal by the affected governmental entities; and

WHEREAS, Broward County also has a reciprocity provision in its local preference ordinance; and

WHEREAS, the County previously had an interlocal agreement with Broward County which expired on September 30, 2017; and

WHEREAS, many residents of Miami-Dade County are employed by local businesses in Broward County and Monroe County; and

WHEREAS, similarly, many residents of Broward County, and Monroe County are employed by local businesses within Miami-Dade County; and

WHEREAS, >><u>this Board desires to examine whether</u><<¹ it would therefore be in the best interest of local businesses in Miami-Dade County and their employees to have local preference programs in Broward County and Monroe County be extended to local businesses in Miami-Dade County; and

WHEREAS, similarly, >><u>this Board desires to examine whether</u><< it would also be in the best interest of County residents that are employed by local businesses in Broward County and Monroe County to have Miami-Dade County extend local preference to those counties' local businesses,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board directs:

Section 1. The County Mayor or County Mayor's designee to [[take all actions necessary to pursue]] >><u>undertake an analysis of and examine the County establishing</u><< local preference reciprocity with Broward County and Monroe County and to provide a written report to this Board within 60 days of the effective date of this resolution on the [[status of the County Mayor's or Mayor's designee's actions taken]] >>results of such analysis and examination<<< to establish reciprocity with said counties along with any recommendations regarding the reciprocity, including but not limited to, recommendations on any amendments needed to the County Code or to said counties' code of ordinances in order to effectuate the reciprocity on local preference reciprocity extended by other governmental entities such as the Miami Dade Public School Board, an evaluation and assessment of the County's past experiences with local preference reciprocity, and the impact that any such reciprocity would have on Miami-Dade County local businesses.<<</p>

Section 2. The Clerk of the Board to send a certified copy of this resolution to the Clerks of the Board of County Commissioners, Chairpersons of the Board of County Commissioners, and Mayors of Broward County and Monroe County.

The Prime Sponsor of the foregoing resolution is Senator René García. It was offered byCommissioner, who moved its adoption. The motion was seconded byCommissionerand upon being put to a vote, the vote was as follows:
