Subject: Miami International Airport (MIA) Retroactive Financial Relief Report – April

At the April 7, 2020 Board of County Commissioners (Board) meeting, Board members adopted Resolution No. R-332-20 as amended, approving a Retroactive Financial Relief Plan (Relief Plan) for airlines, concessionaires, car rental companies, cargo handlers, general aeronautical service permittees, fixed-base operators, and any other tenant providing services at Miami International Airport (MIA) including the aeronautical business operators at the General Aviation Airports (GAA) due to the economic impacts of the "coronavirus disease 2019" (COVID-19) pandemic. This Relief Plan, which went into effect on April 18, 2020, complies with the guidelines published by the Federal Aviation Administration (FAA).

The Relief Plan, which was set to expire on August 31, 2020 was approved by Board members with an initial term of three months and a one-time three-month extension, subject to monthly reviews. Because business revenues and passenger traffic flows continue to remain below pre-pandemic levels throughout MIA, Board members extended the term of the Relief Plan for certain business partners three separate times. Each extension waives the Minimum Annual Guarantee (MAG) and/or rent on a month-to-month basis subject to monthly reviews. The first extension approved at the July 21, 2020 Board meeting via Resolution No. R-749-20 granted an extension from September 1, 2020 to December 31, 2020 for 62 concessionaires, and the only fixed-based operator at MIA required to pay a MAG, Signature Flight Support. The second extension approved at the December 15, 2020 Board meeting via Resolution No. R-1254-20 granted an extension from January 1, 2021 to April 30, 2021 for the same business partners included in the first extension in addition to Goodwill Industries of South Florida, Inc. The third extension approved at the April 20, 2021 Board meeting per Resolution No. 379-21 granted an extension from May 1, 2021 to July 31, 2021 for the same business partners except for Signature Flight Support, whose fixed-based operations are on a clear path to full recovery. By way of these extensions, the County will provide MIA's business partners with the additional assistance needed to help sustain their businesses due to the impacts of the COVID-19 pandemic.

Resolution No. R-1254-20 also directed the County Mayor to prepare a new forward-looking plan for Board approval that provides MIA's concessionaires sustained financial relief prior to the expiration date of the Relief Plan on April 30, 2021. In that regard, the County Mayor was directed to study the impact of passenger traffic levels on business revenues and potential changes to the terms and conditions in MIA's existing concessionary agreements. As such, Miami-Dade Aviation Department (MDAD) staff performed a comprehensive analysis of all applicable performance metrics and evaluated the viability of the business terms and conditions in the concessionary agreements. As a result of these assessments, MDAD staff is proposing to amend certain business terms to reflect a concession pricing strategy and a concession contract term that better suits concessionaires and the County considering the current business environment. MDAD has initiated discussions of these proposed amendments with MIA's concessionaires and is in the process of

finalizing negotiations. Since the ongoing Relief Plan was set to expire on April 30, 2021 and the new forward-looking plan could not be placed on a Board agenda for approval prior to that date, at the April 20, 2021 Board meeting, Board members approved a third extension via Resolution No. 379-21, which extended the Relief Plan to July 31, 2021 on a month-to-month basis (for a total of three months) giving MDAD additional time to finish the negotiations.

The Miami-Dade Aviation Department (MDAD) has prepared this monthly report for the fourth and last month of the second extension period, April 2021. The report provides data related to the financial relief offers made by the County to 62 MIA concessionaires, Signature Flight Support and Goodwill Industries of South Florida, Inc. as well as updates on the changed financial circumstances due to the COVID-19 crisis.

Second Extension of the Relief Plan

Per Resolution No. R-1254-20, the Relief Plan for MIA's concessionaires and Signature Flight Support was extended for a second time on a month-to-month basis for four consecutive months beginning on January 1, 2021 and ending on April 30, 2021, subject to monthly reviews. Goodwill Industries of South Florida, Inc. was also included in the Relief Plan for the specified time period. A summary of the type of financial relief offered through the extension is as follows:

- 1) Waiver of monthly MAG payments, rent, and other related fees for duty-free stores and any other concession operators contracted to pay MAG monthly payment as well as monthly rent. Such waivers are effective on a month-to-month basis from January 1, 2021 to April 30, 2021 and are subject to monthly reviews. These concessionaires will continue to pay the assigned percentage fee of gross revenues in lieu of the MAG and rent for such time period.
- 2) Waiver of MAG monthly payments and other related fees for Signature Flight Support and all other concessionaires with MAG payments, in addition to waiver of monthly fees for Goodwill Industries of South Florida, Inc. Such waivers are effective on a month-to-month basis from January 1, 2021 to April 30, 2021 and are subject to monthly reviews. These concessionaires will continue to pay the assigned percentage fee of gross revenues in lieu of the MAG for such time period, as appropriate.

<u>Impacts of COVID-19 Pandemic</u>

The Transportation Security Administration (TSA) screened its highest number of air travelers in April 2021 as the demand for domestic air travel continues to climb after a challenging year for travel due to the COVID-19 pandemic. There were 13 days in April 2021 during which time TSA screened more than 1,500,000 passengers per day. Most notable is the fact that TSA's travel checkpoint numbers averaged approximately 1,394,000 passengers each day in April 2021 as compared to 111,000 passengers each day in April 2020. This rise in the demand for domestic air travel is expected to continue and to further increase as the busy travel summer season is fast approaching.

Likewise, in April 2021, MIA continued to experience high numbers of domestic air travelers passing through TSA checkpoints with the passenger daily counts exceeding 90,000 passengers

per day for 21 days, capping at 104,381 passengers on April 30th as compared to April 2020, when daily passenger counts did not exceed 9,229 passengers on any given day, reaching bottommost levels on April 14th with 4,238 passengers. The demand for international travel continues to trail behind the demand for domestic travel due to world-wide travel restrictions.

The level of passenger traffic flows and business revenues for April 2021, which are the metrics being used to measure the demand for air travel at MIA are noted below with comparisons to levels reported in 2019, 2020 and 2021.

1. Passenger Traffic Flows at MIA

A comparative analysis of passenger traffic levels for the months of April 2020 and April 2021 shows an average incline in passenger flows (arrivals and departures) of 2,071.9 percent at MIA, with the total number of domestic and international passengers climbing from 129,827 passengers to 2,819,731 passengers. A more detailed look at the analysis confirms that the number of domestic arrivals increased by 1,961.8 percent, from 47,306 passengers to 975,340 passengers while the number of domestic departures also increased by 1,844.6 percent, from 51,388 passengers to 999,278 passengers. The number of international arrivals increased by 4,440.5 percent, from 9,384 passengers to 426,082 passengers, whereas the number of international departures grew by more than 1,826.7 percent, from 21,749 passengers to 419,031 passengers.

On a cumulative basis, a comparative analysis that includes the months of March 2019 through April 2020, as compared to the months of March 2020 through April 2021, shows an average decline in passenger flows (arrivals and departures) of 60.2 percent at MIA, with the total number of domestic and international passengers falling from 48,530,340 passengers to 19,327,592 passengers. Furthermore, the analysis confirms that the number of domestic arrivals decreased by 47.6 percent, from 12,496,515 passengers to 6,544,714 passengers while the number of domestic departures dropped by 48 percent, from 12,586,108 passengers to 6,548,596 passengers. The number of international arrivals decreased by 74.2 percent, from 11,907,918 passengers to 3,068,627 passengers, whereas the number of international departures fell by more than 72.6 percent, from 11,539,799 passengers to 3,165,655 passengers.

2. Gross Revenues Variance Analysis at MIA

Chart A on the next page shows a comparative analysis of total gross revenues for concession operators contracted to pay MAG payments in addition to rent as well as for Signature Flight Support, and concession operators whose MAG payments include rent for the month of April 2019 as compared to April 2021, and the month of April 2020 as compared to April 2021.

As can be seen, the analysis shows an average decline in total gross revenues of 42 percent, with revenues falling from \$41,573,872 to \$24,240,696 when comparing April 2019 to April 2021, and an average increase in total gross revenues of 982 percent, with revenues rising from \$2,239,723 to \$24,240,696 when comparing April 2020 to April 2021. Additionally, Chart A shows the levels of gross revenues generated by these concession operators 1) prior to the pandemic in April 2019, 2) at the onset of the pandemic in April 2020, and 3) one year into the pandemic in April 2021. It should be noted that recovery is underway as evidenced by the increase in revenues when comparing gross revenue streams between April 2020 and April 2021.

On a cumulative basis, a comparative analysis that includes the months of March 2019 through April 2020, as compared to the months of March 2020 through April 2021, shows an average decline in total gross revenues of 66 percent, with revenues falling from \$518,866,784 to \$176,376,907 for concession operators contracted to pay MAG payments in addition to rent as well as for Signature Flight Support, and concession operators whose MAG payments include rent.

Chart B, as shown below, illustrates the total dollar amounts of relief provided by the County to MIA's concessionaires, Signature Flight Support and Goodwill Industries of South Florida, Inc. for the month of April 2021 as well as the billed percentage fee from gross revenues. Each relief offer made and accepted or declined for the month of April 2021 is detailed on Attachment 1, as enclosed.
