Subject:	North Miami Beach Community Redevelopment Agency FY 2019-20 and FY 2020-21 Budgets

Recommendation

It is recommended that the Board of County Commissioners (Board) consider the attached resolution approving the North Miami Beach Community Redevelopment Agency's (Agency) FY 2019-20 and FY 2020-21 budgets for the North Miami Beach Community Redevelopment Area (Area) in the amount of \$4,549,661 and \$5,978,605 respectively.

The Interlocal Cooperation Agreement (Interlocal) between the County, the City of North Miami Beach (City), and the Agency requires the Agency to submit an annual budget for County approval, prior to the Agency expending any funding in the Trust Fund.

Scope of Agenda Item

The Area lies within Commission Districts 2 and 4, represented by Commissioner Jean Monestime and Commissioner Sally A. Heyman, respectively.

Delegation of Authority

This item does not delegate any authority to the Mayor.

Fiscal Impact / Funding Source

The Agency's revenue source is tax increment financing (TIF), which is generated through the incremental growth of ad valorem revenues beyond an established base year, as defined in Section 163.387, Florida Statutes. The countywide TIF payment into the Agency's Trust Fund for FY 2019-20 is \$1,090,388 and the City's TIF payment into the Trust Fund is \$1,394,273. For FY 2020-21 the countywide TIF payment into the Agency's TIF payment into the Trust Fund is \$1,211,375 and the City's TIF payment into the Trust Fund is \$1,590,346.

The County and the City will continue to make annual payments to the Agency through 2028, which is when the Agency and the Area will sunset.

Track Record / Monitor

This item does not provide for contracting with any specific entity, it only approves the Agency's FY 2019-20 Budget of \$4,549,661 and FY 2020-21 Budget of \$5,978,605 as detailed in Exhibit 1 and 2 to the Resolution.

Background

On November 30, 2004 the Board approved Resolution No. R-1345-04, which established the boundaries of the Area and declared the Area to be slum and blight. On June 7, 2005, the Board approved the establishment of the Agency when it adopted the Agency's Community Redevelopment Plan (Plan) pursuant to Resolution No. R-611-05 and funded the Plan when it enacted Ordinance No. 05-110 (Trust Fund). An Interlocal Agreement between Miami-Dade County and the agency was also approved by the Board on June 7, 2005. On December 19, 2006, the Board adopted Resolution No. R-1427-06, allowing the Agency to enter into a loan for infrastructure improvements and property purchase not to exceed \$8 million, and to extend the life of the Agency and the Area from 2015 to 2028. On May 15, 2012, the Board adopted Resolution No. R-429-12, approving the Amended North Miami Beach Redevelopment Plan. On March 7, 2017, the Board adopted Resolution No. R-213-17, amending the North Miami Beach Redevelopment Plan to include new projects, update information and incentivize a healthy mix of affordable, workforce and market housing.

FY 2019-20

The Agency's FY 2019-20 budget of \$4,549,661 was approved by the Agency through Resolution No. 2019-05 on September 3, 2019 and by the City through Resolution No. 2019-78 on September 17, 2019 as noted in Attachment A. The budget includes \$1,090,388 in County TIF, \$1,394,273 in City TIF, projected carryover funds of \$2,050,000, and \$15,000 in interest earnings. The budget is being presented to the Board late as county staff had several questions on the carryover amounts that the Agency had included in this budget, the Agency was recently able to provide background for the carryover amounts after their audit.

Administrative expenditures total \$369,351 and represent eight percent of the funds contemplated to be expended, excluding the 1.5 percent County Administrative Charge of \$16,356, satisfying the 20 percent cap in administrative expenditures required by the Interlocal Agreement.

Operating expenditures total \$4,163,954 including:

- \$2,083,347 for Capital and Infrastructure improvements including:
 - \$858,347 for land acquisition opportunities to include workforce/affordable housing;
 - \$400,000 for sewer installation through the Corona Del Mar neighborhood;
 - \$200,000 for the West Dixie Highway Implementation Strategy;
 - \$200,000 for swale compacting and irrigation;
 - \$150,000 for wayfinding signage, place making, and branding;
 - \$130,000 for signalized crosswalks across NE 163rd St. & West Dixie Highway;
 - \$80,000 for the replacement of two LED Street digital boards, and
 - \$65,000 for installation of security cameras and lighting at the Amphitheatre.
- \$1,535,000 for various grant programs that include:
 - \$1,000,000 for a Targeted Industry Incentive Project to attract a craft brewery, a micro distillery and / or a micro winery;
 - \$300,000 for a Wastewater Connection Impact Fee Assistance Program;
 - \$175,000 for Commercial Façade Improvements and Commercial Improvement Programs, and

- \$60,000 for the Art in Public Places program.
- \$229,051 for other operating expenditures including salary and fringes associated with Agency operations, legal services, marketing, printing and publishing.
- \$200,700 for the debt service payment on the 2007 loan that matures in 2027.
- \$115,856 for consulting services to assist with review of TIF Recapture Incentive applications, targeted industry market analysis, branding and economic development services, economic development strategy and Finding of Necessity study for proposed CRA expansion and amended Redevelopment Plan.

The budget does not include a contingency reserve.

FY 2020-21

The Agency's FY 2020-21 budget of \$5,978,605 was approved by the Agency through Resolution No. 2020-01 on September 8, 2020 and by the City through Resolution No. 2020-91 on September 15, 2020 as noted in Attachment B. The budget includes \$1,211,375 in County TIF, \$1,590,346 in City TIF, projected carryover funds of \$3,161,884, and \$15,000 in interest earnings.

Administrative expenditures total \$422,511 and represent seven percent of the funds contemplated to be expended, excluding the 1.5 percent County Administrative Charge of \$18,171, satisfying the 20 percent cap in administrative expenditures required by the Interlocal Agreement.

Operating expenditures total \$5,537,923 including:

- \$3,070,001 for Capital and Infrastructure improvements including:
 - \$2,695,001 for land acquisition opportunities which may include parking, development, blight elimination and public-private partnership that meet CRA plan objectives;
 - \$200,000 for West Dixie Highway Streetscape improvements;
 - \$100,000 for Snake Creek Canal improvements, and
 - \$75,000 for wayfinding signage to identify public parking, public and historic facilities, landmarks and bicycle lane improvements.
- \$1,125,000 for Commercial Improvements Grants including:
 - \$500,000 for Targeted Industry Incentive Program;
 - \$300,000 for Tax Increment Financial Incentives;
 - \$300,000 for Wastewater Tie-In Sewer system required impact and connection fees, and
 - \$25,000 for the Art in Public Places Program along the commercial corridor.
- \$827,749 for contractual services including:
 - \$335,920 implementation of Agency's Action Plan;
 - \$296,829 for other general professional & contractual services;
 - \$100,000 Hanford Boulevard development;

- \$50,000 for 163rd Street Corridor analysis to implement right-of-way roadway, pedestrian, bicycle and landscape improvements;
- \$25,000 for Civic Commons Area conceptual design services, and
- \$20,000 for evaluation, identification of site and call to artists for a P3 style mural.
- \$214,973 for other operating expenditures including salary and fringes associated with Agency operations, and printing and publishing.
- \$200,200 for the debt service payment on the 2007 loan that matures in 2027.
- \$100,000 for promotional activities including:
 - \$55,000 for general promotional activities;
 - \$25,000 for marketing collateral materials;
 - \$15,000 for the One North Beach Concert Series;
 - \$2,500 for the Bike305 activities, and
 - \$2,500 for the Heart Health Walk.

The budget does not include a contingency reserve.

Overview

The North Miami Beach Community Redevelopment Agency ("CRA") was authorized in 2005 by the Miami-Dade County Board of County Commissioners ("BCC"), and is a successful partnership between the City of North Miami Beach ("City") and the BCC.

The BCC delegated many of the CRA powers to the City, which then created the CRA. The BCC retained other CRA powers such as approval of the annual budget, amending the Redevelopment Plan, approval of long-term debt such as loans and bonds, and other powers, which was described in the 2005 Interlocal Agreement between the BCC, City, and CRA.

The CRA's goals are:

- 1) Eliminate and prevent blight,
- 2) Improve the public infrastructure, and
- 3) Prevent and reduce incidents of crime.

The CRA is a dependent special district that may only take on projects and programs that were approved in the Redevelopment Plan.

The latest Redevelopment Plan amendment was adopted by the BCC on March 7th, 2017 through Resolution R-239-17. The CRA will sunset on October 11th, 2028.



2019-2020 Budget Document

The CRA desires to adopt this fiscal year 2020 budget with Revenues equaling Expenditures totaling \$4,549,661 with no reserves or contingency line item. The Executive Director or his designee acting as the CRA budget officer may authorize certain amendments to the FY20 budget if the total appropriations from the redevelopment trust fund do not increase. Please see Section 189.016 (6) of the Florida Statutes for further information.

2019-2020 Revenues

Total Revenues for the CRA FY2019-2020 is estimated at \$4,549,661. The primary source of revenue is from Tax Increment Financing. The sources of revenue include contributions from the City (\$1,394,273) and Miami-Dade County (\$1,090,388) totaling \$2,484,661 and a carry forward from FY2018-2019 of \$2,050,000 plus a projected \$15,000 on investments. 2014 to 2020 Comparison

Tax increment revenues increased from \$424,612 in the fiscal year 2014 to \$2,484,661 in the fiscal year 2019 budget. This was an increase of 485%. Of note, the City rezoned a significant portion of the redevelopment area in 2015 to a new mixed-use zoning district, that increase density, intensity, and permitted uses. An federal Opportunity Zone was created that covers the southern portion of the Redevelopment Area. The 8 story Lazul development was completed on Hanford Blvd, which was the first substantial CRA redevelopment project since its inception.

Legal notices placed and published for CRA Board, Redevelopment Advisory Board, and special meetings, announcements, workshops, staff, and public information.

4. Travel (\$ 10,000)

Funding for staff and Board Members to travel to conventions, seminars, continuing education, conferences, and developer meetings, including costs associated with attaining professional certifications for staff such as CEcD and AICP.

5. City Administrative Support (\$ 278,885)

The City of North Miami Beach will continue provide support services to the CRA.

6. Other Administrative Expenses (\$ 12,449)

Other Administrative Expenses include but are not limited to overhead expenses, operating supplies, bank fees, education program, communication services, repair and maintenance, office supplies, operating supplies, books and memberships, maintenance and repair of vehicles, fuel, computer equipment and software, postage, professional organization membership dues, subscriptions to publications, and maintenance agreements. Also included in the annual Florida Special Districts fee.

7. County Administrative Charge (\$ 16,356)

Required County Fee @ 1.5% of County's tax increment contribution.

Operating Expenses

1. Employee Salary and Fringe (\$ 174,051)

100% of the CRA Administrator's position75% of the City's Economic Development Director position25% of the City's Assistant City Manager position

2. Contractual Services (\$ 115,856)

CRA will contract will consultants to assist with, but not limited to, review of Tax Increment Finance Recapture Incentive applications, meeting recording, meeting minutes, targeted industry market analysis, marketing, branding, Finding of Necessity study for proposed CRA expansion, amended Redevelopment Plan, 14% of a Citywide Economic Development Strategy, and economic development services.

3. Printing and Publishing (\$ 5,000)

Covers the cost of producing agendas / annual reports and other documents required by the CRA Board and the Redevelopment Advisory Board. Also included are developer recruitment packages, welcome packages including annual public information, and other materials needed to provide an economic overview.

4. Marketing/Promotional Activities (\$ 30,000)

Through promotional activities and marketing, the CRA will promote its services and the Redevelopment Area to new businesses and developers and prevent the spread of blighting conditions. The CRA will continue to annually provide customary sponsorship to the Heart Health Walk, Bike305, and One NMB Concert Series, in addition to other activities as approved by the CRA Board.

5. Legal Services Costs (\$ 20,000)

Outside legal assistance for development agreements/legal issues and attendance at CRA Board, Redevelopment Advisory Board Meetings, and other meetings as needed. "Legal services" shall include the review of contracts and agreements and the rendering of legal opinions as requested.

6. Grant Programs and Projects

The appropriation of funding for individual CRA grants may be adjusted in the event a project is delayed, and additional funding is needed for another grant program. For example, if NMB Water is unable to commence the installation of a sewer system, which was awarded a \$400,000 grant below, the CRA may reallocate those funds to the Commercial Property Improvement Program or Sidewalk Installation Project as listed below.

A. <u>Commercial Improvement Programs</u> (\$ 175,000)

Commercial Improvement Grant Program: The grant will pay for 50% of the cost of an approved grant package up to a maximum cost of \$50,000. All improvements must comply

with any and all applicable codes, design standards, and all other restrictions of the City of North Miami Beach.

B. <u>Wastewater Impact and Connection Fee Assistance Program</u> (\$ 300,000)

The grant will reimburse up to 50% of the impact and connection fees.

C. Art in Public Places (\$ 60,000)

The CRA will continue is Art in Public Places program.

D. Signalized Crosswalks (\$130,000)

The CRA will develop plans, engineering drawings, and have installed signalized crosswalks across NE 163rd Street and West Dixie Highway.

E. LED Street Board Replacement (\$80,000)

The CRA will have replaced the two existing street digital boards because their manufacturer went out of business and service support is no longer available for these aging devices.

F. Sewering the Corona Del Mar Neighborhood (\$400,000)

The CRA will assist NMB Water with the installation of a sewer system in the Corona Del Mar neighborhood.

G. Installation of Stage Lights and Cameras at the Amphitheater to include **Electrical (\$65,000)**

The CRA will assist the City with the installation of security cameras and additional lighting at the amphitheater.

H. <u>Wayfinding Signage</u> (\$ 150,000)

The CRA will assist in the creation of wayfinding signage, marked public parking, public facilities, historic facilities, landmarks, places of interest, bicycle lane improvements, and place making improvements of utility, traffic signal, and telephone boxes.

I. Swale Compacting, Irrigation, Tree Pit Systems, and other Permanent Landscaping Improvements (\$ 200,000)

The CRA is to provide financial assistance to pay for a tree pit system, uplighting, landscaping, and improved safety, which includes but is not limited to materials, planning, engineering, and beautification.

J. Targeted Industry Incentive Projects (\$ 1,000,000)

This grant package will create new employment opportunities through the attraction of targeted industries. Funding for all three phases may be pooled into one or more incentives on the decision of the Board. The grant package may be reduced to pay any TIF based incentive approved by the Board.

Phase 1: Craft brewery - \$500,000 with surplus funding rolling into Phase 2 Phase 2: Micro distillery - \$250,000 with surplus funding rolling into Phase 3 Phase 3: Micro-winery - \$250,000

K. <u>West Dixie Highway Implementation Strategy</u> (\$ 200,000)

Miami-Dade County utilizing impact fee funding in Project No. 20140020 intends to widen West Dixie Highway between NE 164th and NE 172nd Street and reconstruct the bridge over the NMB Canal. The CRA and Miami-Dade County Department of Transportation and Public Works are working as a team to create an amazing revitalized corridor. The CRA agrees to install the landscaping with this grant up to \$200,000, the County agrees to have installed the necessary irrigation system, and the City agrees to maintain the landscaping.

L. Skateboard Park (\$ TBD)

The Redevelopment Plan calls for increased recreational uses along NMB canal. The City and CRA are exploring the installation of a skateboard park along the canal.

M. Tax Increment Finance Based Incentives (\$ TBD)

The CRA has a TIF based incentive for the Lazul redevelopment project (formerly NoMa). The incentive may be paid during FY20 if all conditions within the agreement are met. Funding for this incentive will be draw from "J" above.

7. Debt Service (\$ 200,700)

The repayment of borrowed funds for one (1) 3,000,000 tax exempt loan drawn down in 2007. The loan will expire on 2/1/2027.

The following is recognized as ongoing and potential future infrastructure improvements within the Redevelopment Area:

FY 2019-2020 Accomplishments

- ✓ Developed and adopted a 5-year Strategic Finance Action Plan to guide the future direction of the CRA and its activities.
- ✓ Developed a Resource Package for Business, distributed a Covid-19 Survey and undertook other efforts to support businesses being negatively impacted by the pandemic.
- ✓ Tax Increment revenue collections grew over 18% during FY 2020 amid the successful efforts of the City and property owners to alleviate blight, and reflecting increased development, redevelopment and property values.
- ✓ Facilitated and participated in the inaugural *Bisnow* Event held in Sunny Isles Beach, designed as a forum to discuss redevelopment opportunities in South Florida and how these development projects can revitalize the CRA.

Fiscal Year 2020-2021 Budget

The following section provides a narrative of the CRA's FY 2021 budget (attached as Exhibit A) which is substantially in alignment with the adopted 5-Year Strategic Finance Action Plan.

Revenues

Revenues for the CRA total \$6 million and include the following:

Tax Increment

The primary source of revenue for the CRA is derived of tax increment received from the City (est. millage rate: 6.2000 mills) and BCC (est. millage rate: 4.6669 mills) and totals \$2,801,721 for FY 2021 (after adjustment for final 2018 taxroll variations).

Property values within the CRA (July certification) for FY 2021 increased 6.9% to \$520 million.

Investment Earnings

Earnings on the CRA's invested cash is conservatively estimated at \$15,000 for FY 2021.

Carryforward Fund Balance

Represents the carryforward of fund balance (i.e. unspent cash balance) within the CRA that is available for investment in redevelopment initiatives.

Expenditures

Expenditures for the CRA total \$3.2 million and include the following:

Represents \$518,270 funding for the following:

- Debt Service on the Series 2007A Notes Payable (\$200,200); and
- Administrative Cost Allocation to the City for services delivered to the CRA throughout the year (\$318,070).

Redevelopment Initiatives

Represents funding totaling \$500,000 for the following initiatives:

- West Dixie Highway Streetscape Improvements (\$200,000) Complete plans and engineering drawings for streetscape project funded by the County.
- Wastewater Tie-In NMB Sewer (\$300,000) Assistance with Wastewater Impact Fees and Connection Fees required by City, County, and State government agencies for properties to tie-in to a Wastewater System.

South of the Canal Target Area

Represents funding totaling \$237,500 for the following initiatives:

- Snake Creek Canal Improvements (\$100,000) Develop conceptual design, select consultant, and develop design for the area improvements.
- Hanford Boulevard Development (\$100,000) Develop conceptual design, select consultant, and develop design for the area improvements.
- Promotional activities including sponsorships for the One NB Concert Series (\$15,000) and the Heart Health Walk (\$2,500).
- P3 Mural (\$20,000) Evaluate and identify potential mural sites; issue call to artists and initiate mural project.

Civic Commons Target Area

Represents funding totaling \$25,000 for the following:

• 19th Street Grand Boulevard Improvements (\$25,000) - Initiate process for development for conceptual design services.

<u>163rd Corridor/Neighborhoods Target Area</u>

Represents funding totaling \$50,000 for the following:

 N.E. 163rd St. Complete Streets Initiative (\$50,000) - Work with the Florida Department of Transportation (FDOT) and BCC to initiate design and right-ofway analysis to implement a variety of roadway, pedestrian, bicycle, landscaping and related improvements to the 163rd Street corridor.

Branding and Marketing Target Area

Represents funding totaling \$152,500 for the following:

 Promotional Activities (\$52,500) - Through promotional activities and marketing, the CRA will promote its services and the Redevelopment Area to new businesses and developers and prevent the spread of blighting conditions. General promotional activity funding totals \$25,000 with additional funding of \$2,500 for Bike305 activities, and \$25,000 for marketing collateral materials.

- Wayfinding Signage (\$75,000) The CRA will assist in the creation of wayfinding signage to identify public parking, public and historic facilities, landmarks, places of interest, bicycle lane improvements, etc. There will also be place-making improvements including utility, traffic signal, and telephone boxes.
- Art in Public Spaces (\$25,000) The CRA will continue to encourage the Art in Public Places program through placement of art in the public rights-of-way and by providing incentives for publicly displayed artwork on private property.

<u>Land Acquisition and Redevelopment Incentives Target Area</u> Represents funding totaling \$3.5 million for the following:

- Land Acquisition (\$2,695,001) Purchase of property for redevelopment purposes (such as parking, development, blight elimination, public-private partnership) as opportunities arise in accordance with the CRA's objectives as stated in the Redevelopment Plan.
- Targeted Industry Incentive Program (\$500,000) This grant package will create new employment opportunities through the attraction of targeted industries to the CRA
- Tax Increment Financial (TIF) Incentives (\$300,000) As development projects are proposed, this allows for TIF based incentives to be offered to incentivize projects. The CRA had a TIF based incentive for the Lazul redevelopment project that was completed, the conditions were met and approximately \$434,000 in incentives was paid out in FY 2020.
- Parking The CRA participated in a parking study to: (1) determine the availability of parking; and (2) identify parking demand. Staff will be developing recommendations to address the CRA's current and future parking needs.
