Daviella Leine Cara Resolution Retroactively Authorizing the County Mayor or the County Mayor's

Designee to Apply for, Receive and Expend Funds from the Pérez Family Foundation CreARTE Grant Program in the Amount of \$100,000.00 for the African

Heritage Cultural Arts Center and to Execute all Necessary Agreements

Recommendation

It is recommended that the Board of County Commissioners (Board) retroactively authorize the County Mayor or the County Mayor's designee to apply for, receive and expend a grant in the amount of \$100,000.00 from the Pérez Family Foundation CreARTE Grant Program for the African Heritage Cultural Arts Center (AHCAC) and to execute all necessary agreements.

Scope

The African Heritage Cultural Arts Center (AHCAC) is located at 6161 NW 22nd Avenue, Miami, FL 33142 in District 3, represented by County Commissioner Keon Hardemon.

Fiscal Impact/Funding Source

This item will have a positive fiscal impact on the County of \$100,000 as the Pérez Family Foundation CreARTE Program grant does not require matching funds. The grant funding will be used to launch the architectural and engineering planning work needed to conceptualize and design a new campus of state-of-the-art buildings for the AHCAC at its current site.

Delegation of Authority

The County Mayor or Mayor's designee is delegated the authority to execute the grant agreement and to take all actions to comply with the requirements of the grant agreement and the purpose for which the funds were granted to the County.

Track Record/Monitor

Alejandro Peraza with the Department of Cultural Affairs (Department) manages all contracts related to the project's design, and Marshall Davis manages the ongoing operations of the AHCAC. The Department team has a track record of successfully implementing capital grants and managing design and construction projects.

Background

The African Heritage Cultural Arts Center was formerly the Model City Cultural Arts Center which opened in 1975 with funding support from the Model City Program initiated by President Lyndon B. Johnson. This regional facility has served Liberty City and the adjacent communities for 45 years. Its campus of buildings includes a music building, a dance studio, a visual arts/classroom building, an art gallery and a black box theater, along with a complement of offices and necessary support spaces, reception area, and storage spaces, all of which are connected by a central courtyard area.

The Department applied for and received from the Pérez Family Foundation a CreARTE grant in the amount of \$100,000.00. These grant funds will be used to complete the planning work necessary to build a new AHCAC on the existing site. This work includes: creating a building program that determines the requirements and goals for a new Center to define the project scope; developing a comprehensive master plan that incorporates the physical needs of the facility and the vision for a new campus; and establishing a schematic design that includes initial study drawings and basic design concepts for the new Center.

The AHCAC is 45 years old and consists of aging buildings that were adapted to serve as teaching, rehearsal, performance, and exhibition spaces for educating students in the arts and presenting public cultural programs. The AHCAC has a distinguished track record of improving the lives of families and children through the arts. A team of extraordinary teachers and artists is nurturing generations of children. AHCAC alumni are proof of their transformational impact; they include MacArthur Fellow and 2017 Oscar winner for Moonlight, Tarell Alvin McCraney and Robert Battle, Artistic Director of Alvin Ailey American Dance Theater. An epicenter of African American culture, the AHCAC has presented Dance Theater of Harlem, National Black Theater Company, and Alvin Ailey American Dance Theater, as well as Eartha Kitt, Ossie Davis, Maurice Hines, and Melton Mustafa. Through AHCAC, audiences who might not otherwise experience world-class performances have access to artists who are national treasures.

A new state-of-the-art AHCAC can improve and advance the next generation of this work of educating students in the arts and presenting outstanding public programs in a campus that is designed to 21st century standards for instructional purposes and public performances and exhibitions.

- 3. To prominently acknowledge that support has been provided by "The Jorge M. Pérez Family Foundation at The Miami Foundation" in any and all publications and materials produced by the recipient in connection with programs being supported by this award as follows:
 - a. By acknowledging "The Jorge M. Pérez Family Foundation at The Miami Foundation" in any and all publications, communications, media releases, event signage, and promotional collateral materials produced by the recipient in connection with or regarding programs being supported by this award

- **4.** To report on the grant as per the schedule in this agreement and following the Foundation's reporting guidelines; and be prepared to provide additional information and documentation if requested.
- 5. Grantee will maintain its tax-exempt status as a Section 501(c)(3) organization classified as a public charity under Sections 509(a)(1) or (2) current throughout the period of this grant.
- 6. As required by IRS rules, The Miami Foundation funds will not be used: a) to carry on lobbying activities as defined under Section 501(c)(3) of the Internal Revenue Code; b) for partisan political activities which are prohibited under Section 501(c)(3); c) to make a grant to any individual for travel, study or other similar purposes or to make a sub-grant to any other organization unless the grant complies with Section 4945(d)(3) or (4) of the Internal Revenue Code and the grant has been detailed in the approved grant plan and budget; or (d) to undertake any activity for any purpose other than the charitable and educational purposes specified in Section 170(c)(2)(B) of the Internal Revenue Code.
