Subject: Recommendation to Ratify Emergency Purchase: Laundry Services

Agenda Item No. 8(F)(14)

Recommendation

It is recommended that the Board of County Commissioners (Board) approve this request for a designated purchase under *Contract No. E10022-0/20, Emergency Laundry Services*. Approval of a designated purchase is being requested by the Miami-Dade Corrections and Rehabilitations Department (MDCR), pursuant to Section 2-8.1(b)(3) of the Miami-Dade County Code by a two-thirds vote of the Board members present, to ratify the extension of this emergency contract for twelve months with additional expenditure authority in the amount of \$600,000. This extension was necessary to ensure continuity of services while MDCR establishes an in-house laundry facility. On March 2, 2021, the Board ratified this emergency contract through Resolution No. R-149-21, in the amount of \$554,000 for a one-year and eleven-month term.

This contract provides for the washing, drying, and folding of linens and uniforms for the inmates in County correctional facilities in accordance with the best commercial standards. At present, approximately 20,000 pounds of soiled linen, bedding, uniforms, and towels are laundered weekly for the County's average daily population of 4,200 inmates. The provision of laundry services is a critical component of MDCR's daily operations and overall sanitation program. The quality and reliability of these services play a major role in the Department's ability to comply with Florida Model Jail Standards, Accreditation Standards, and Civil Rights for Institutionalized Persons Act. Correctional facilities are mandated to maintain clean and sanitary environments at all times, and provide inmates with uninterrupted access to clean linen, bedding, and uniforms.

The Director of MDCR declared an emergency on June 5, 2019, to purchase laundry services in order to prevent service interruptions as the vendors providing services under *Contract No. 8443-0/19, Laundry Services*, were unable to fulfill their contractual obligations. Since MDCR does not have the capacity to address its laundry requirements in-house, Cy's Linen Service, Inc. was selected among several vendors as the only vendor capable of providing the required linen services at the time of the declared emergency.

On March 11, 2021, during the Community Safety and Security Committee meeting, Chairwoman Sally A. Heyman, requested that MDCR evaluate the feasibility of transitioning all inmate laundry services inhouse. The feasibility report indicated that MDCR anticipates in-house laundry services will commence by March 2022, if the County is able to finalize a location for laundry operations and expedite the design/build construction project. The transition of laundry services in-house will allow MDCR to effectively and efficiently manage essential inmate needs, while realizing a prospective reduction of \$252,800 annually for laundry services. This extension will ensure inmates have continuous access to clean laundry while MDCR transitions these services in-house.

An emergency was declared on April 30, 2021 to extend the contract with CY's Linen Service, Inc, as the County's efforts to procure the services competitively have been unsuccessful due to lack of capable vendors. Although MDCR does not anticipate having to utilize the full allocation and anticipates the successful implementation of the in-house laundry, this extension will serve as a contingency plan. It is in the County's best interest to approve this ratification for extension of time and additional expenditure

authority in the amount of \$600,000 to ensure continuity of services while MDCR implements its plan to bring the services in-house.

Scope

The scope of this item is countywide in nature.

Fiscal Impact/Funding Source

The contract term expires on May 4, 2022. The cumulative fiscal impact for the emergency purchase is \$1,154,000, inclusive of the requested \$600,000. The modification amount represents a change in the price per pound for laundry services from \$0.42 to \$0.65; a difference of \$0.23 per pound. The vendor attributes the increased rates to factors such as shortage of manpower to launder inmate laundry resulting in significant over-time rates, a minimum wage increase, and a \$0.75 per pound rate paid by other clients for laundry services.

RESOLUTION AUTHORIZING A DESIGNATED PURCHASE PURSUANT TO SECTION 2-8.1(B)(3) OF THE COUNTY CODE BY A TWO-THIRDS VOTE OF THE BOARD MEMBERS PRESENT; RATIFYING EXTENSION OF TIME FOR TWELVE MONTHS AND ADDITIONAL EXPENDITURE AUTHORITY FOR AN EMERGENCY PURCHASE FOR THE MIAMI-DADE CORRECTIONS AND REHABILITATION IN AN AMOUNT NOT TO EXCEED \$600,000.00 FOR A TOTAL CONTRACT VALUE OF \$1,154,000.00 FOR EMERGENCY LAUNDRY SERVICES, CONTRACT NO. E-10022-0/20

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,
