Subject: Resolution Approving the Plat of Sunset Pointe Apartments II Filed by Sunset Point

II Associates, Ltd.

Recommendation

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for Sunset Pointe Apartments II is bounded on the north approximately 530 feet south of NW 79 Street, on the east approximately 380 feet west of NW 11 Avenue, on the south by NW 75 Street, and on the west by NW 12 Avenue.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Full scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

Scope

This plat is located in Commission District 3, which is represented by Commissioner Keon Hardemon

There are no delegation requirements with this item.

Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the county would be approximately \$50.00 annually for new roadway and sidewalk construction adjacent to the project. These costs would be covered by the Department of Transportation and Public Works' annual General Fund allocation.

- Available public water and sewer lines abut the proposed subdivision. The parcel is required to connect to public water and public sanitary sewers.



RESOLUTION APPROVING THE PLAT OF SUNSET POINTE APARTMENTS II FILED BY SUNSET POINT II ASSOCIATES, LTD., LOCATED IN THE SOUTHEAST 1/4 OF SECTION 11, TOWNSHIP 53 SOUTH, RANGE 41 EAST (BOUNDED ON THE NORTH APPROXIMATELY 530 FEET SOUTH OF NW 79 STREET, ON THE EAST APPROXIMATELY 380 FEET WEST OF NW 11 AVENUE, ON THE SOUTH BY NW 75 STREET, AND ON THE WEST BY NW 12 AVENUE)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, Sunset Point II Associates, Ltd., a Florida limited partnership, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as "Sunset Pointe Apartments II," the same being a replat of a portion of Lots 3, 4, and 5 of "Robert's Subdivision," according to the plat thereof, as recorded in Book B, at Page 133 of the Public Records of Miami-Dade County, Florida, lying and being in the Southeast 1/4 of Section 11, Township 53 South, Range 41 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any

zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.
