Reappointment of Two Agricultural Practices Advisory Board Members **Subject:** 

#### Recommendation

It is recommended that the Board of County Commissioners (Board) reappoint the following two persons to the Agricultural Practices Advisory Board: Mr. Sam Accursio as one of two Vegetable Industry Representatives as recommended by the Dade County Farm Bureau and Ms. Ivonne Alexander as one of two Nursery Industry Representatives as recommended by the Florida Nursery Growers and Landscape Association, to the Agricultural Practices Advisory Board (APAB). Pursuant to Section 2-934 of the Code, members of the APAB serve four-year terms commencing upon appointment by the Board.

The recommendations and actions of the Agricultural Practices Advisory Board have a countywide impact.

#### **Delegation of Authority**

The proposed resolution does not delegate authority to the County Mayor or County Mayor's designee.

#### **Fiscal Impact/Funding Source**

There is no fiscal impact to Miami-Dade County.

#### **Track Record/Monitor**

Jerry Bell, Assistant Director for Planning within the Department of Regulatory and Economic Resources monitors the APAB.

#### **Background**

The APAB currently consists of 13 members representing a variety of agricultural industries:

- Two representatives from the Tropical Fruit Crops Industry of Miami-Dade County, one recommended by the Florida Avocado Committee, and one recommended by the Tropical Fruit Growers of South Florida, Inc.;
- Two representatives from the nursery industry, recommended by the Miami-Dade County Chapter of the Florida Nursery Growers & Landscape Association;

- Two representatives from the vegetable industry, recommended by the Dade County Farm Bureau;
- One representative of the aquaculture industry, recommended by the Ornamental Aquaculture Association of South Florida;
- One representative of a citizens' association supportive of agriculture, recommended by the Redland Citizens' Association;
- One representative of allied agribusiness recommended by the Dade AgriCouncil;
- One representative of agri-banking, agri-financial consulting, or agri-lending recommended by the Homestead-Florida City Chamber of Commerce;
- One representative of Farm Labor, recommended by Coalition of Florida Farmworkers Organizations;
- One representative of the South Dade Soil & Water Conservation District, recommended by the South Dade Soil & Water Conservation District; and
- One at large representative recommended by the Miami-Dade Agricultural Practices Advisory Board.

Section 2-935 of the Miami-Dade County Code requires that the Board fill vacancies occurring on the APAB. Pursuant to Section 2-935 of the Code, each designated organization shall submit, for Board review, at least one nominee for their vacant position(s), including the nominee's resume and the minutes of the organization's meeting at which the nominee was selected. The required documentation for Mr. Accursio and Ms. Alexander is attached as Exhibit A.

The following nominees were submitted:

#### Vegetable Industry Representative

Mr. Sam Accursio was nominated by the Dade County Farm Bureau as its nominee to serve a fourth term representing the vegetable industry. Mr. Accursio is currently the Chair of the APAB and recently served as a member of the Governing Board of the South Florida Water Management District. Mr. Accursio is the owner and operator of Sam S. Accursio and Sons Farms which produces squash, beans, and pickles. He has previously served on the Board of Directors of the Dade County Farm Bureau and has been a member of the Miami-Dade County Cooperative Extension Service's Vegetable Advisory Committee, the Florida Fruit & Vegetable Association, and the Florida Nursery Growers and Landscape Association. The Dade County Farm Bureau recommended the reappointment of Mr. Accursio to the APAB at their October 2, 2020 meeting. Mr. Accursio's resume and the minutes of the meeting at which he was selected are attached as Exhibit A.

### Nursery Industry Representative

Ms. Ivonne Alexander was nominated by the Florida Nursery Growers and Landscape Association as its nominee to represent the nursery industry. Ms. Alexander currently owns and operates Management & Business Consultants, Inc., a consulting company catering exclusively to the agricultural industry. She previously served as CFO of Nature's Way Nursery of Miami, Inc., a grower of outdoor landscape material, and previously owned and operated Happy Days Nursery, Inc., a moderate size foliage and woody ornamental plant nursery. She is a Florida International University graduate and had a 23-year career with Farm Credit working with row crop farmers, fruit growers, and nursery operations. Ms. Alexander has also held numerous community positions, including Director of the Dade County Agri-Council, Director and President Elect of the Dade County Farm Bureau, Director and Past President of the Dade County Fair and Exposition Association, and Past Director of the 4-H Foundation. The Florida Nursery, Growers and Landscape Association ("FNGLA") recommended the reappointment of Ms. Alexander to the APAB at their September 24, 2020 virtual meeting. Ms. Alexander's resume and a letter reflecting the FNGLA's unanimous approval of her nomination are attached as Exhibit A.

Ivonne remembers going to Crandon Park and eating seagrapes as a substitute. If you ask-her she will tell you how she detests them today.

She went to Shenandoah Junior High School and was active in sports. Friends will attest to the fact that she was a fierce competitor. This is a trait that has served her well throughout her career. After graduating from Miami Senior High School, she attended Miami Dade Community College. She then transferred to Florida International University studying Accounting and Finance.
