Subject: Request for Expenditure Authority to Prequalification Pool No. 5966-0/23, Work Gloves

# **Recommendation**

It is recommended that the Board of County Commissioners (Board) authorize additional expenditure authority to *Prequalification Pool No. 5966-0/23, Work Gloves*, for various County departments. The departments are requesting \$5,720,765 in additional expenditure authority to continue purchasing work gloves. Small Business Enterprise (SBE) measures will be determined prior to advertising each spot market competition. Local Preference will be applied at the time of spot market competition where permitted by the funding source. There are 22 prequalified vendors, of which 14 have local addresses and eight are certified SBE firms.

The County established this pool on December 1, 2013, for a ten-year term under Resolution No. R-943-13. On January 23, 2018, through Resolution No. R-31-18, the Board authorized additional expenditure authority in the amount of \$4,726,000, to consolidate *Contract 8909-0/18* into *Prequalification Pool No. 5966-0/23*, increasing the total allocation to \$8,046,000. The consolidation allowed the County to use a single pool for the purchase of gloves, thereby allowing for efficiency and more favorable pricing. Subsequently the pool was modified under delegated authority increasing the total allocation to \$8,340,300.

### Background

The pool is used to solicit quotes for various types of work gloves, including driving gloves, latex examination gloves, welder's gloves, and other gloves that provide protection from hazardous chemicals, waste, and prevent punctures, burns and cuts. As required by the National Institute for Occupational Safety and Health Administration (OSHA) and Miami-Dade County's Safety Manual, gloves are provided to employees as hand protection for daily duties.

Additional expenditure authority is requested based upon anticipated expenditures for the remainder of the pool term, taking into account increased requirements as a result of the Coronavirus (COVID-19) pandemic, as follows:

- 1. Animal Services is requesting \$322,000 to continue purchasing gloves for usage by staff. The COVID-19 pandemic has created an urgent need to procure a higher volume of gloves for staff interfacing with customers or caring for animals. Also, the COVID-19 pandemic has caused supply chain challenges which have contributed to increased glove prices.
- 2. Corrections and Rehabilitation is requesting \$3,000,000 to continue provide gloves for the health and safety of its inmates and staff. Due to the COVID-19 pandemic, the consumption and price of gloves have increased and these funds are necessary to purchase additional gloves to maintain hygienic conditions for approximately 4,000 inmates and 2,600 staff members.
- 3. Fire Rescue is requesting \$1,500,000 to replenish work gloves inventory depleted based on unanticipated increase for supplies due to the COVID-19. Gloves are necessary for the department's daily field operations and the protection of staff.
- 4. Medical Examiner is requesting \$50,000 to provide staff with gloves for the remainder of the contract term. The need for gloves has surged since COVID-19 as well as prices have increased.

- 5. Police is requesting \$138,000 to purchase nitrile and work gloves for sworn and non-sworn personnel for daily usage and hurricane related activities. Nitrile glove offer the best protection against blood borne pathogens and is recommended by state and federal agencies as the best protective barrier against opioids. Each patrol officer is required to store gloves in their vehicle for use when contacting the public. Additionally, work gloves are purchased to outfit the Facilities Maintenance section for daily operations.
- 6. Transportation and Public Works is requesting \$195,000 for continued supply of gloves. Per collective bargaining agreements, gloves are mandatory safety items that must be maintained in inventory for staff working in the garages.
- 7. Water and Sewer Department is requesting \$505,765 to purchase gloves to protect staff from germs and unsanitary residues. The Department maintains over 7,600 miles of water pipe, 6,400 miles of sewer pipe, 88 water wells and more than 1,000 sewer pumping stations. The Department's work crews replace pumps and motors in the sewer pumping stations potentially exposing them to varying degrees of unsanitary conditions such as untreated sewage. Gloves are cyclical ordered by cases almost weekly and is a stock item that must be replenished due to heavy usage. These include but are not limited to cotton, chemical resistant, high dexterity, latex, nitrile, neoprene rubber, sensilite general purpose and welding gloves.

#### Scope

The scope of this item is countywide in nature.

## Fiscal Impact/Funding Source

The pool expires on November 30, 2023 and has a cumulative allocation of \$8,340,300. If this request is approved, the pool will have a modified cumulative allocation of \$14,061,065. The requested increase in expenditure authority is based on department's anticipated needs for work gloves for the remainder of the pool term, and increased prices of gloves. The additional expenditure for this year was approved by the Board as part of the fiscal year 2021-2022 County budget.

#### **Delegated Authority**

The County Mayor or County Mayor's designee will have the authority to exercise all provisions of the contract, including any cancellation or extension provisions, pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38.

## **Prequalified Vendors**

Pursuant to Resolution No. R-31-18, local vendors are to be utilized for the purchase of work gloves. Non-local vendors are only to be utilized for items not available from local vendors.
