#### RESOLUTION NO.

RESOLUTION DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO: (I) MAKE ALL TELEPHONE AND COMMUNICATION SERVICES FOR INMATES IN MIAMI-DADE COUNTY CORRECTIONS AND REHABILITATION DEPARTMENT ("MDCR") JAIL FACILITIES FREE OF CHARGE OR TO ALLOCATE A PERIOD FOR INMATES TO MAKE FREE CALLS EACH DAY IN THE NEXT SOLICITATION AND CONTRACT FOR **TELECOMMUNICATIONS** OR COMMUNICATIONS SERVICES; (II) IDENTIFY LEGALLY AVAILABLE FUNDING IN FISCAL YEAR 2021-22 COUNTY BUDGET OR, IF CONTRACT IS TO BE AWARDED IN NEXT FISCAL YEAR, INCLUDE FUNDING IN COUNTY MAYOR'S PROPOSED FISCAL YEAR 2022-23 COUNTY BUDGET, TO PROVIDE FREE TELEPHONE AND COMMUNICATION SERVICES FOR INMATES IN MDCR JAIL FACILITIES; (III) PROVIDE A REPORT; AND (IV) COMPLY WITH RESOLUTION NO. R-1106-15

WHEREAS, some inmates can spend years housed in Miami-Dade County Corrections

and Rehabilitation Department ("MDCR") jail facilities; and

WHEREAS, for many inmates, telephone calls to family and friends are their lifelines to

the outside world; and

WHEREAS, this became especially true in March of 2020 when the coronavirus disease

2019 ("COVID-19") became a global pandemic; and

WHEREAS, before the pandemic, MDCR permitted in-person visitations at its jails; and

WHEREAS, however, after the pandemic struck, to combat COVID-19, MDCR imposed

safety guidelines which include prohibiting in-person visitations; and

WHEREAS, as a result, inmates must rely on verbal and written means to communicate

with friends and family; and

WHEREAS, in addition, for safety reasons, inmates are not permitted to have cellular telephones and must use the telephone services provided by MDCR; and

WHEREAS, on November 9, 2021, the *Miami Herald* reported that the cost of jail telephone calls provided under the County's contract with Global Tel\*Link Corporation would be reduced from \$0.14 to \$0.05 per minute, and inmates would be entitled to receive two free 15-minute calls each week from the month of November through the duration of the current contract, which expires on July 31, 2022; and

**WHEREAS**, this \$0.09 per minute price difference in telephone calls is funded in MDCR's FY 2021-22 budget and was made possible because the County opted to forgo the commissions it ordinarily would have received under the balance of the contract term, which have been estimated to be more than \$2,000,000.00; and

**WHEREAS**, in the upcoming months MDCR will utilize a formal competitive solicitation process to select a vendor to provide telecommunication or other communication services after its existing contract expires on July 31, 2022; and

**WHEREAS**, although jail telephone calls that are \$0.09 less expensive than previous call prices are a step in the right direction, more can and should be done to further reduce the cost of telephone calls for inmates to communicate with their friends and family members; and

WHEREAS, it is imperative that during negotiations for the new telecommunications or communications services contract, that best efforts are used to obtain telephone services at no cost to inmates or that inmates are provided telephone services free of charge for a daily allotment of time,

### NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. The foregoing recitals are hereby incorporated herein by reference and adopted by this Board.

Section 2. Subject to the identification and approval of funding, this Board directs the County Mayor or Mayor's designee to make all telephone and communication services for inmates in Miami-Dade County Corrections and Rehabilitation Department ("MDCR") jail facilities free of charge or to allocate a period for inmates to make free calls each day in the next solicitation and contract for telecommunications or communications services at MDCR jail facilities.

Section 3. If the County Mayor or Mayor's designee: (a) anticipates issuing a solicitation and/or awarding a new contract for telecommunications or communications services in Fiscal Year 2021-22, this Board directs the County Mayor or County Mayor's designee to identify one or more legally available funding sources from the Fiscal Year 2021-22 County Budget to make all telephone services for inmates in MDCR jail facilities free of charge or to allocate a period for inmates to make free calls each day in such contract; or (b) does not issue a solicitation and/or award a new contract for telecommunications or communications services in Fiscal Year 2021-22, directs the County Mayor or County Mayor's designee to include sufficient funds in the County Mayor's proposed budget for Fiscal Year 2022-23 to make all telephone and communication services for inmates in MDCR jail facilities free of charge or to allocate a period for inmates in MDCR jail facilities free of charge or to allocate a period for inmates in MDCR jail facilities free to include sufficient funds in the County Mayor's proposed budget for Fiscal Year 2022-23 to make all telephone and communication services for inmates in MDCR jail facilities free of charge or to allocate a period for inmates to make free calls each day in such contract.

Section 4. In the event such funding in the Fiscal Year 2021-22 County Budget is not available for the purposes set forth in section 3(a) above, the County Mayor or County Mayor's designee shall provide a report to this Board within 30 days of the effective date of this resolution and shall place the completed report on an agenda of the full Board pursuant to Ordinance No. 14-65. Such report shall be presented directly to the full Board without committee review.

[[<u>Section 5</u>. This Board directs the County Mayor or County Mayor's designee to present any solicitation for the purchase of telecommunication or communication services at MDCR jail facilities to the Board for its review and approval prior to advertisement. To the extent a solicitation for the purchase of telecommunication or communication services at MDCR jail

facilities has already been advertised as of the effective date of this resolution, the Board directs the County Mayor or County Mayor's designee to: (a) place such solicitation, including any addenda, on an agenda of the full Board without committee review, for the Board's review and approval of the solicitation prior to the submission of responses or proposals; and (b) to issue an addendum extending the due date for responses or proposals to a date that is no less than 30 days following the date the solicitation is presented to the Board.]]<sup>1</sup>

This Board directs the County Mayor or County Mayor's designee to ensure that this Board's policy of encouraging County vendors to utilize a diverse workforce that is reflective of the racial, gender and ethnic diversity of Miami-Dade County and employ locally-based small firms and employees from the communities where work is being performed as set forth in Resolution No. R-1106-15 is adhered to in the next solicitation and contract for telecommunications or communications services at MDCR jail facilities.
