Subject:	Resolution Waiving Competitive Bidding and Ratifying a Confirmation Purchase for the Provision of Transportation Services with Limousines of South Florida, Inc.			

Executive Summary

The purpose of this item is for the Board of County Commissioners (Board) to approve waiving competitive bidding and ratifying a confirmation purchase with Limousines of South Florida, Inc. (LSF) in an amount of up to \$9,131,772 for the continued provision of transportation and disinfecting services for a retroactive term of February 28, 2022 through February 27, 2023 for the Department of Transportation and Public Works (DTPW).

Recommendation

It is recommended that the Board approve the attached resolution (1) waiving competitive bidding procedures pursuant to Section 5.03(D) of the Home Rule Charter and Section 2-8.1 of the County Code by a two-thirds vote of the Board members present and (2) ratifying a confirmation purchase with LSF for the provision of transportation and disinfecting services for a total contract amount not to exceed \$9,131,772 for a retroactive term commencing February 28, 2022 through February 27, 2023.

This item is placed for Board review pursuant to County Code Section 29-124(f)(ii). Since this is a transit-related procurement, with a value of more than \$1 million, even though no Charter County Transportation Surtax Funds will be used to pay the costs, the Board may only consider the item if the Citizens' Independent Transportation Trust (CITT) has forwarded a recommendation to the Board. If CITT has not forwarded a recommendation and 45 days have not elapsed since the issuance of this recommendation, a withdrawal of the item will be requested.

Delegated Authority

If this item is approved, the County Mayor or County Mayor's Designee will have the authority to exercise all provisions of the contract, including termination, pursuant to Section 2-1.1 of the County Code and Implementing Order No. 3-38.

Scope

The impact of this item is countywide in nature as the contract promotes connectivity to the entire transit system.

Fiscal Impact/Funding Source

The total estimated cost associated with the transportation and disinfectant services shall not exceed \$9,131,772 for the one-year term and is covered under DTPW's Operating Fund. The

cost breakdown is as follows: transportation services at the hourly rate of \$55.98 and disinfecting services at a fixed amount of \$9.00 per vehicle. Fuel does not factor into the cost as it is paid for, directly, by DTPW.

Track Record/Monitor

The Project Manager is Joel Perez, DTPW General Superintendent, Bus Operations.

Background

On June 6, 2017, the Board approved Resolution No. R-611-17, authorizing accessing this City of Miami contract with LSF for the provision of public transit services for Miami-Dade County. The Board expressly required that any future option to renew be brought before it for approval. Subsequently, the Board approved five options to renew with the last one terminating on February 27, 2022. Accordingly, this confirmation purchase affords DTPW an additional year for continuity of service while facilitating the transition to a new contract with a new vendor.

With approval of this item, LSF continues to service fixed bus routes 1, 29, 46, 56, 71, 72, 82, 101(A), 115, 202, 210, 211, 212, 217, 246, 248, 254, 267, 272, 286, 344 and the Biscayne Gardens Circulator (Route 155). The following Lifeline Routes will also continue to be serviced: Green Hills, Kings Creek, Sierra Lakes, Robert Sharp, Ahepa, and Federation Gardens.

Except for three material changes, effective February 28, 2022, the same contract terms and conditions apply to the one-year extension.

- (1) The underlined language was added to Section XVII, Termination: The Contractor is determined by the City to be in breach of any of the <u>material</u> terms and conditions of the agreement or any other agreement the Contractor has with a Florida public agency. <u>Prior to issuing any Notice of Termination, the City (County) shall issue a written Notice to Cure and provide 30 days to remedy the alleged violation.</u>
- (2) This language was deleted from Section XVII, Termination: *The City Manager has determined that such termination will be in the best interest of the City to terminate the Agreement for its own convenience.*
- (3) This language was added to Section 7, Additional Terms and Conditions: *Contractor* shall provide Bus Disinfecting and Sanitizing Services for all buses assigned to Contract No. 18483 (RFP No. 256244) (Contracted Routes) daily at a fixed amount of \$9.00 per vehicle cleaned and disinfected, and on up to seven (7) days per week at their facilities.

DTPW discontinued COVID-19 disinfecting and sanitizing services, effective March 13, 2022, due to the continued significant decline in reported COVID cases in Miami-Dade County. Such disinfecting and sanitizing services are estimated to cost \$13,500 monthly. Discontinuing the services results in an estimated annual savings of \$162,000. The contract permits the services to be reinstated as needed.

Under the contract, vehicle capacity may range from eight to 25 passengers. However, LSF has surpassed this by providing larger vehicles to accommodate passenger demand at no additional cost to the County. Per the contract, all vehicles are compliant with the Americans with Disabilities Act. Moreover, prior to being placed in service, all newly added vehicles are inspected by DTPW's bus operations staff for compliance with all contract requirements.

Contingent upon approval by the Board of County Commissioners, Miami-Dade County has elected to extend the above referced contract, as amended herein, for the provision of transit services at a rate of \$55.98 per revenue hour for a one-year period from February 28, 2022 through February 27, 2023. You are to proceed with the work described in the attached Letter of Agreement (LOA) between Miami-Dade County (County) and Limousines of South Florida, Inc. (LSF), DBA Transportation America accessing the Professional Services Agreement for Municipal Trolley Operations Services, Contract No. 18483 (RFP No. 256244) including prior amendments listed below and as further amended herein, for the provision of transportation services on Miami-Dade County Bus Routes: 1. 29, 46, 56, 71, 72, 82, 101A, 115, 155, 202, 210, 211, 212, 217, 246, 248, 254, 267, 272, 286, 344, and six (6) Life Lines.

Prior amendments to Contract No. 18483 (RFP No. 256244):

- 1. Letter dated October 30, 2017, "RE: Fueling pursuant to Professional Services Agreement for Municipal Trolley Operations Services, Contract No. 256244,"
- 2. Amendment No. 1 including sections 7.12 and 7.13
- 3. Letter of Understanding dated November 23, 2020, "Re: Professional Services Agreement for Municipal Trolley Operations Services, Contract No. 256244, Section 7.3 Diesel Fuel,"
- 4. Amendment No. 2 including section 7.14

It is mutually understood and agreed by and between the undersigned contracting parties to amend the previously executed contract effective February 28, 2022 as follows:

- A. Amendments to Section XVII. Termination, of the Professional Services Agreement for Municipal Trolley Operations Services:
 - a) Amend language in Subsection 17.1 to include (bold and underlined):

The Contractor is determined by the City to be in breach of any of the <u>material</u> terms and conditions of the agreement or any other agreement the Contractor has with a Florida public agency. <u>Prior to issuing any Notice of Termination, the</u> <u>City (County) shall issue a written Notice to Cure and provide 30 days to</u> <u>remedy the alleged violation.</u>

Re: One-Year Extension of the Professional Services Agreement for Municipal Trolley Operations Services, Page 1 of 3 Contract No. 256244 (2022-2023) b) Subsection 17.2, of Section XVII. Termination, which provides as follows is hereby deleted in its entirety:

"The City Manager has determined that such termination will be in the best interest of the City to terminate the Agreement for its own convenience."

B. Add the following to Section 7. Additional Terms and Conditions:

7.15 Bus Disinfecting and Sanitizing. Contractor shall provide Bus Disinfecting and Sanitizing Services for all buses assigned to Contract No. 18483 (RFP No. 256244) (Contracted Routes) daily at a fixed amount of \$9.00 per vehicle cleaned and disinfected, and on up to seven (7) days per week, at their facilities as follows:

- a. Contractor is required to disinfect and sanitize the bus after the morning service when the vehicle returns to the garage and at night before morning departure. If Contractor's bus does not return to the garage after morning peak Contractor is required to sanitize the bus after every other run at the end of the line. Contractor is required to use materials that meet the Environmental Protection Agency (EPA) List N guidelines for COVID-19.
- b. The Contractor will disinfect interior at commonly touched surfaces of the bus. This will include but may not be limited to driver's compartment area, bus seats, poles, door handles, handrails, fare collection (if not covered) equipment, doors, windows, window sills, passenger pull chord and grab rails which shall be sprayed and/or wiped down or disinfected by any other approved method.
- c. Time for Provision of Services. Contractor shall perform the Services specified herein from Monday through Sunday, including holidays prior to buses being dispatched into service.
- d. Labor, Materials, and Equipment. Contractor shall furnish all labor, materials, equipment, transportation and all other work and incidentals required to provide Services under this Agreement. The Contractor shall also be responsible for storing and securing all the pre-approved cleaning supplies and equipment (disinfecting wipes, garbage bags, disinfecting sprays, etc.) that Contractor utilizes in the provision of Services under this Agreement.
- e. Safety & Safety Supplies. Contractor shall be responsible for providing Contractor's Staff with all personal protective equipment such as, hats gloves, masks, face shields etc. that Contractor deems necessary for the safety of Contractor's Staff.
- DTPW may decrease or increase the quantity on the frequency or number of buses to be cleaned and disinfected at any time during the term of this Agreement.
