1. What interests you about the Health Council of South Florida?

What interests me about the Health Council of South Florida (HCSF) is your vision to drive integration, collaboration and engagement, to improve the health and wellness of residents in the communities we serve. I see HCSF as trusted partner in our community and value your service in data sharing, measurement, evaluation and quality improvement for community benefit. I also appreciate your work in facilitating collaboration, advocacy and partnerships among key community stakeholders, building capacity and driving positive change.

2. What skills, connections, resources, and expertise do have to offer and are willing to use on behalf of the Health Council of South Florida?

I am an accomplished leader with over 15 years of progressive hospital administration and operations experience leading multiple service lines and programs, and have been a licensed occupational therapist since April 2000. I have a strong track- record in past clinical, leadership and operating roles, in profit and loss management and clinical programming. I currently serve as Director of Telehealth and Special Projects at Nicklaus Children's Hospital, where I provide leadership in telehealth strategy, partnerships and operations, in the delivery of virtual care services across the organization. I have led telehealth services at Nicklaus Children's since 2014, and was a key stakeholder in supporting providers in successfully scaling telehealth services during the COVID-19 pandemic. In 2020, providers delivered over 31K virtual visits, a 7,000% increase over prior year. During my tenure at Nicklaus Children's, I have held various leadership roles including Director of Rehabilitation, Director of Global Health and Administrative Director of Orthopedic Surgery. I hold a Bachelor of Science in Occupational Therapy degree, a Master of Science in Health Services Administration, and Doctor in Occupational Therapy (OTD) degree, with a concentration in administration and practice management. I enjoy mentoring students and currently serve as Adjunct Professor at Nova Southeastern University, teaching business and management coursework, including strategic planning and business plan development. I am involved in national and local volunteer activities, which include Chair for the American Telemedicine Association (ATA) Telerehabilitation Special Interest Group (SIG); Member of the ATA Tele-Mental Health SIG Controlled Substances Subcommittee; Co-Chair for the Florida Occupational Therapy Association Early Intervention/School Systems Special Interest Section; and Treasurer for a Parent Teacher Student Association (PTSA).

I am a thought leader and interact with community leaders, policymakers and key stakeholders, for knowledge transfer, to bring awareness to pediatric healthcare issues and develop relationships, with the aim of enhancing access to multidisciplinary pediatric care for unserved children and families. I have been invited to present at numerous local and national conferences, serving as conference chairperson, keynote and podium speaker, and poster presenter at over 30 national and international conferences. I have led in various quality

improvement projects and served as Principal Investigator (PI) or co-PI. I am currently leading in secondary analysis of data to study health outcomes and translational clinical efforts in virtual care. These initiatives have supported telehealth innovation and have paved the way for future research projects and scientific discovery in telehealth. I have collaborated with local and national colleagues in peer-reviewed journal publications focused on telerehabilitation policy and early intervention, which are in press and will be published December 2021.

3. Have you had any experience in serving on non-for-profit boards and, if so, what has that experience taught you?

I have worked for a not-for-profit organization, Nicklaus Children's Hospital, for nearly 30 years. My experience serving on a non-profit board has been limited to Treasurer for my child's school PTSA Board. As Treasurer, I have fiduciary responsibilities which include budgeting, financial and accounting operations, implementing financial controls, maintaining accounting records, fundraising, grants management, filing IRS federal taxes, and am the authorized custodian of the funds of the association. I enjoy offering my time, skills and expertise to non-profits and volunteer driven organizations, to give back to the community. My current job responsibilities at Nicklaus include grant management. I have been an instrumental stakeholder in securing several non-research grants and contracts, serving as operational lead or PI. I have led in development of effective workflows, outcome measures, and established strong ties with community organizations and partners. In 2015, I secured a contract with Early Steps for tele-rehabilitation consultative services. Early Steps is Florida's early intervention system program serving children age birth to 36 months, who have or are at risk of developmental disabilities or delays. The telehealth program focused on offering telehealth consultations by rehabilitation services professionals for underserved children and families residing in underserved and rural areas of Miami and the Florida Keys.

In 2017, I was also instrumental in securing a \$1-million annual contract from the Florida Department of Health (DOH) to provide basic nursing telehealth supported services to over 75,000 students in 62 Miami Dade County Public Schools, the 4th largest school district in the country. The program has received funding from DOH through the 2020-2021 academic year and is well positioned for continued funding and sustainability. I served as PI for this grant from 2017 to April 2019. In 2020, I was part of a team that secured a \$300,000 award from the Florida Blue Foundation over a three-year period, and launched a telehealth nursing intervention program to improve the transition to home care for patients being discharged from the neonatal intensive care unit (NICU). In 2021, I have contributed to securing several other small grants and private donor sponsorships to support other programs including telehealth mental health services. These grant supported programs have laid the groundwork for telehealth expansion and future research at NCHS.

I have extensive experience in data management and analysis, needs assessment, community health services planning, program evaluation, grants management, performance and quality improvement, and building community strategic partnerships. My academic training, clinical background, operations track record of success, as well as my passion for public health, make me an ideal candidate to serve on the HCSF Board of Directors. It would be a great honor to serve on the HCSF Board of Directors and have a greater impact to improve the quality of life of residents in our community, improving health equity and promotion, and reducing disparities in access to care.

4. What expectations do you have from the management of organizations on whose boards you serve?

An expectation I would have from the management of the organization is to provide an orientation to new Board of Director members and board initiatives for historical perspective including HCSF goals, priorities, challenges and opportunities. I would welcome any educational opportunities and resources that may be facilitated by the management of the organization, and will ensure the success of the Board of Directors as a

whole, and enable individual board members to have the greatest impact on the community. I would appreciate having access to any databases, reports, needs assessments and other important documents available to HCSF, which will assist the Board of Directors during strategic planning discussions. Additionally, an expectation from the management is to set clear roles and responsibilities for board members, to optimize their engagement, effectiveness and success. Finally, I would be excited to build strong working relationships and partnerships with the management team and other Board of Director members to help advance the HCSF vision and mission.

5. What challenges do you anticipate having in being able to fulfill your board commitments?

Understanding that board commitments require significant time and effort, it will be key to manage my time to effectively provide leadership and fulfill my obligations of service. I will mitigate those challenges through effective calendar management to ensure active participation in board meetings and activities.

I am confident that my participation on the Board will support me in pursuit of career growth as a healthcare executive and taking on new leadership challenges for community benefit. I am passionate about increasing access to specialized healthcare services via telehealth for underserved children and promoting health equity. I am a member of the American College of Healthcare Executives (ACHE) and take advantage of outstanding professional development and networking opportunities. I have led in development of effective workflows, outcome measures, and established strong ties with community organizations and partners. In 2015, I secured a contract with Early Steps for tele-rehabilitation consultative services. Early Steps is Florida's early intervention system program serving children age birth to 36 months, who have or are at risk of developmental disabilities or delays. The telehealth program focused on offering telehealth consultations by rehabilitation services professionals for underserved children and families residing in underserved and rural areas of Miami and the Florida Keys.

In 2017, I was also instrumental in securing a \$1-million annual contract from the Florida Department of Health (DOH) to provide basic nursing telehealth supported services to over 75,000 students in 62 Miami Dade County Public Schools, the 4th largest school district in the country. The program has received funding from DOH through the 2020-2021 academic year and is well positioned for continued funding and sustainability. I served as PI for this grant from 2017 to April 2019. In 2020, I was part of a team that secured a \$300,000 award from the Florida Blue Foundation over a three-year period, and launched a telehealth nursing intervention program to improve the transition to home care for patients being discharged from the neonatal intensive care unit (NICU). In 2021, I have contributed to securing several other small grants and private donor sponsorships to support other programs including telehealth mental health services. These grant supported programs have laid the groundwork for telehealth expansion and future research at NCHS.

I have extensive experience in data management and analysis, needs assessment, community health services planning, program evaluation, grants management, performance and quality improvement, and building community strategic partnerships. My academic training, clinical background, operations track record of success, as well as my passion for public health, make me an ideal candidate to serve on the HCSF Board of Directors. It would be a great honor to serve on the HCSF Board of Directors and have a greater impact to improve the quality of life of residents in our community, improving health equity and promotion, and reducing disparities in access to care.
