Resolution Ratifying an Extension of Time to the Department Funded Agreement for a **Subject:**

> Project Related to Miami-Dade Water and Sewer Department Consent Decree and Capital Improvement Programs Acceleration Ordinance pursuant to Section 2-8.2.12 of the

Miami-Dade County Code

Executive Summary

The attached resolution seeks ratification by the Board of County Commissioners (Board) of Amendment No. Two (Amendment) to the Department Funded Agreement Between the State of Florida Department of Transportation and Miami-Dade County (FDOT Agreement). The Amendment provides a non-compensable time extension of 547 days to the contract term.

Recommendation

It is recommended that the Board ratify the action of the County Mayor or County Mayor's designee, as authorized under Section 2-8.2.12 of the Miami-Dade County Code related to Miami-Dade Water and Sewer Department's Consent Decree and Capital Improvement Programs Acceleration Ordinance (WASD's Acceleration Ordinance) for the funded Project identified below and on Exhibit A, as attached.

Capital Improvement Project

Item 1- Amendment No. Two to the Department Funded Agreement Between the State of Florida Department of Transportation and Miami-Dade County for an extension of the contract term by 547 non-compensable days to June 30, 2023. The FDOT Agreement was entered into so the County's contractor could conduct roadway improvements at S.R. 916/N.W./N.E. 135 Street from N.W. 6 Avenue to S.R. 5/Biscayne Boulevard while the County is installing water and sewer infrastructure in the area. The Amendment is attached hereto as Exhibit B.

Scope

The County's utility project consists of installing approximately 13,210 linear feet of 36-inch Ductile Iron Pipe and 1,300 linear feet of High-Density Polyethylene via horizontal directional drilling in the vicinity of N.E. 135 Street from N.W. 7 Avenue to N.E. 16 Avenue (Project). While the County is doing the utility work, FDOT requested that the County's contractor perform roadway improvements along S.R. 916 from N.W. 6 Avenue to S.R. 5/Biscayne Boulevard. This Project is located in District 2, which is represented by Commissioner Jean Monestime.

Fiscal Impact/Funding Source

Amendment No. Two provides for a non-compensable time extension with no additional monies, so there is no fiscal impact to the County.

Delegation of Authority

Amendment No. Two was approved pursuant to Section 2-8.2.12 of the Miami-Dade County Code related to WASD's Acceleration Ordinance, which delegates authority to the County Mayor or County Mayor's designee to award certain projects, and among other things, negotiate and settle claims and execute change orders that do not exceed ten percent (10%) of the base contract amount, subject to ratification by the Board

Track Record/Monitoring

WASD Deputy Director of Capital Improvements, Marisela Aranguiz, P.E., will oversee the implementation of Amendment No. Two.

Background

On June 4, 2019, the Board of County Commissioners adopted Resolution R-606-19, which approved a Joint Participation Agreement between the County and the Florida Department of Transportation (FDOT). The FDOT Agreement is a joint utility and roadway improvement project in which FDOT will reimburse the County for the cost of roadway improvements needed by FDOT along State Road 916/N.W.-N.E. 135 Street, which improvements are being done by the County's contractor while it performs the County's utility work.

The County's Project was expected to reach Substantial Completion in February 2022 and Final Completion in April 2022. Due to unforeseen circumstances that were encountered during the construction of the Project and in order to allow for further coordination with FDOT, the parties have entered into Amendment No. Two to add additional time to the FDOT Agreement, extending its term to June 30, 2023.

To date, the delays encountered by the Contractor that necessitate additional time include:

- 1) Unexpected conflicts with utility infrastructure for several entities, such as AT&T and the City of North Miami's water mains, sewer laterals, force mains and drainage utilities, which caused a delay of 146 days;
- 2) The need to relocate an unforeseen TECO Gas line along N.E. 135 Street between N.E. 12 Avenue and N.E. 16 Avenue, which caused a delay of 49 days;
- 3) The discovery of contamination in the Harriet Tubman Highway section of the Project, which prompted the work to pause since August 31, 2021, until the contamination is resolved. For this purpose, the Contractor has retained a geologist to perform testing to determine the limits and levels of contamination. The number of days of delay due to this issue have not been determined at this time;
- 4) The complex nature of the final water main connection at N.E. 16 Avenue and the difficulty obtaining raw materials, such the tapping sleeve needed for this connection, which caused a delay of 304 days; and

5) Complications with the phasing of a bridge rehabilitation and maintenance of traffic plan that could not proceed until the TECO Gas line referenced above had been relocated.

The Department Funded Agreement Between the State of Florida Department of Transportation and Miami-Dade County is kept on file and is available upon request from the Procurement Division of the Miami-Dade Water and Sewer Department.
