Subject: Approval of the Use of Up to \$12,416,812.45 of Charter County Transportation Surtax Funds for Various Roadway Resurfacing Projects

Executive Summary

The purpose of this item is to gain approval of the Board of County Commissioners (Board) to authorize the Administration’s use of up to \$12,416,812.45 in Charter County Transportation Surtax Funds for roadway resurfacing contracts awarded under the Miscellaneous Construction Contracts 7360 Plan. This item does not increase the amount of discretionary People’s Transportation Plan (PTP) funding. The intent is to prepare for an anticipated increase in spending by Commissioners of their discretionary PTP funds.

Recommendation

It is recommended that the Board approve the use of Charter County Transportation Surtax (Surtax) funds for selected roadway resurfacing projects as part of the Neighborhood Infrastructure Improvements Program. These contracts are currently approved for the use of non-Surtax funding sources via the Miscellaneous Construction Contracts (MCC) Program. The Department of Transportation and Public Works (DTPW) is seeking approval for the use of Surtax funding for the roadway improvement projects included within the PTP as approved by individual commissioners. The contracts are enumerated below and further details can be found in the accompanying attachments, Exhibit A.

Contract No. 1 – Roadway Resurfacing-Multiple Sites (RPQ No. 20210056, MCC 7360 Plan) with a total awarded amount of \$3,824,866.56 to H & J Asphalt, Inc.

Contract No. 2 – Roadway Resurfacing-Multiple Sites (RPQ No. 20210057, MCC 7360 Plan) with a total awarded amount of \$3,706,594.51 to H & R Paving, Inc.

Contract No. 3 – Roadway Resurfacing-Multiple Sites (RPQ No. 20210190, MCC 7360 Plan) with a total awarded amount of \$3,958,150.46 to Metro Express, Inc.

Contract No. 4 – Roadway Resurfacing-Multiple Sites (RPQ No. 20210191, MCC 7360 Plan) with a total awarded amount of \$4,031,404.03 to Metro Express, Inc.

This item may only be considered by the Board if the Citizens’ Independent Transportation Trust (CITT) has forwarded a recommendation to the Board prior to the date scheduled for Board consideration or 45 days have elapsed since the filing with the Clerk of the Board of this item.

If the CITT has not forwarded a recommendation and 45 days have not elapsed since the filing of this item, the Administration will request a withdrawal of this item.

Scope

These contracts have been previously awarded under the MCC Program with a scope of work consisting of roadway resurfacing improvements throughout Miami-Dade County. The scope of work per contract is captured in Exhibit A.

Fiscal Impact/Funding Source

The projects are funded by proceeds of Surtax Financings allocated as part of Neighborhood Infrastructure Improvements, (Program 2000000535) – People’s Transportation Plan / Projects: 3002896, 3002897, 3002898, 3002901, 3002902, 3002903, 3002904, 3002905, 3002906, 3002907, 3002908, 3002909, and 3002910, funded by the Surtax in the FY 2021-22 Adopted Budget and Multi-Year Capital Plan. This program is part of the original Exhibit 1 to the People’s Transportation Plan, which as approved by voters, includes modifications of intersections; resurfacing of local and arterial roads; installation/repairs of guardrails; installation of school flashing signals and enhancement of greenways and bikeways; replacement/repair of sidewalks; repair/installation of drainage, landscape beautification roadway signage, roadway lighting, pavement markings, and traffic calming; and Americans with Disabilities Act (ADA) accessibility to bus stops throughout the County. There is no additional fiscal impact to operations or maintenance.

Track Record/Monitor

DTPW reviewed the performance history of the awarded contractors and reports the following:

- (1) H & J Asphalt, Inc. has performed work for Miami-Dade County at a satisfactory level. The Capital Improvements Information System (CIIS) lists 142 performance evaluations with an average overall performance rating of 3.2 out of a possible 4.0 rating.
- (2) H & R Paving, Inc. has performed work for the County at a satisfactory level. The CIIS lists 234 performance evaluations with an average overall performance rating of 3.3 out of a possible 4.0 rating.
- (3) Metro Express, Inc. has performed work for the County at a satisfactory level. The CIIS lists 65 performance evaluations with an average overall performance rating of 3.6 out of a possible 4.0 rating.

These roadway resurfacing projects will be monitored by Joaquin Rabassa, P.E., DTPW Construction Manager.

Delegation of Authority

No additional delegation of authority is being sought.


Background

The resurfacing contracts were originally procured with Road Impact Fee funding through the MCC Program. DTPW issued a Request for Price Quotation to a pool of firms registered with the Internal

Services Department (ISD) for each respective trade. Additionally, DTPW advertised each project in the Daily Business Review and all solicitations were available online through the County portal under the “Procurement Solicitations” link. Each project’s award evaluation was based upon the bid submitted by the lowest responsive and responsible bidder.

Furthermore, due diligence was conducted in accordance with ISD’s Procurement Guidelines to determine contractor responsibility, including verifying corporate status with the Florida Department of State’s Division of Corporations and review of performance or compliance issues. A copy of all bids, and the bid tabulation for all projects, is available by contacting DTPW’s Capital Improvements Division. Consistent with Florida Statutes 212.055 and Sections 29-124 and 2-1421 of the County Code, Surtax funds will be used for projects included in the Five-Year PTP Implementation Plan. However, per restrictions placed on the use of transportation Surtax funds under the State Legislature’s House Bill 385, the use of PTP funds will no longer be authorized for resurfacing projects. The bill’s relevant provisions will become effective on October 1, 2022. Accordingly, to ensure that the funds available to each commission district for Neighborhood Improvements can be timely allocated, this item must be approved prior to that deadline.

All four contracts provide DTPW a means of quickly responding to the expected increase in funding approval of resurfacing work via competitively bid contracts. The work on these contracts is initiated via work order on an as-needed basis. Within the contract, an estimated quantity is provided for bidding purposes as plan details are not available at the time of the bid. Bidders are advised that actual quantities may vary, depending on the scope of work identified in each work order. Payment is based on the authorized work completed by the contractor.



Background: On June 24, 2021, DTPW forwarded an RPQ for Roadway Resurfacing-Multiple Sites, utilizing the MCC 7360 Plan – CICC 7360-0/08 Contract, to a list of 76 pre-qualified firms. Five submitted contract documents, and all five firms proffered a bid.

On July 28, 2021, H & J Asphalt Inc. proffered the lowest responsive and responsible base bid of \$3,279,344.10, which is 8.35 percent above the County's cost estimate. The second lowest bidder, H & R Paving, Inc. proffered a base bid of \$3,340,111.05, which is 10.36 percent above the County's cost estimate. The third lowest bidder, Metro Express, Inc., proffered a base bid of \$3,594,944.50, which is 18.78 percent above the County's cost estimate. Based on the results of the solicitation, DTPW issued a recommendation for award on August 23rd, 2021, for RPQ No. 20210056 to H & J Asphalt, Inc.

The third lowest bidder, H & R Paving, Inc. proffered a base bid of \$3,679,414.30, which is 15.42 percent above the County's cost estimate.
