Subject:	Resolution Ratifying Action Related to the Award of Haulover Park, Boat Ramp and Parking Lot Renovat 17-005, Contract: 222302-17-005	

Executive Summary

The purpose of this item is for the Board of County Commissioners to ratify the action of the County Mayor or Mayor's Designee, as authorized under the County's Economic Stimulus Plan Ordinance, for the award of a construction contract to General Asphalt Co. Inc. in the amount of \$10,521,985.32 for renovations to Haulover Park's boat ramp and parking lot. The request for upgrades responds to current sea level rise and flood mitigation data for Haulover Park. In an effort to advance resiliency solutions, the Miami-Dade County Parks, Recreation and Open Spaces Department (PROS) has identified vulnerable locations that will benefit from renovations geared to addressing sea level rise. The construction phase of this project comprises the replacement of existing piers with a concrete floating dock system and renovating existing parking lots and access roads by raising grade elevation by three feet and improving drainage, signage, and lighting.

Recommendation

It is recommended that the Board of County Commissioners (Board) ratify the action of the County Mayor or Mayor's Designee, as authorized under the County's Economic Stimulus Plan (ESP) Ordinance (Section 2-8.2.7 of the Code of Miami-Dade County) for the award of a construction contract in the amount of \$10,521,985.32 to General Asphalt Co. Inc. for the Haulover Park Boat Ramp and Parking Lot Renovation ESP, Project No: 222302-17-005, Contract: 222302-17-005.

Scope

Haulover Park and the park's Bill Bird Marina are located at 10700 Collins Avenue, Miami, FL 33154 within County Commission District 4, which is represented by Commissioner Sally A. Heyman, and are assets of County-wide significance.

Fiscal Impact/Funding Source

The funding sources for this project are \$7,826,640.00 of Building Better Communities General Obligation Bond Program (GOB) funds; \$1,195,345.32 of Countywide Infrastructure Investment Plan (CIIP) funds, and \$1,500,000.00 of Florida Inland Navigation District (FIND) funds for a total of \$10,521,985.32, as outlined in Attachment A. These capital programs were included in the County's FY 2021-22 adopted budget and multi-year capital plan.

Delegation of Authority

The authority of the County Mayor or County Mayor's designee to execute and implement this contract is consistent with those authorities granted under the Code of Miami-Dade County. Approval of this project is pursuant to the County's Economic Stimulus Plan (ESP) Ordinance (Section 2-8.2.7 of the Code of Miami-Dade County).

Track Record/Monitor

The Planning, Design, and Construction Excellence Division Contract Manager Mr. Michael J. Cornely will oversee the implementation of this project. Mr. Guillermo Pena will be the Project Manager overseeing this project throughout the construction phase.

Background

The purpose of the ESP Program is to expedite competitively awarded construction contracts and professional services agreements associated with funded capital improvement projects with the express purpose of stimulating the local economy. The ESP Program continues to be an effective way of accelerating the County's capital improvement program by expediting funded projects through the contract approval process.

In an effort to advance resiliency solutions, PROS has identified vulnerable locations that will benefit from renovations geared to addressing sea level rise. This mitigation strategy provides flood protection from seasonal weather events and coastal threats such as storm surge, king tides, and rain events. The proposed enhancements will provide lasting benefits for public use of the marina and recreational boating.

The contract for the improvements to Haulover Park and the park's Bill Bird Marina includes, but it is not limited to the raising and replacement of existing boat ramps; replacement of existing docks with concrete floating docks; elevating the existing parking lot, approach, access and staging roads, primary and secondary overflow parking lots by three (3) feet, along with drainage, lighting, and signage to comply with sea level rise recommendations. Also included are new intersections, entry points and the reconfiguration of existing entrances, removal and replacement of a sewer lateral, and landscaping and restoration work further described in the contract documents. Attachment A is the recommendation to award the construction contract and includes the details of the competitively bid award for which ratification is being requested.


