Subject:	Parking License Agreement with the City of Miami Gardens Authorizing Miami- Dade County's Use of a Parking Garage and Adjacent Parking Lot During the Inaugural Miami Grand Prix

#### Recommendation

It is recommended that the Miami-Dade Board of County Commissioners (Board) approve the attached resolution, pursuant to Section 2-9 and 2-10 of the Miami-Dade County Code, and ratify the execution of a Parking License Agreement (Agreement) between the City of Miami Gardens (Miami Gardens) and Miami-Dade County (County), for the Miami-Dade Police Department's (MDPD) use of a parking garage and adjacent vacant parking lot during the inaugural Miami Grand Prix. Miami Grand Prix weekend began on May 6, 2022, and concluded on May 8, 2022. The Agreement was executed on April 28, 2022, and there was no cost to the County.

#### **Scope**

The parking garage and adjacent vacant parking lot used by the MDPD to stage personnel and vehicles during Miami Grand Prix weekend are located in Commission District 1, which is represented by Commissioner Oliver Gilbert III.

#### **Delegation of Authority**

Pursuant to Section 2-8.3 of the County Code, there are no delegations of authority beyond those specified in the Resolution.

#### **Fiscal Impact/Funding Source**

There were no costs associated with the MDPD's use of the parking garage and adjacent parking lot located in Miami Gardens during the inaugural Miami Grand Prix. As such, there was no fiscal impact to the County.

### **Track Record/Monitor**

Chief Edgardo Caneva, of MDPD's Strategic Response Division, tracked and monitored the Agreement.

### Background

Formula One, also known as Formula 1 or F1, began in 1950 and is viewed as the world's most prestigious motor racing competition, as well as the world's most popular annual sporting series. A Formula 1 season consists of a series of races, known as Grand Prix, which take place worldwide on both purpose-built circuits and closed public roads. A Formula 1 Grand Prix event spans a weekend and begins with two free practice sessions on Friday and one free practice session on

Saturday. The free practice sessions determine the starting order for the race on Sunday. A Formula 1 Grand Prix race is one of the world's most powerful tourism advertisements for the city hosting the race, as Formula 1 is among the world's most-watched annual sports series garnering a cumulative audience of 1.8 billion viewers each season. As such, cities that host a Formula 1 Grand Prix race benefit from increased tourism, spending, and economic development that accompany the race.

On May 15, 2018, the Board adopted Resolution No. R-518-18 directing the County Mayor or County Mayor's designee to negotiate an agreement with the appropriate entity for the hosting of Formula 1 racing events in the County and to coordinate with any hosting municipality and other municipalities on such events, provided, however, that the site commonly referred to as Parcel B and located behind the American Airlines Arena would not be considered or used as a site for hosting the Formula 1 racing events. After consideration, Hard Rock Stadium, located in Miami Gardens, and Formula 1 negotiated an agreement to host the Miami Grand Prix on its property.

The Miami Grand Prix is a Formula 1 Grand Prix which forms part of the 2022 Formula 1 World Championship. The inaugural Miami Grand Prix took place on May 8, 2022, with practice sessions taking place on May 6, 2022, and May 7, 2022. The MDPD provides sheriff services throughout the County, and aided Miami Gardens and the Miami Gardens Police Department during the Miami Grand Prix. The MDPD required the use of an area to stage law enforcement personnel and vehicles, as such Miami Gardens provided the MDPD authority to use a parking garage and adjacent parking lot located in Miami Gardens. The Parking License Agreement attached and labeled herein as Exhibit A, establishes the terms and responsibilities of each party.

#### PARKING LICENSE AGREEMENT

THIS LICENSE AGREEMENT, made and entered into this <u>4th</u> day of <u>April</u>, 2022 by and between the **CITY OF MIAMI GARDENS**, FLORIDA (hereinafter, "CITY"), a municipal corporation of the State of Florida, whose address is 18605 N.W. 27<sup>th</sup> Avenue, Miami Gardens, Florida 33056, and MIAMI-DADE COUNTY, a political subdivision of the State of Florida and its police department, the Miami Dade Police Department, (hereinafter, "LICENSEE"), whose address is 9105 NW 25<sup>th</sup> Street, Doral, Florida 33172.

WITNESSETH:

WHEREAS, LICENSEE desires to obtain a license to park vehicles at City of Miami Gardens Parking Garage and vacant lot located at NW 27<sup>th</sup> AVE and NW 187 Street, adjacent to the parking garage ("Premises"), which is owned by CITY, and

WHEREAS, the CITY agrees to permit LICENSEE to park vehicles on the Premises, subject to certain terms and conditions.

NOW, THEREFORE, for and in consideration of the mutual covenants and promises as hereinafter set forth and of the faithful performance of all such covenants and conditions, LICENSEE AND CITY do hereby agree as follows:

1. The CITY hereby grants to LICENSEE the license, permit and privilege to park vehicles on the premises in an area designated by the CITY for parking. No tractor-trailer, RV's or other large vehicles may be parked on the Premises. This Agreement shall be in effect for Formula 1 weekend (May 6, 2022, through May 8, 2022).

2. The CITY's Police Department will assign police officer(s) to the Premises for security purposes.

3. LICENSEE and CITY intend that this document shall be a license and privilege, and that no leasehold or other interest in the land is conferred upon the user under the provisions hereof.

4. LICENSEE shall be deemed an independent contractor and not an agent or employee of the CITY and shall not attain any rights or benefits generally afforded to CITY employees; further, LICENSEE shall not be deemed entitled to the CITY'S worker's compensation, insurance benefits or similar protections or benefits. LICENSEE shall obtain written approval prior to engaging any subcontractor(s) to assist with fulfilling the obligations outlined in this Agreement.

5. Each party agrees to assume responsibility for the acts, omissions, or conduct of such party's own employees while participating herein and pursuant to this Agreement, subject to the provisions of Section 768.28, Florida Statutes, where applicable. "Assume Responsibility" shall mean incurring any and all costs associated

with any suit, action, or claim for damages arising from the performance of this Agreement.

6. LICENSEE shall maintain insurance coverage or maintain an ongoing selfinsurance program in sufficient amounts for the performance of this Agreement including public liability, automobile liability, police professional liability and workers' compensation. If requested, LICENSEE shall provide satisfactory proof of the required insurance or ongoing self-insurance program.

7. LICENSEE in the conduct of its activities under this Agreement shall comply in all material respects with all applicable federal, state, and local laws and regulations.

8. CITY shall have the right in its sole discretion to terminate this Agreement without or without cause, and without notice if LICENSEE breaches any provision of this Agreement.

9. In the event that any sentence, section, paragraph, or portion of this Agreement shall be held by a court to be invalid for any reason, such invalidity shall not affect the remaining portions of this Agreement and the same shall remain in full force and effect.

10. Any waiver by either party hereto of any one or more of the covenants, conditions, or provisions of this Agreement, shall not be construed to be a waiver of any other covenant, condition, or provision of this Agreement.

11. Any and all notices to be given to CITY under this Agreement may be given by certified or registered mail addressed to:

12. In the event that either party is required to file legal action to enforce provisions under this Agreement, the prevailing party shall be entitled to its costs of collection, attorney's fees and costs, and interest at the maximum rate allowable by law.

13. This Agreement shall be governed by the laws of the State of Florida and venue shall lie in Miami-Dade, Florida.
