#### **Recommendation**

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for DCG Development is bounded on the north approximately 350 feet south of SW 80 Street, on the east by SW 121 Avenue, on the south by SW 81 Terrace, and on the west by SW 122 Avenue.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Full scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

#### **Scope**

This plat is located in Commission District 10, which is represented by Senator Jaiver D. Souto.

### **Delegation of Authority**

There are no delegation requirements with this item.

#### Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the County would be approximately \$150.00 annually for roadway construction adjacent to the project. These costs would be covered by the Department of Transportation and Public Works' annual General Fund allocation.



RESOLUTION APPROVING THE PLAT OF DCG DEVELOPMENT FILED BY DCG INVESTMENTS, INC., LOCATED IN THE SOUTHEAST 1/4 OF SECTION 36, TOWNSHIP 54 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH APPROXIMATELY 350 FEET SOUTH OF SW 80 STREET, ON THE EAST BY SW 121 AVENUE, ON THE SOUTH BY SW 81 TERRACE, AND ON THE WEST BY SW 122 AVENUE)
