Pursuant to the authority vested in me under Section 2.02(C) of the Miami-Dade County Home Rule Charter, I hereby appoint Raied "Ray" Jadallah to the position of Fire Chief for Miami-Dade Fire Rescue (MDFR), effective immediately.

Chief Jadallah is a 26-year fire service veteran and has had a distinguished career with MDFR for the last 22 years. Most recently, as the Deputy Fire Chief of Emergency Operations, Chief Jadallah oversaw 2,100 MDFR employees who provide vital services such as fire suppression, medical rescue services, and emergency services. He has also overseen the Office of Emergency Management and has been tasked as the Department's Incident Commander for COVID-19 since March 2020, leading the County's coordinated COVID response within MDFR. In 2021, he oversaw one of the most significant complex incidents in Miami-Dade's history – the Champlain Towers South building collapse in Surfside.

Chief Jadallah holds a bachelor's degree in fire and emergency services management from St. Thomas University. His resume is attached for your reference. I have the utmost confidence in Chief Jadallah's leadership and know he will continue to provide essential fire rescue and emergency response services to our millions of residents and visitors. Chief Alan Cominsky will take on a critical new role as Miami-Dade County's Chief Fire Marshal helping lead building safety efforts Countywide.

Please join me in congratulating Chief Jadallah on his appointment and in congratulating Chief Cominsky on his new role as Chief Fire Marshal.

# Surfside Champlain Tower South Collapse – June 2021

As the Assistan Fire Chief of Operations, I assumed oversight of all operations in the initial hours of the tragic collapse as part of MDFR's Incident Management Team (IMT). During this mission, I transitioned to become the Agency Representative for the families of the missing where my role was to provide information to the families twice a day and keep them updated.

### Super Bowl LIV – February 2020

As the Operations Section Chief, I was responsible for the oversight of all response units and personnel for the event that brought almost 70K spectators to the Hard Rock Stadium. This task involved an 18-month preparation of plan involving the coordination with various stakeholders and committees regarding hundreds of sanctioned and unsanctioned events over seven days of Super Bowl activities in Miami-Dade County.

#### o COVID-19 - March 2020

Assigned as the Incident Commander, my responsibilities entailed from the selection of a team to the coordination and implemention of a response plan to be used by MDFR, various County departments and State agencies.

# o FIU Bridge Collapse – March 2018

As the Deputy Incident Commander, on March 15, 2018, when the Florida International University pedestrian bridge suddenly collapsed, I was responsible for coordinating the strategy and tactics necessary to mitigate the incident.
