RESOLUTION DECLARING SEPTEMBER 2022 AND THE
MONTH OF SEPTEMBER OF EACH YEAR THEREAFTER AS
“SUICIDE PREVENTION AWARENESS MONTH”

WHEREAS, suicide is a leading cause of death in the United States, and a major public health concern; and

WHEREAS, according to the United States Centers for Disease Control and Prevention (“CDC”), there was one death by suicide every 11 minutes in 2020; and

WHEREAS, according to the CDC, the number of people who think about or attempt suicide is even higher, with an estimated 12.2 million Americans seriously thinking about suicide, 3.2 million planning a suicide attempt, and 1.2 million attempting suicide in 2020; and

WHEREAS, according to the CDC, suicide affects people of all ages, and in 2020 was among the top nine leading causes of death for people aged 10-64, and was the second leading cause of death for people aged 10-14 and 25-34; and

WHEREAS, while the causes of suicide are complex, mental illness is among the contributing risk factors, according to the National Institute of Mental Health; and

WHEREAS, the United States Surgeon General has acknowledged that Americans are indicating increased mental health concerns, with many individuals facing hardship and social isolation as a result of the coronavirus disease 2019 pandemic; and

WHEREAS, the United States Surgeon General has also stated that identifying and supporting people at risk, as well as increasing social connectedness and helping individuals build coping skills, are protective factors that can help prevent suicide; and

WHEREAS, the National Suicide Hotline Designation Act was signed into law after passage of bipartisan legislation in 2020, authorizing use of the new universal three-digit phone number 9-8-8 as part of a hotline system in the United States for individuals experiencing crisis; and

WHEREAS, September 10 is recognized annually as World Suicide Prevention Day; and

WHEREAS, in 2020, the United States Senate agreed to designate the month of September as “National Suicide Prevention Month”; and

WHEREAS, this Board seeks to promote awareness of the importance of suicide prevention resources in the community; and

WHEREAS, this Board finds that the month of September is an appropriate month to designate as Suicide Prevention Awareness Month,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board declares September 2022, and the month of September of each year thereafter as “Suicide Prevention Awareness Month.”

The Prime Sponsor of the foregoing resolution is Senator René García. It was offered by Commissioner _____, who moved its adoption. The motion was seconded by Commissioner _____ and upon being put to a vote, the vote was as follows:
