RESOLUTION DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE (1) TO INCLUDE AS PART OF THE SCOPE OF THE URBAN AIR MOBILITY ("UAM") SYSTEMS WORKING GROUP CREATED PURSUANT TO RESOLUTION NO. R-1058-21, THE IDENTIFICATION, EVALUATION, DESIGNATION, AND DEVELOPMENT OF A LOCATION, SUCH AS THE EVERGLADES JETPORT OR ANOTHER AVAILABLE AND APPROPRIATE FACILITY, TO **SERVE** AS AN UNMANNED **TRAFFIC MANAGEMENT** ("UTM") **TESTING FACILITY** WITHIN MIAMI-DADE COUNTY: (2) TO COORDINATE WITH APPROPRIATE FEDERAL, STATE, LOCAL AGENCIES, **INCLUDING BUT** AND NOT LIMITED TO THE **FEDERAL** AVIATION **ADMINISTRATION** THE AND MIAMI-DADE TRANSPORTATION PLANNING ORGANIZATION ("TPO"), IN ORDER TO FURTHER THE DESIGNATION AND DEVELOPMENT OF A UTM TESTING FACILITY WITHIN MIAMI-DADE COUNTY; AND (3) TO PROVIDE A REPORT; AND URGING THE TPO TO, IN COORDINATION WITH THE MIAMI-DADE **COUNTY UAM SYSTEMS** WORKING **EVALUATE** GROUP, THE **CONCEPT** OF **DESIGNATING** AND **DEVELOPING** UTM TESTING FACILITY WITHIN MIAMI-DADE COUNTY

WHEREAS, an urban air mobility ("UAM") system is an emerging technology concept that refers to transportation systems for the movement of people and goods by air to mitigate traffic congestion; and

WHEREAS, a UAM system would be an efficient aviation transportation system that utilizes highly automated aircraft that will operate and transport passengers or cargo at lower altitudes within urban and suburban areas; and

WHEREAS, a UAM system in Miami-Dade County may significantly reduce traffic congestion, improve commuting times, and generally enhance mobility options within the County; and

WHEREAS, on November 2, 2021 the Board of County Commissioners adopted Resolution No. R-1058-21 which directed the County Mayor to create a working group to develop an implementation plan for a UAM system in Miami-Dade County (the "UAM Systems Working Group"); and

WHEREAS, on June 2, 2022 the Governing Board of the Miami-Dade Transportation Planning Organization ("TPO") adopted Resolution #24-2022 which approved a scope of services and budget to evaluate the concept of UAM technology and assess policy framework requirements for the integration of said technology into Miami-Dade County's existing transportation network; and

WHEREAS, Miami-Dade County has existing facilities that provide the necessary land area buffered from population areas, that may be feasible for utilization as an urban air mobility ground testing site location; and

WHEREAS, identifying, evaluating, and designating a location, such as the Dade-Collier Training and Transition Airport commonly referred to as the Everglades Jetport, or another available and appropriate facility, to serve as an unmanned air traffic management ("UTM") testing facility would facilitate the research, development and advancement of urban air mobility, positioning Miami-Dade County at the forefront of the emerging UAM transportation system technologies; and

WHEREAS, a UTM testing facility would provide a hub within Miami-Dade County for the management of low-altitude drones, UAM vehicles, and other regional air mobility activities; and WHEREAS, encouraging and enabling coordination by the UAM Systems Working Group, the TPO, the Federal Aviation Administration, as well as other appropriate federal, state, and local agencies, would also assist Miami-Dade County in facilitating UAM industry advancement for testing, assembly, and certification of UAM technology,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Directs the County Mayor or County Mayor's designee (1) to include as part of the scope of the UAM Systems Working Group created pursuant to Resolution No. R-1058-21, the identification, evaluation, designation, and development of a location, such as the Everglades Jetport or another available and appropriate facility, to serve as a UTM facility within Miami-Dade County; and (2) to coordinate with appropriate federal, state, and local agencies, including but not limited to the Federal Aviation Administration and the TPO, in order to further the designation and development of a UTM facility within Miami-Dade County.

Section 2. Directs the County Mayor or County Mayor's designee to provide a status report to this Board regarding the directives and actions identified in section 1 within 45 days of the effective date of this resolution and to place the completed report on an agenda of the full Board without committee review pursuant to Ordinance No. 14-65.

Section 3. Urges the TPO to, in coordination with the UAM Systems Working Group, evaluate the concept of designating and developing a location, such as the Everglades Jetport or another available and appropriate facility, to serve as a UTM testing facility within Miami-Dade County.
