Subject:	Recommendation for Approval to Establish a Prequalification Pool: EVN000045 for Reproduction and Binding Services	

Summary

This item is for the purchase of reproduction and binding services, including but not limited to, architectural blue printing, drawing services, building document files, and project presentations, on an as-needed basis, for multiple County departments. Departments anticipate utilizing this pool for printing jobs that are not available through the County's printshop. Three vendors are being recommended to be included in the pool, and all are certified Small Business Enterprise (SBE) firms. A set-aside measure has been assigned to the pool.

Recommendation

It is recommended that the Board of County Commissioners (Board) approve the establishment of a prequalification pool, *EVN0000045, Reproduction and Binding Services,* for multiple County departments with an allocation of \$1,440,000 for a five-year term. To track pool expenditures by vendor, bidding under this and other prequalification pools will gradually be conducted and monitored in a single platform, INFORMS, which will allow staff to provide data reports to the Board, as requested. The pool will remain open to allow additional vendors that meet the prequalification criteria to be added throughout the pool's term.

The pool will replace current pool, *8254-1/22*, which was established by the Board on September 4, 2012, through Resolution No. R-680-12 for an initial five-year term, with one five-year option to renew, and a cumulative allocation of \$3,816,000. The pool was subsequently modified under delegated authority. The current pool has eleven vendors; ten have local addresses, five of which are certified SBE firms. At the time the pool was established, seven vendors were included in the pool and four additional vendors were added since then. The pools expire at the end of the term unless extended by the Board prior to the expiration.

<u>Scope</u>

The scope of this item is countywide in nature.

Fiscal Impact/Funding Source

The fiscal impact for the five-year term is \$1,440,000. The current pool, *8254-1/22*, is valued at \$4,217,500 for the ten-year and six-month term and expires on April 30, 2023. The allocation for this replacement pool is a reduction from the current pool due to fewer departments participating in the pool.

Track Record/Monitor

Shari Francis of the Strategic Procurement Department is the Procurement Contracting Manager.

Delegated Authority

Upon approval of this item, a pool of prequalified vendors will be established to participate in spot market competitions. The County Mayor or the County Mayor's designee will have the authority to award contracts up to an aggregate amount of the allocation authorized by the Board. The County Mayor or the County Mayor's designee will also have the authority to (a) exercise all provisions of the solicitation documents and any resulting contracts pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38 and (b) add vendors to the pool at any time, subject to ratification by the Board on a bi-annual basis.

Vendors Prequalified for Pool

A Request to Qualify was issued under full and open competition. Three vendors responded to the solicitation, of which all are SBE firms and are being recommended for inclusion in the pool as set forth in the table below.

Outreach efforts conducted included market research to identify and contact potential vendors, and to gauge their interest in participating in the pool. A total of 95 firms were notified upon advertisement. In addition, local and non-local firms, including the incumbents, were notified of the draft scope of services posted to the County's Future Solicitations website. SBD identified eight SBE firms certified under the project commodity code, and three were able to provide the items under this solicitation. Staff will continue to conduct vendor outreach to increase local vendor participation.

Due Diligence

Pursuant to Resolution No. R-187-12, due diligence was conducted in accordance with the Strategic Procurement Department's Guidelines to determine vendor responsibility, including verifying corporate status and that there are no performance and compliance issues through various vendor responsibility lists and a keyword internet search. The lists that were referenced included convicted vendors, debarred vendors, delinquent contractors, suspended vendors, and federal excluded parties. There were no adverse findings relating to vendor responsibility.

Pursuant to Resolution No. R-140-15, prior to re-procurement, a full review of the scope of services was conducted to ensure the replacement pool reflects the County's current needs. The review included conducting market research, posting a draft solicitation for industry comments, corresponding, and drafting sessions with the user departments.

Each spot market quote under this pool must be submitted to Small Business Development for review.
- The Living Wage applies as the services are covered under the Ordinance.
- The Responsible Wages and Benefits do not apply as the services are not covered under the Ordinance.
