## **Executive Summary**

Pursuant to Florida Statute 907.043, Section (4)(a)(b), the "Citizens' Right-To-Know Act," each pretrial services program must submit an annual report to the governing body in the county where the program is located. Miami-Dade Corrections and Rehabilitation Department (MDCR) operates a pretrial services program and is responsible for releasing and supervising offenders who qualify, per the presiding judge's decision during bond hearings, for a non-financial custody release into the pretrial services program. The Annual Report indicates there were 5,435 defendants released into the Pretrial Services Program with 474 (or 9%) failing to report to a court hearing and 610 (or 11%) arrested on a new offense while in the program.

## **Background**

The Pretrial Services Bureau is a component of the MDCR and provides defendant profiles to the judiciary at first appearance hearings and/or subsequent circuit court hearings. The role of the MDCR is to decrease the number of days defendants, who could otherwise be safely released to the community while awaiting court appearances, are incarcerated, and to provide pertinent information to the court, criminal justice agencies, defendants, and the community. While the report is being prepared to be presented through an upcoming committee cycle, we are providing a copy of the Annual Report containing the following information:

- The name, location, and funding sources of the pretrial release program, including the amount of public funds, if any, received by the pretrial release program.
- The operating and capital budget of each pretrial release program receiving public funds.
- The percentage of the pretrial release program's total budget representing receipt of public funds.
- The percentage of the total budget which is allocated to assisting defendants obtain release through a non-publicly funded program.
- The amount of fees paid by defendants to the pretrial release program.
- The number of persons employed by the pretrial release program.
- The number of defendants assessed and interviewed for pretrial release.
- The number of defendants recommended for pretrial release.
- The number of defendants for whom the pretrial release program recommended against non-secured release.
- The number of defendants granted non-secured release after the pretrial release program recommended non-secured release.
- The number of defendants assessed and interviewed for pretrial release who were declared indigent by the court.
- The number of defendants accepted into a pretrial release program who paid a surety or cash bail or bond.

- The number of defendants for whom a risk assessment tool was used in determining whether the defendant should be released pending the disposition of the case and the number of defendants for whom a risk assessment tool was not used.
- The specific statutory citation for each criminal charge related to a defendant whose case is accepted into a pretrial release program, including, at a minimum, the number of defendants charged with dangerous crimes; nonviolent felonies; or misdemeanors only.
- The number of defendants accepted into a pretrial release program with no prior criminal conviction.
- The name and case number of each person granted non-secured release who: failed to attend a scheduled court appearance; was issued a warrant for failing to appear; was arrested for any offense while on release through the pretrial release program.

MDCR remains committed to serving the community by providing safe, secure, and humane detention of individuals in its custody while preparing them for a successful return to the community. As such, MDCR works diligently to assess the eligibility of any defendant being considered for non-financial custody release to ensure the safety of Miami-Dade County residents is maintained.
