Executive Summary

This item is requesting that the Board of County Commissioners approve the recommendations of the FY 2022-2023 Miami Individual Artists (MIA) Grants Program totaling \$1,500,000.00 for three hundred and nine (309) applicants. The objective of the MIA Grants Program is to recognize and support the contributions of Miami-Dade's diverse and outstanding professional artists to the fundamental vitality and creativity of the cultural community. The recommendations are made by the MIA Grants Program Panel and the Cultural Affairs Council. Awards to artists are recommended at the levels of \$3,400, \$5,000, \$7,500 and \$10,000 based on the competitive evaluation and rating of applications. The funds were allocated via the Fiscal Year 2022-2023 County budget.

Recommendation

It is recommended that the Board of County Commissioners (Board) approve \$1,500,000.00 in funding support for three hundred and nine (309) grant awards to Miami-Dade County-based artists. In addition, it is recommended that Resolution R-130-06 (requiring contracts with non-governmental entities be signed by the other parties before being submitted to the Board) be waived in order to expedite the allocation of funding support for these time-sensitive grant awards. Attachment 1 to this memorandum is a list of the artists and their corresponding artistic disciplines being recommended for grant awards.

Scope

The impact of this agenda item is countywide. There are artists recommended for funding based in every County Commission district. It should be noted that many artists applied using their home addresses and their activities may occur in multiple locations in Miami-Dade County further distributing the impact county-wide (e.g., studios, art centers, galleries, schools, museums, rehearsal spaces, theaters, etc.).

Delegation of Authority

This item delegates authority for the Mayor and Mayor's designee to execute the grant agreements and exercise all provisions contained therein, including cancellation provisions contained therein.

Fiscal Impact/Funding Source

The funding for each of the three hundred and nine (309) Miami Individual Artists Grant awards is from approved departmental revenues, as adopted in Fiscal Year 2022-2023 County budget. Miami Individual Artist Grants are disbursed through Department Fund S1031, Department: CU02010000, Account: 5606450000, Grant: No Grant, Project: CU_GTS_MIA, Activity: Grants. The FY 2022-2023 Cultural Affairs budget, under Grants to Programs for Artists and Non-Profit Cultural Organizations, includes a total allocation of \$1,500,000.00 for this program.

Track Record/Monitor

Artists who have received grants from the Department have complied with their contractual requirements. Michael Spring, Director of the Miami-Dade County Department of Cultural Affairs, is responsible for monitoring the contracts on behalf of the Department.

Background

In FY 2021-2022, the Department of Cultural Affairs applied for and received full funding of \$500,000.00 from the National Endowment for the Arts (NEA) to launch the Miami Individual Artists Program, one of 66 communities selected nationally for this major federal grant award. The NEA funded this one-time grant opportunity with American Rescue Plan (ARP) funding and supported the Department's application in response to the quality, diversity and need evidenced for support of professional working artists based in Miami-Dade County. Following the success of the MIA Program, the County established a grant program to recognize and support the contributions to the fundamental vitality and creativity of the cultural community being made by Miami-Dade's diverse and outstanding professional artists of all artistic disciplines.

There was an enthusiastic response from artists with six hundred and eleven (611) grant requests and two hundred and eighteen (218) funded applicants in the FY 2021-2022 inaugural year of the MIA Program. The Board delegated the authority to the Cultural Affairs Council to award these artist grants in FY 2021-2022 in conjunction with the acceptance of the federal NEA ARP funding. Subsequently, the County sustained and increased funding for the program for FY 2022-2023 to more adequately address the quality and quantity of artists requesting support.

MIA Grants Program applicants are required to be working professional artists which are defined as persons who have created a recognized body of work over a sustained period and pursue this work as a means of livelihood. In addition, applicants must provide proof of being a legal full-time resident of Miami-Dade County for at least one (1) year at the time of application and must have resided and worked in Miami-Dade County for at least one (1) year at the time of application.

The three hundred and nine (309) recommended artists were chosen by the discipline-based grant panel through a competitive process after reviewing five hundred and seventy-two (572) applications received from professional artists in the following artistic disciplines:

- Dance (dancers, choreographers, dance artists, etc.)
- Film/Video/Media Arts (computer/digital artists, etc.)
- Folk/Traditional Arts (artisans, ceramicists, etc.)
- Literary Arts (writers, poets, etc.)
- Music (composers, musicians, singers, etc.)
- Theater/Playwriting (playwrights, designers, actors, etc.)
- Visual Arts (artists, photographers, etc.)
- Multidisciplinary/Interdisciplinary

The MIA Grants Program Panel consisting of twenty-one experts with expertise covering the seven (7) artistic disciplines and representing the diversity of Miami-Dade County, convened to review all of the submissions in each of these areas and to recommend finalists. The MIA Grants Program Panel carefully

reviewed the applicants based on work samples and support materials submitted demonstrating artists' professional activities and accomplishments. The Panel used the following criteria to make their recommendations:

- Evidence of artist merit through an established and recognized body of work over a sustained period;
- Consistency in the submitted body of work; and
- Quality and scope of the artistic activities being pursued during the grant period (such as performances, presentations, exhibitions, workshops, research projects, and/or the creation of artwork).

The grant awards range from \$3,400.00 to \$10,000.00 based on the review and rating of the applications and represent the quality and diversity of artists living and working in Miami-Dade County. The Panel and the resulting artist recommendations exemplify the key principle of diversity, defined in the broadest possible sense, including gender, gender identity, race, ethnicity, national origin, disability, age, culture, socio-economic status, geographic background, faith/religion, sexual orientation, profession, and ability. The Cultural Affairs Council is scheduled to meet on May 17, 2023 to review and approve the Fiscal Year 2022-2023 Miami Individual Artist Grants Program recommendations.

It is recommended that Resolution R-130-06 (requiring contracts with non-governmental entities be signed by the other parties before being submitted to the Board) be waived. It is in the best interest of the County to waive Resolution R-130-06 and proceed in this manner in order to expedite grant awards for time-sensitive funding to individual artists. This "dual track" approach saves from one to two months of time in providing funding support to individual artists that have been evaluated through a thorough and lengthy review process.

Attached is a list of the artists and their respective disciplines being recommended for funding.

THIS AGREEMENT ("Agreement"), made and entered this ____ day of _____, 2023 between the MIAMI-DADE COUNTY ("County"), c/o DEPARTMENT OF CULTURAL AFFAIRS, ("Department"), and _____ ("Artist"),
(Artist Legal Name, exactly as listed on IRS FORM W-9)

_____, residing in Miami-Dade County, provides as follows:

After a competitive process involving a review panel and approval by the Miami-Dade County Cultural Affairs Council on May 17, 2023 and the Miami-Dade County Board of County Commissioners and Mayor, the County awards to the Artist one non-matching \$AMOUNT Miami Individual Artists Grant ("Grant"). This Grant is awarded solely on the basis of the Grant Application ("Application") submitted by the Artist which is incorporated by reference into this Agreement, and in consideration for Artist's agreement to abide by the following terms and considerations set forth in this Agreement.

This Grant is to be used by the Artist according to his, her, or their needs, pursuant to the activities described by Artist in the Application. Funding of the Grant is paid by the Miami-Dade County Department of Cultural Affairs, through its Miami Individual Artists (MIA) Grant Program, with the support of the Miami-Dade County Mayor, the Board of County Commissioners, and the Cultural Affairs Council. This Agreement shall be in effect during the grant period of October 1, 2022 - September 30, 2023.

The Artist attests that he/she/they is over 18 years of age, is a professional artist (defined as a person who has created a recognized body of original works in his/her/their discipline over a sustained period of time, and who is striving to achieve the highest level of professional recognition; someone who creates, on an ongoing basis, original works and pursues this work as a means of livelihood), resides currently in Miami-Dade County and intends to remain in residence in Miami-Dade County for at least the entirety of the term of this Agreement.

As a condition of eligibility to be considered for this Grant, the Artist's Application included an attestation that Artist has resided in MIAMI-DADE COUNTY for at least one year prior to the time of the application deadline of March 17, 2023. Proof of residency in Miami-Dade County, beginning not later than March 17, 2022, is required in order to receive the Grant. Such evidence may include, but is not necessarily limited to, any of the following: a copy of a realty deed or rental agreement in the Artist's name; a utility bill in the Artist's name; voter's registration; a current State of Florida Driver's License; or 2021 IRS personal tax returns. Other forms of proof intended to be submitted as substantiating evidence of the residency requirement must first be authorized in writing by the Department of Cultural Affairs Director ("Director") as eligible and acceptable alternate documentation.

The Artist agrees to remain active professionally, continuing to work during the period of this Agreement, and that on or before September 30, 2023, the Artist's role in the activities described by Artist in the Application will be completed.

This Agreement may be extended by the Director with a written notice submitted by Artist, and at the sole discretion of the Director. Change(s) to the project described in the Application must be submitted by Artist with a written notice to the change(s) taking place and may be authorized at any time at the sole discretion of the Director. Changes must be in line with the original intent of the activities as described in the Application.

A final report form, provided by the Department, is required within forty-five (45) days of the project end date. All activities must be accessible to people with disabilities. Funded activities that are occurring in-person must be held in a physically accessible venue and program access and effective communication must be provided for participants and audience members with disabilities.

It is expressly understood and intended that the Artist is merely a recipient of a Grant and is not an agent or employee of Miami-Dade County, its Mayor, its Board of County Commissioners, Miami-Dade County Department of Cultural Affairs, or the Cultural Affairs Council. The Artist will consult his/her/their own tax advisor or the Internal Revenue Service to determine his/her/their tax liability.

Artists who wish to credit Miami-Dade County for its support can use the following credit line: "With the support of the Miami-Dade County Department of Cultural Affairs and the Cultural Affairs Council, the Miami-Dade County Mayor and Board of County Commissioners." In the event the Artist shall fail to materially conform with any of the provisions of this Agreement, the Department may cancel the Grant, after giving forty-five (45) calendar days' written notice to the Artist of the details of the failure. If the Artist fails to cure the failure within the 45 days, the Agreement shall be cancelled; the County shall have no further obligation to the Artist under this Agreement, the Artist shall repay to Miami-Dade County all portions of the Grant which have been received, and, at the Director's sole discretion, the Artist may be declared ineligible to apply to the Department for a period up to five years.
