Subject:	Setting of Proposed FY 2023-24 Countywide Ope	erating Millage Rate

Executive Summary

This item recommends a Countywide operating millage rate for the Board's approval. As the Proposed Budget was developed this year, we prioritized providing continued relief to residents struggling with rising costs of living by providing a Countywide millage cut – while sustaining our current level of services and investing in our community's key priorities, including housing, transit, public safety, small business, and our families and seniors. Our proposed budget recommends reducing the Countywide millage rate for the second year, while maintaining services and making continued investments in tackling the affordability crisis and building our infrastructure for the future. We propose that additional ad-valorem revenues, realized in the July 1st preliminary tax rolls released by the Property Appraiser, above and beyond what is required to sustain valuable services for our community, be placed in reserves to be used during emergencies when needed.

I urge the Board to consider the millage rate outlined below. Although it is a lower rate than what has been proposed for several years, it is enough to provide the level of service required to be funded from the Countywide budget.

Recommendation

It is recommended that the Board approve the Countywide operating millage rate of 4.5740 mills, as proposed in the FY 2023-24 Proposed Budget, for use in preparing the "Notice of Proposed Property Taxes" to be mailed to all property owners in August. The proposed millage rate represents a one percent reduction from the adopted FY 2022-23 Countywide operating millage rate.

Scope

State law requires that all property owners be advised of proposed property taxes along with notification of public budget hearings. The Property Appraiser will mail required notices to all property owners in August using proposed tax rates adopted by all taxing authorities in Miami-Dade County.

Delegated Authority

This item contains no delegations of authority to the County Mayor or Mayor's designee.

Fiscal Impact/Funding Source

The millage rate recommended will generate \$1.850 billion in ad valorem revenue for the Countywide General Fund.
