The attached item was prepared by the Citizens Independent Transportation Trust (CITT) and is being placed on the agenda of the Board of County Commissioners (BCC) at the request of Javier Betancourt, Executive Director of the CITT, for approval.

The Miami-Dade TPO is leading a regional Bicycle Immersion Program (Program) supported by the Netherlands Ministry of Infrastructure and Water Manager, in collaboration with the Embassy of the Kingdom of the Netherlands, and the Consulate General in Miami. This Program will be led by the Dutch Cycling Embassy, from October 23-25, 2023, and will be open to Miami-Dade TPO regional agencies and industry partners.

It is recommended by the CITT that the BCC approve travel expenses in an amount not to exceed \$9,000 (or \$3,000 per traveler), budgeted for such purposes in the Office of the CITT's operating budget, to enable up to three CITT members selected by the CITT Chairman to attend the Program.

This Program will provide an immersive experience in bicycle and pedestrian-friendly infrastructure through a combination of sessions with political and industry leaders, as well as guided cycling, to learn the Dutch approach for the design and implementation of bicycle infrastructure.

The CITT's participation in this program helps to advance several CITT objectives related to the promotion of bicycle/pedestrian infrastructure as an alternative mobility solution, including the development of first/last mile connectivity to transit services such as the Strategic Miami Area Rapid Transit Plan corridors.

Due to logistical time constraints and the August recess, at the request of the CITT, the Administration will request a waiver of this item from BCC Committee review and placement of the item on the agenda for the September 19 meeting of the BCC. RESOLUTION APPROVING REIMBURSEMENT OF TRAVEL EXPENSES, NOT TO EXCEED A TOTAL OF \$9,000.00 OF CHARTER COUNTY TRANSPORTATION SURTAX FUNDS (OR \$3,000.00 PER TRAVELER) BUDGETED FOR SUCH PURPOSES, TO PERMIT UP TO THREE MEMBERS OF THE CITIZENS' INDEPENDENT TRANSPORTATION TRUST ("CITT") SELECTED BY THE CITT CHAIRMAN TO ATTEND THE MIAMI-DADE TRANSPORTATION PLANNING ORGANIZATION ("TPO") DUTCH CYCLING EMBASSY BIKE IMMERSION PROGRAM SCHEDULED FOR OCTOBER 23-25, 2023

WHEREAS, the Citizens' Independent Transportation Trust ("CITT") is actively working with its partner transportation organizations to promote the development of bicycle/pedestrian infrastructure throughout Miami-Dade County as an alternative mobility solution, and as first/last mile connectivity to the County's transit system; and

WHEREAS, these efforts are consistent with and further the CITT's charge, pursuant to County Code, to "monitor, oversee, review, audit and investigate the implementation of the transportation and transit projects listed in any levy of the surtax, and all other projects funded in whole or in part with surtax proceeds"; and

WHEREAS, the CITT is engaged in the ongoing oversight and monitoring of the current 5 Year Implementation Plan of the People's Transportation Plan ("PTP"), which currently includes several bicycle/pedestrian related projects, such as Vision Zero and the South Dade Trail component of the South Dade Corridor; and which may be amended in the future to include eligible bicycle/pedestrian projects that provide first/last mile connectivity to transit services such as the Strategic Miami Area Rapid Transit ("SMART") Plan; and

WHEREAS, the CITT is also engaged in the ongoing oversight and monitoring of municipalities' use of their share of surtax funds, including several past, present and future bicycle/pedestrian projects; and

WHEREAS, the Miami-Dade Transportation Planning Organization ("TPO") has invited the CITT to attend a regional Bicycle Immersion Program supported by the Netherlands Ministry of Infrastructure and Water Manager, in collaboration with the Embassy of the Kingdom of the Netherlands, and the Consulate General in Miami. This Program, included herein as part of Exhibit A, will be led by the Dutch Cycling Embassy, from October 23-25, 2023, and will be open to Miami-Dade TPO regional agencies and industry partners; and

WHEREAS, the Program will provide an immersive experience in bicycle and pedestrianfriendly infrastructure through a combination of sessions with political and industry leaders, as well as guided cycling, to learn the Dutch approach for the design and implementation of bicycle infrastructure; and

WHEREAS, the CITT's active participation in this unique Program alongside its partner transportation organizations will help to better educate and inform the CITT with respect to successful bicycle/pedestrian infrastructure, policies and programs, thereby enhancing its ability to properly monitor, oversee, review, audit and investigate proposed County and municipal bicycle/pedestrian projects and programs seeking surtax funds; and

WHEREAS, the Office of the CITT's FY23 (current) and FY24 (proposed) operating budgets have funds budgeted for Staff and Member travel in amounts sufficient to cover these expenses; and

WHEREAS, at its public meeting on July 27, 2023, the CITT unanimously approved a Resolution, provided herein as Exhibit A, recommending to the County Commission approval of the reimbursement of travel expenses, not to exceed \$9,000.00 of Charter County Transportation

Surtax Funds (or \$3,000.00 per traveler) budgeted for such purposes, to permit up to three members of the CITT selected by the CITT Chairman to attend the Miami-Dade Transportation Planning Organization Dutch Cycling Embassy Bike Immersion Program scheduled for October 23-25, 2023; and

WHEREAS, this item was waived from BCC Committee review due to time constraints between the time that the CITT received an invitation from the TPO to attend the Program, and the actual dates of travel, requiring expeditated approval in order to be able to make the necessary travel arrangements in a timely and cost effective manner,
